**Note 1. Description of the Plan**

The following description of the Tablecraft Products Employees' Profit Sharing Plan & Trust (the Plan) provides only general information. The plan agreement, which governs the Plan's provisions, should be referred to by participants for a more complete description.

**General**

The Plan is a defined contribution plan covering all employees of Tablecraft Products Company, Inc. (the Company) who have completed three months of service and are 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Ascensus, as agent for Ascensus Trust Company, is the trustee of the Plan under a contractual agreement with the Company and manages all investments. Ascensus is the recordkeeper. The record-keeping agreement provides that the record-keeper shall keep account of all receipts and disbursements, benefit payments and other transactions, and shall provide annually a report setting forth such transactions and the status of the fund at the end of the period.

**Contributions**

Participants may elect to make pre-tax contributions ranging from 1% to 80% of their eligible compensation, as defined in the Plan. Participants are permitted to designate a portion, or all of the deferral contributions made as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make safe harbor contributions up to 3% of eligible compensation. The Company also may make discretionary profit sharing contributions to the Plan. Employee contributions can be made on a before-tax basis only and cannot exceed \$23,000 in 2024. Participants over the age of 50 can contribute an additional \$7,500 in 2024.

**Participant Accounts and Allocations**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings and charged with an allocation of plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and in amounts representing distributions from other qualified defined benefit or contribution plans plus actual earnings thereon. Additionally, participants are 100% vested in the safe harbor contributions. Vesting in the Company's discretionary profit sharing contributions, plus actual earnings thereon, is based on years of cumulative service as follows:

Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%

Six years or more	100%

A year of service is defined as at least 1,000 hours of service during any plan year.

***Investment Options***

Upon enrollment in the Plan, participants may direct their participant contributions, plus actual earnings thereon, into a variety of investment options as more fully described in the Plan's literature. Participants may change their investment options daily.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. At December 31, 2024, interest rates on notes receivable from participants ranged from 3.25% to 8.50%.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may also leave the value of their vested interest in the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$51 and \$2,639, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. Forfeitures in the amount of \$2,806 were used to pay plan expenses during the year ended December 31, 2024. In 2024, no forfeited nonvested amounts were used to reduce employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. The Plan's investments in shares of registered investment companies are valued at quoted market prices.

The common or collective trust fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. Participants may redeem units of the fund upon 12 months advance written notice to the Trustee of the common or collective trust fund. There were no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Administrative Expenses***

Certain administrative fees are paid by the Company on behalf of the Plan. Administrative expenses paid by the Plan are expensed as incurred. Certain investment fees are netted and reported in the net appreciation in fair value of investments.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

**Note 3. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value.

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

The fair value of shares of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Parties-in-Interest**

Fees paid by the plan sponsor for services rendered by the trustee and other parties-in-interest were for services required by the Plan. The Plan paid \$18,091 of fees to Ascensus during 2024. The Company provides certain administrative services at no cost to the Plan.

**Note 6. Plan Termination**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA as amended by subsequent legislation. In the event of plan termination, participants will become 100% vested in their Company contribution accounts.

**Note 7. Tax Status**

The Plan operates under a non-standardized pre-approved profit sharing plan sponsored by Ascensus LLC. This prototype plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$6,235, \$2,215, \$48,553, and \$276,842 were not remitted within the required time period for the years ended December 31, 2024, 2023, 2021, and 2020, respectively. Late remittances from the 2023, 2021, and 2020 Plan years were subsequently corrected using the Voluntary Fiduciary Correction Program during the year ended December 31, 2024.

**Note 9. Risks and Uncertainties**

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
