Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fairbanks Scales Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

General

The following description of Fairbanks Scales Inc. 401(k) Plan, formerly known as Fairbanks Scales Inc. Savings Plan (the Plan), provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan is a defined contribution plan sponsored by Fairbanks Scales Inc. (the Company) for the benefit of its full-time employees who have at least thirty days of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*. The Plan was amended and restated effective June 15, 2024. The amended and restated Plan changed the Plan name, and changed the Plan's trustee and custodian from John Hancock Trust Company LLC to Delaware Charter Guarantee & Trust Company, d/b/a Principal Trust Company (Principal).

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 75% of eligible compensation. Employees have the option to elect Roth contributions. Employee rollover and catch-up contributions are also permitted.

The Company may make matching contributions, which are discretionary as determined by the Company's Retirement Committee. For 2023 and through June 15, 2024, the Company match is calculated at 50% match on the first 5% of employee compensation contributed as pre-tax. Employees under a collectively bargained agreement are eligible to participate in the Plan. Collectively bargained employees will receive a Company match of 2.5% if hired after October 31, 2005 or 1.5% if hired prior to October 31, 2005. Collectively bargained employees that participate in the Company's defined benefit plan will receive a Company funded nonelective contribution between 2% and 6% of annual wages, based on the participant's age.

Effective June 15, 2024, the amended and restated Plan changed the Company match provisions whereby participants are put into groups based on employment status and years of eligible service, as defined by the Plan. Group 1 is classified as a bargaining employee with a hire date after October 1, 2005. The Company match for this group is 100% of a participant's elective deferral contribution up to a maximum of 2.50%. Group 2 is classified as a bargaining employee with a hire date on or before October 1, 2005. The Company match for this group is 100% of a participant's elective deferral contribution up to a maximum of 1.50%. Group 3 is classified as a nonunion employee. The Company match for this group is 50% of a participant's elective deferral contribution up to a maximum of 5.00%. The Company may make additional discretionary contributions. Qualified nonelective contributions are allocated to each person who was an eligible active participant at any time during the plan year.

The Plan allows for the Company to make discretionary profit-sharing contributions. Employees under a collectively bargained agreement are not eligible to receive a discretionary profit-sharing contribution but are eligible for a mandatory non-elective profit-sharing contribution with a defined eligibility and compensation formula. During the 2024 plan year, the Company made three profit-sharing contributions totaling \$53,511. During the 2023 plan year, the Company made one profit-sharing contribution totaling \$227,893.

Contributions are subject to certain limitations. Forfeitures are used to first reduce Company contributions and then to offset the Plan's administrative costs. Any remaining forfeitures shall be allocated to participants, as defined by the Plan Document.

Participant Investment Account Options

Investment account options available include various mutual funds, common collective trust funds, and others. Each participant has the option of directing his/her contributions into any of the investment accounts and may change the allocation daily.

The Plan includes an automatic deferral feature for all new hire eligible participants whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for a 1% annual increase in the percentage deferred and is ultimately capped at 10%.

Employees under a collectively bargained agreement are not eligible for automatic enrollment.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. The nonvested balance is forfeited upon termination of service.

Vesting in the Company's discretionary profit-sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. The table below shows the participant's vesting schedule for the discretionary profit-sharing contributions. The nonvested balance is forfeited upon termination of service.

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prime rate plus 1.5% at the time of issuance.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his/her account or installment payments.

Forfeited Accounts

At December 31, 2024 and 2023, unapplied forfeited nonvested accounts totaled \$9,430 and \$20,491, respectively. These accounts will be first used to reduce future Company contributions and then to offset the Plan's administrative costs. Any remaining forfeitures shall be allocated to participants, as defined by the Plan Document. Also, in 2024 and 2023, employer contributions were reduced by \$64,726 and \$21,521, respectively, from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Pooled separate accounts are valued at estimated fair value as provided by Principal.

The Plan's interest in the collective trusts is valued based on information reported by the trustee using the audited financial statements of the collective trusts at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company, d/b/a Principal Trust Company (as of December 31, 2024 and for certain activity for the period from June 15, 2024 to December 31, 2024) and John Hancock Trust Company LLC (as of December 31, 2023 and for certain activity from January 1, 2023 to August 31, 2024), qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Company directly pays any other fees related to the Plan's operations.

The Plan paid \$82,061 and \$84,383 of recordkeeping fees to parties-in-interest during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Plan Tax Status

The Plan operates under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Principal Financial Group. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
