- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at year end as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Weigel Stores, Inc. Profit Sharing 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of Weigel Stores, Inc. and certain of its affiliates (the Company), who have two months of service with the entry date on the first of each calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974. The Company's Board of Directors and the Plan Administrator are responsible for the oversight of the Plan. The Plan's investments are held in a directed trust at The Trust Company of Tennessee, who is also the corporate trustee and investment custodian. The Board of Directors and the Plan Administrator determine the appropriateness of the Plan's investment offerings and monitor investment performance. The Plan Administrator has delegated third party administration and record keeping to The Trust Company of Tennessee.

Contributions - The Plan is funded by both participant and employer contributions. As defined by the Plan, participants may contribute a percentage of their salary not to exceed the IRS Code Section 402(g) limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contribution amounts representing distributions from other qualified retirement plans. The Company may make discretionary profit sharing contributions which are determined annually by the Company's Board of Directors. The Company made a profit sharing contribution of \$356,218 for 2024. Employer profit sharing contributions are allocated to participants who are still employed by the Company as of the last day of the Plan year. Additionally, the employer may make discretionary matching contributions at an amount determined by the Company's Board of Directors. The Company made matching contributions of 100% of the employee's deferral up to 2% of compensation to eligible participants for 2024. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions, allocations of the employer's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

Forfeitures - At December 31, 2024 and 2023, there were no unallocated forfeited non-vested accounts. The total amount of forfeitures allocated to participants for the year ended December 31, 2024 was \$80,129.

Excess Contributions Payable - Amounts payable to participants in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits - Upon retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) may receive the vested portion of the participant's account. The Plan also permits distributions prior to termination of employment (in-service and hardship) upon meeting certain requirements. A participant who has attained the Plan's normal retirement age and who has not separated from service may also request distribution of his or her account balance. Distributions are made in the form of lump sum payments or installment payments.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. A participant vests in the employer contributions at 20% per year after completing two years of service and is 100% vested after six years of credited service. In addition, a participant will become 100% vested in the employer contributions in the event of death or permanent disability.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Plan's financial statements have been prepared using the accrual basis of accounting.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian and investment advisor. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events - Management has evaluated subsequent events through July 29, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that are required to be disclosed.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund. The money market fund held in the Plan is an open-ended mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: The Plan is invested in a stable value fund, Invesco Stable Value Trust (Federated Capital Preservation Fund in 2023) (the "Fund"). The Fund is a collective trust valued at the NAV of the units owned, and the NAV is used as a practical expedient to estimate fair value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. The Fund is a stable value fund, which seeks to provide investors stable principal and high current income and invests in guaranteed investment contracts ("GICs"), separate account guaranteed investment contracts ("SGICs"), synthetic guaranteed investment contracts ("SICs"), money market mutual funds, and other stable value products.

NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE AND INVESTMENT CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from The Trust Company of Tennessee, the trustee of the Plan, that the information in the accompanying financial statements and supplemental schedule with respect to investments and related investment activity is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The investment information certified by the trustee is presented based on the certifications and is summarized below:

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Plan Sponsor adopted a non-standardized profit sharing plan sponsored by The Trust Company of Tennessee. The Internal Revenue Service (IRS) has determined and informed the Plan's third-party administrator by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During the 2024, the Plan paid \$83,570 in administrative fees to The Trust Company of Tennessee, the investment custodian, trustee, record keeper and third-party administrator, which qualify as party-in-interest transactions.

The Plan Sponsor provides the Plan with certain accounting, auditing and administrative services for which no fees are charged to the Plan.
