The liability under the unit credit cost method is the value of the accrued pension benefit using service and pay as of the valuation date. The sum of the present value of the accrued benefits for all participants is the ERISA funding target. The normal cost is the present value of the benefits earned during the year. The target normal cost is the sum of the normal costs for all participants and the assumed administrative expenses.

Valuation software and enrolled actuary changed for the Plan Year. Prior to the change, the actuary compared the prior year funding target liability, target normal cost and actuarial value of assets with the prior actuary's and the results were within the required thresholds.
