**1. DESCRIPTION OF THE PLAN**

The following description of Munger Bros., LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General** The Plan is a defined contribution plan covering substantially all employees of entities in which members of the Munger family have an ownership interest, which include Munger Bros., LLC; Crowne Cold Storage, LLC; Monarch Nut Company, LLC; Sarbanand Enterprises, LLC; and Sarbanand Farms, LLC (collectively, the Company), who are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA) as amended. The Plan was originally established on January 1, 2018, and has been subsequently amended and restated. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

**Contributions** Participants may elect to contribute to the Plan, in the form of traditional and Roth salary deferrals, up to the lesser of 100% of their eligible compensation or the maximum amount allowable by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions based on 100% of the employee's elective deferral that does not exceed 3% of the employee's compensation, plus 50% of the next 2% of the elective deferral, not to exceed 5% of the employee's compensation. The Company made safe harbor matching contributions of \$344,567 and \$350,916 for the years ended December 31, 2024 and 2023, respectively. Additionally, the Company may make nonelective contributions as determined by the Company. The Company made no nonelective contributions for the years ended December 31, 2024 and 2023.

**Automatic Enrollment** Employees eligible to participate in the Plan are automatically enrolled upon meeting the eligibility requirements noted above. Unless otherwise directed, the rate of deferral upon enrollment is 3% of eligible compensation on a pre-tax basis, to be invested in specific pre-selected investment offerings based on a participant's estimated time to retirement.

**Participant Accounts** Each participant's account is credited with the participant's contributions, Company contributions, and account earnings, and may be charged with an allocation of administrative expenses that are paid by the Plan. The Company's nonelective contribution allocations are based on a participant's eligible compensation, relative to total eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** Participants are immediately vested in their contributions, Company safe harbor matching contributions, and earnings thereon. Nonelective contributions are subject to vesting. A participant is 100% vested after five years of credited service. Participants are credited with one year of service for each Plan year in which they worked at least 1,000 hours.

**Payment of Benefits** Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the *Internal Revenue Code* (IRC). Payments are made in the form of a lump-sum distribution.

At December 31, 2024 and 2023, there were no amounts allocated to participants who elected to withdraw from the Plan but have not yet been paid.

**Forfeitures** Forfeitures attributable to nonelective contributions may be used to pay Plan expenses or reduce future Company contributions. No forfeited were used to make matching contributions for the years ended December 31, 2024 and 2023. There were no forfeited nonvested account balances at December 31, 2024 and 2023.

**Plan Termination** Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their Company nonelective contributions.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

**Fair Value Measurements** The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Pooled Separate Account:* The underlying assets of the pooled separate account consist of mutual funds known as sub-accounts. Each sub-account invests in shares of an underlying mutual fund. Sub-accounts are measured in terms of accumulation units. The sub-accounts are valued based on the quoted market prices of the mutual funds. Certain fund fees, expenses, and administration charges (if any) are deducted from the value of the mutual funds to arrive at the value of the sub-accounts. The accumulation units are valued at net asset value on a daily basis. Participant transactions (issuances and redemptions) may occur daily. If the Plan were to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay, for up to seven days, withdrawal from the pooled separate account, in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 and 2023.

*Deposit Administration Contract:* The deposits invested become part of Standard Retirement Services' general account, and there are no particular segregated or identifiable assets ascribed to the Plan's investment. The net deposits and interest credited become liabilities against Standard Retirement Services on the Plan's behalf. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Standard Retirement Services. The contracts are included in the financial statements at fair value, as contract value approximates fair value. The crediting rate resets quarterly, and the fund's declared crediting rate will never be below one percent annually. The Plan sponsor has instructed Standard Retirement Services to reduce the declared crediting rate in order to offset certain administrative fees. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contracts, plus earnings, less withdrawals and administrative expenses.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Payment of Benefits*** Benefits are recorded when paid.

***Expenses*** Certain operating expenses of the Plan are deducted from participant accounts and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

***Evaluation of Subsequent Events*** The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**3. INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments included on the statements of net assets available for benefits, and the investment income included on the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, were not subject to auditing procedures and have been certified as complete and accurate by Standard Insurance Company (Standard). Standard is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

Transfers into level 3 investment from level 2 totaling \$217,202 and \$142,567 for the years ended December 31, 2024 and 2023, respectively, were made because of the lack of observable market data due to decreased market activity for the securities. Transfers out of level 3 investments totaling \$61,648 and \$13,791 for the years ended December 31, 2024 and 2023, respectively, were made because observable market data became available for the securities. The Plan's policy is to recognize transfers into and out of level 3 as of the actual date of the event or change in circumstances.

There were purchases of level 3 investments totaling \$109,894 and \$102,570, and sales of level 3 totaling \$92,306 and \$194,763 for the years ended December 31, 2024 and 2023, respectively.

**5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Standard. Standard is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Standards provides certain administrative services to the Plan pursuant to an agreement between the Company and Standard. Standard receives revenue from mutual funds and other service providers for services provided to the funds. This revenue is used to offset certain amounts owed to Standard for administrative services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by Standard from investment providers exceeds the amount owed under the agreement, Standard remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Company may make a payment to Standard for administrative services not covered by revenue sharing.

**6. TAX STATUS**

The Plan has adopted a nonstandardized pre-approved profit sharing/money purchase/CODA (cash or deferred arrangement) plan established by Central Administrative Services, Inc. DBA Hicks Pension Services. The pre-approved plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the pre-approved plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

The Plan had delinquent participant contributions for a number of years. Management is confident the prohibited transactions will not adversely affect the qualified status of the Plan.

**8. SUBSEQUENT EVENTS**

Effective April 1, 2025, the Plan's custodian has been transferred from Standard to ADP Retirement Services. Additionally, third-party services provided by Hicks Pension Services have been transferred to Pentegra Services, Inc. Additionally, the Plan was amended to allow participants to borrow from their accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and may only have one loan outstanding at any time.
