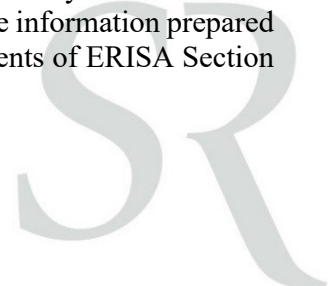

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year – December 31, 2024) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following description of Michigan Orthopaedic Surgeons, PLLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) retirement and savings plan covering all eligible employees of Michigan Orthopaedic Surgeons, PLLC (the “Company”). The Plan began effective January 1, 2017 and was amended and restated effective June 1, 2022, when the Plan adopted the *Sentinel Benefits Group, Inc. Pre-Approved Defined Contribution Plan* (the “Plan”). Except as described in the amendments below, a participant must reach age 21 to enter the Plan.

For eligibility purposes, years of service with Michigan Orthopaedic Institute, PC, Troy Orthopedic Associates, P.L.C., Beverly Hills Orthopaedic Surgery, PLLC, Performance Orthopedics, PLLC, Oakland Orthopaedic Surgeons, PLLC, Jerome P. Wiater, MD, PC, Thomas D. Magnell, MD, PC, Michael Pochron, MD, PC, J. Michael Wiater, MD, PC, Patrick J. Wiater, MD, PLLC, Gregory V. Sobol, MD, PLLC and Brett P. Wiater, MD, PC are counted.

The age and service requirements are waived for employees who are former participants of the Michigan Orthopaedic Institute, PC 401(k) Plan who were employed on January 1, 2017 and for physicians who were employed on January 1, 2017. For these eligible employees the Plan entry date is January 1, 2017.

The Plan includes the waiver of service and age requirements for certain individuals employed on July 1, 2018, making them eligible for the employer profit sharing contribution.

The Plan includes the waiver of service and age requirements for certain individuals employed on January 1, 2019, making them eligible for elective deferral only.

Effective July 1, 2023, the Plan was amended to waive the age and service requirements for salary deferrals for Employees of Michigan Hand & Wrist PC who were employed on July 1, 2023 and such eligible employees entered the Plan on this date, for purposes of salary deferrals and rollover contributions. The age and service requirements for matching contributions and profit-sharing contributions were also waived for employees of Michigan Hand & Wrist PC employed on July 1, 2023. For vesting purposes, years of service with Michigan Hand & Wrist PC are counted.

Under the Plan the service requirement is 3 months of service for pre-tax and Roth deferrals and the entry date is the first day of the month following the date requirements are met. The Plan also includes automatic pre-tax contributions, for new participants, of 5% of compensation as defined by the Plan, subject to annual percentage increases.

NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Benefits Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute to the Plan a percentage of their annual wages, up to the maximum dollar amount determined by the Internal Revenue Service. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may elect either Regular 401(k) deferrals (pre-tax) or Roth 401(k) deferrals (after tax). Participants may elect to rollover funds into the Plan from other employers' qualified plans and certain Individual Retirement Accounts ("Employee Rollover Contributions"). Also, amounts may be transferred to the Plan in a Plan to Plan transfer from other tax qualified plans as defined by the Plan. Such rollovers and transfers are fully vested with the participant making the transfer. See Vesting, below. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust.

The Plan includes an auto-enrollment provision whereby all employees newly eligible, on or after January 1, 2020, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. Unless a participant affirmatively elects otherwise after receiving appropriate notice, contributions for each active participant shall be increased annually on the first day of the Plan year, by 1%, up to an annual maximum of 10% of eligible compensation.

The Company contributes a safe harbor nonelective contribution equal to 3% of an eligible participant's annual compensation. Certain employees are not eligible for the safe harbor contribution as follows: i) Highly compensated employees are excluded however, the Company may make a discretionary contribution in a percentage that does not exceed the amount or rate provided to non-highly compensated employees and ii) employees who have not met the age 21 and 3 months of service requirements are excluded. The Company's safe harbor nonelective contribution totaled \$478,299 and \$437,902 for the years ended December 31, 2024 and 2023, respectively.

The Company may, at its discretion, make matching or profit sharing contributions to the Plan. The Company's profit sharing contribution totaled \$2,257,089 and \$2,035,646 for the years ended December 31, 2024 and 2023, respectively. There were no matching contributions for the Plan years ended December 31, 2024 and 2023. See Vesting, below.

Contributions are subject to certain statutory limitations.

Plan Operations

The Company has appointed Charles Schwab Bank (“CSB”) to serve as Trustee, the Company to act as plan administrator and Sentinel Benefits & Financial Group (“Sentinel”) to assist the Company with Plan administration. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The Plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled. See Note 5.

Participant Accounts

Each participant’s account is credited with (a) the participant’s contributions and the Company’s safe harbor contribution, (b) the Company’s profit sharing and match, if applicable and (c) the Plan’s earnings, and charged with an allocation of investment and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. See Vesting, below.

Vesting

Participants are immediately vested in their elective, safe harbor nonelective contribution and rollover contributions. Vesting in the Company’s profit sharing and elective employer matching contributions occurs based on a Participant’s years of service, over six years such that by the end of six years of service, the participant shall be fully vested.

Notes Receivable from Participants

Participants are eligible to borrow up to the lesser of 50% of the value of their vested account balance or \$50,000 in a minimum amount of \$1,000. Such loans are treated as a direct investment of the participant and earnings on the loan will be credited to their account. Only one outstanding note receivable is permitted at any time and the note receivable prepayment schedule can be no longer than 5 years. The notes are secured by the balance in the participant’s account and bear interest at rates ranging from 4.25% to 9.50%, per annum, which are commensurate with interest rates charged for similar types of loans by other lenders and considered reasonable by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum or as a direct rollover. Benefits amounts under \$5,000 are automatically distributed. If the value of the account is greater than \$5,000 the participant may elect to take a lump sum distribution, rollover into an IRA or to another qualified plan which accepts rollovers or leave the funds in the Plan where they remain tax deferred and invested at the participant's direction. In-service distributions from 100% vested accounts are permitted if the participant has attained 59.5 years of age. Financial hardship withdrawals are permitted, if certain conditions are satisfied as defined by the Plan.

Benefits are recorded when paid.

Plan Amendments

The Plan implemented certain provisions permitted by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which allowed certain eligible individuals to receive coronavirus related relief for eligible distributions and loan repayments. The features within these acts were implemented during the year ended December 31, 2020, as required by the Internal Revenue Service (IRS). Amendments to the Plan to reflect these operational changes were adopted on October 7, 2022, with an effective date of March 27, 2020, in accordance with applicable law and IRS guidance.

The Plan intends to formally adopt certain provisions from the Secure Act 2.0 by the Plan year ending December 31, 2026. Certain changes were effective as soon as administratively and operationally feasible.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant withdrawals are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation of fair value of investments. See Note 5.

Forfeited Accounts

Forfeited amounts may be used to reduce future employer contributions or pay Plan expenses. During 2024 and 2023, the Plan used \$48,436 and \$34,334 to pay plan expenses, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,924 and \$10,272, respectively.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Date of Management's Review

The Plan has evaluated subsequent events through October 10, 2025 which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification Topic 820, Fair Value Measurement, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3 – FAIR VALUE MEASUREMENTS – CONTINUED

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as quoted by the fund. The mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by The Plan are deemed to be actively traded.

Common Collective Trust - is valued at Net Asset Value (“NAV”) in accordance with valuation procedures established by the fund’s Trustee and is calculated daily as of the close of trading of The New York Stock exchange. NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The Plan held no Level 3 investments at December 31, 2024 and 2023.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103- 8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all investment information included in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments and dividends for the years then ended, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (“CSB”).

NOTE 5 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan Administrator entered into an agreement with Sentinel Benefits Group Inc. to act as the record keeper and third party administrator to assist in the continuing operation and maintenance of the Plan to ensure compliance with applicable tax laws and various additional administrative services. Fees incurred by the Plan for these services are included in administrative expenses in the amount of \$69,036 and \$54,520 for the years ended December 31, 2024 and 2023, respectively.

During 2024 and 2023, Schwartz & Co. provided investment advisory services to the Plan. Fees incurred by the Plan for these investment services are included in administrative expenses in the amount of \$44,403 and \$17,870 for the years ended December 31, 2024 and 2023.

Custodial fees paid to CSB by the Plan are included in administrative expenses in the amount of \$17,373 and \$15,633 for the years ended December 31, 2024 and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all benefits earned to that date.

NOTE 7 – TAX STATUS

The *Sentinel Benefits Group, Inc. Pre- Approved Defined Contribution Plan*, adopted by the Plan (effective June 1, 2022) obtained an opinion letter dated November 30, 2020 in which the Internal Revenue Service stated that the form of the plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees.

The Plan has not requested or received a plan determination letter. Although the Plan has been amended since receiving the determination letter, the Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in market values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
