NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Pearce Industries, Inc. 401(k) Retirement and Savings Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Pearce Industries, Inc. and its affiliate, Waukesha-Pearce Industries, LLC (collectively, the “Company”), excluding union employees and non-resident aliens. Employees are eligible to participate in the Plan immediately upon completion of one month of service and the attainment of age 19. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax and/or Roth after-tax salary deferral contributions to the Plan, up to the maximum allowed under the appropriate sections of the Internal Revenue Code (IRC). Participants age 50 or over during the plan year may also make catch-up contributions.

The Company may make a discretionary matching contribution as a percentage of each participant’s pre-tax or Roth after-tax salary deferral contributions, excluding catch-up contributions. During 2024, the Company elected to match 50% of each participant’s salary deferral contributions up to a maximum of 6% of such participant’s eligible compensation earned each payroll period.

In addition, the Company may make a discretionary nonelective contribution to be allocated based on the eligible compensation for the allocation period of all benefitting participants. Discretionary nonelective contributions are allocated to participants who are employed by the Company on the last day of the plan year in accordance with Plan provisions. For the year ended December 31, 2024, the Company made a discretionary nonelective contribution in the amount of \$1,042,310 which was funded during 2025, net of forfeitures used.

The Plan allows rollover contributions from eligible retirement plans qualified under the appropriate sections of the IRC. In-plan Roth rollovers are also allowed. The Plan is participant directed and participants may change their contribution amounts and investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings. In addition, participants are charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Vesting in the discretionary matching and nonelective contributions portions of their accounts plus earnings thereon is based on years of service. Participants vest 20% after one year of service and then 20% per year until they are 100% vested after five years of service. A participant shall be immediately vested upon death, retirement, or termination of employment due to total and permanent disability.

Payment of Benefits

Normal retirement age under the Plan is 62. Upon retirement, disability, death, or termination of service with the Company, participants may receive their distributions in a lump-sum payment or other method as defined in the Plan. The Plan also permits hardship distributions and certain in-service withdrawals.

Forfeitures

Forfeitures of nonvested employer contributions may be used to pay Plan expenses, reduce employer contributions, or reallocate to participants as elected by the Company. The forfeitures balance at December 31, 2024 and 2023 was \$112,884 and \$114,311, respectively. During 2024, forfeitures of \$29,666 and \$114,311 were used to pay Plan administrative expenses and reduce the discretionary nonelective contribution, respectively. Forfeitures of \$124,884 were used in 2025 to reduce the 2024 discretionary nonelective contribution.

Notes Receivable from Participants

Plan participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance in the Plan or \$50,000, reduced by the excess, if any, of the highest outstanding balance of loans from the Plan by the participant during the one-year period ending on the day before the date on which such loan is made. Interest rates on loans are stated at 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month before the loan is originated. Loans are repaid in level installments through payroll deductions for periods ranging up to five years. Loans are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest. Participants may only have one loan outstanding at any time.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, recordkeeper and trustee. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and discretionary matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation. The Company discretionary nonelective contribution is recorded in the plan year in which compensation is paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when distributed.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain administrative fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant-Directed Brokerage Account: Account primarily consists of mutual funds and common stocks that are valued at the closing price reported by the active market on which the individual securities are traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Collective Trust Fund: Valued at NAV based on the underlying unit value reported by the trustee of the fund based on the fair value of the underlying investments less liabilities. The Putnam Fiduciary Trust Company (Putnam) Stable Value Fund is invested in high quality guaranteed investment contracts and similar investments issued by insurance companies, banks, and other financial institutions to preserve principal and achieve high current income. The fund also invests in security-backed investment contracts, including insurance separate accounts. The fund provides for daily redemptions by the Plan with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Trust Company, LLC (Empower), the trustee, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a stable value fund managed by Putnam, an affiliate of Empower. Therefore, transactions in this investment qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 6 - TAX STATUS

The Plan adopted a non-standardized pre-approved plan, which obtained its latest opinion letter dated November 14, 2022, in which the Internal Revenue Service (IRS) stated that the pre-approved document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
