INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Dailey Company, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Dailey Company, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of the year ended December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 – Description of Plan

The following description of the Dailey Company, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan created on January 1, 2017. All employees of Dailey Company, Inc. (the Company) who have one year of service, including at least 1,000 hours worked, and are age 20 or older are eligible to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees governance of the Plan, including determining the appropriateness of the Plan's investment offerings, monitoring investment performance and reporting to the Company.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds through separate pooled accounts and a guaranteed investments contract as investment options for participants. The Company matches employee contributions up to 3% plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions to the Plan and allocated earnings thereon. Participants are also 100% vested in employer safe-harbor contributions.

Distributions to Participants

Upon retirement, death, disability or termination of employment, a participant (or the participant's beneficiary, if applicable) will receive a lump sum distribution equaling their vested account balance. Participants may receive a hardship distribution from their vested account balances subject to certain limitations, as defined in the Plan.

Note 1 – Description of Plan (continued)

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate determined by the Plan agreement at the time of application. Principal and interest are paid ratably through payroll deductions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments in shares of separate pooled accounts comprised of mutual funds are stated at fair value as determined primarily by published market prices, which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. The net appreciation (depreciation) in fair value of investments includes realized and unrealized investment gains and losses. Dividends are recorded on the ex-dividend date.

Fully benefit-responsive investment contracts are reported at contract value, and the associated interest is reflected in the net appreciation (depreciation) in investments.

Notes Receivable from Participants

Participant loans are valued at their unpaid principal balances plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Defaulted loans totaling \$8,321 were recognized as distributions to participants for the year ended December 31, 2024.

Payments of Benefits

Benefits are recorded when paid.

Note 3 – Information Prepared and Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest income on notes receivable from participants as of and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company (the Trustee).

Note 4 – Tax Status

The Plan is a non-standard prototype plan which has received an opinion letter from the Internal Revenue Service dated November 30, 2020, stating the Plan qualifies under Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan is not a taxpaying entity for income tax purposes and, accordingly, no provision has been made for income taxes. The Plan's management believes it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Fair Value Measurements

FASB ASC 820-10 (formerly FASB Statement No. 157), *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted market prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. At December 31, 2024 and 2023, all Plan investments were valued using Level 2 inputs.

Level 2 – The fair value of mutual funds and pooled separate accounts (comprised of mutual funds) is based on inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 – Party-in-Interest Transactions and Administrative Expenses

The Company pays for various fees and administrative expenses on behalf of the Plan including but not limited to fees to Standard Insurance Company (Standard) as the trustee and third-party administrator as well as Thompson, Derrig & Craig, PC as the Plan auditor. Such expenses are not included in the financial statements. The Plan pays for other fees to Standard for administrative expenses as reflected in the accompanying statement of changes in net assets available for benefits.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 – Guaranteed Investment Contract with Insurance Company

In 2023, the Plan's assets were transferred to Standard, and the Plan entered into a guaranteed investment contract with the new Trustee. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the Trustee. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, or (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) the Plan's failure to abide by state or federal law, (b) failure to render performance necessary to comply with the contract terms, (c) failure to maintain the required dollar amount of assets, (d) plan disqualification, or (e) failure to adopt the plan in a reasonable period of time. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The contract value of the investment contract at December 31, 2024 and 2023 was \$323,750 and \$275,298, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Note 11 – Excluded Deferrals

During 2024 and 2023, management identified various pay periods for the years ended December 31, 2023 and 2022 where bonus compensation and other off-cycle payments were incorrectly excluded from eligible compensation for several participants. Management is in the process of making corrective contribution of approximately \$3,029 and \$1,156 to the plan to remediate the issues for the years ended December 31, 2023 and 2022, respectively. As the amount was reasonably considered to be immaterial to the financial statements, no receivable was recorded on the statement of net assets available for benefits for either year.

Subsequent to December 31, 2024, management identified more pay periods for the year ended December 31, 2024 where bonus compensation and other off-cycle payments were incorrectly excluded from eligible compensation for several participants. Management also identified various missed safe harbor matching contributions that should have been made during 2024. Management has estimated the total impact of the corrective contribution to be approximately \$2,551, and as of the date of this report, was working with the recordkeeper to remediate these items. As the amount is reasonably considered to be immaterial to the financial statements, no receivable has been recorded on the statement of net assets available for benefits.

Note 12 – Subsequent Events

As discussed in Note 11, management identified errors related to missed deferrals on off-cycle bonus payments for several participants for the year ended December 31, 2024.

Management of the Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.
