Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

Years ended December 31, 2024 and 2023

Note 1 - Description of Plan

The following description of the 401(k) Plan for The Washington Post and Companies (the Plan) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

General

The Plan is a defined contribution plan sponsored by Nash Holdings LLC (the Plan Sponsor or the Company) permitting eligible employees of the following subsidiaries of the Company to participate upon hire: WP Company LLC, Express Publications Company, LLC (closed in 2019), Post Community Media LLC, Greater Washington Publishing, LLC (closed in 2018), and Robinson Terminal Warehouse LLC (collectively, the Publishing Subsidiaries or The Washington Post and Companies). Effective March 1, 2018, except as noted in Guild and Craft Union agreements, there is no longer a match waiting period for participants to receive a Company Matching Contribution. The match waiting period was removed for Guild covered employees effective July 13, 2018.

An Administrative Committee (Plan Administrator) whose members are appointed by the Company has overall authority to administer the Plan.

Effective January 1, 2017, the Plan document was restated.

During 2024 and 2023, the Plan Sponsor adopted amendments to the Plan, which are not expected to affect the Plan's qualified status under ERISA.

Contributions

Each year, participants may contribute a percentage of pre-tax annual eligible compensation to the Plan at rates specified in the Plan document. The total pre-tax contribution, however, is subject to dollar limitations set forth by the Internal Revenue Code (the Code) (\$23,000 in 2024 and \$22,500 in 2023). Participants who are at least 50 years of age are permitted to make "catch-up" contributions. In 2024 and 2023, the maximum allowed "catch-up" contributions was \$7,500. Participants may also contribute a percentage of annual eligible compensation to the Plan as after-tax contributions at rates established by the Plan Sponsor.

Effective March 1, 2018, participants may also make Roth 401(k) contributions on the same basis as pre-tax contributions. Effective March 1, 2018, participants who do not opt out or elect a deferral rate are automatically enrolled in the Plan at a deferral percentage established by the Administrative Committee. For employees auto enrolled into the Plan, their deferral rate percentage will increase by one percentage point each April thereafter, until reaching a deferral rate percentage of 10%.

Note 1 - Description of Plan (Continued)

Contributions (Continued)

The Company Matching Contribution is equal to a percentage of the total amount of the participant's pre-tax and Roth contributions, not to exceed a percentage of their base salary as determined by the Company at its discretion. During 2024 and 2023, the Company Matching Contribution is generally 50% of a participant's pre-tax and Roth contributions, that do not exceed 6% of their base salary. Participants covered by a Craft union receive a different Company Matching Contribution, as set out in their applicable collective bargaining agreement. The Plan also provides for a Company Automatic Contribution for Utility Mailer participants. A participant's total contributions to the Plan are subject to dollar limitations set forth in the Code. Contributions are remitted to a trust that is administered by Vanguard Fiduciary Trust Company (VFTC).

Participant Accounts

Each participant's account is credited with their contributions, the Company Matching Contributions, if any, and an allocation of the investment earnings or losses. Allocations are based on participant earnings or account balances, as defined. All investments are participant directed.

Vesting

Participants hired before March 1, 2017 are fully vested at all times in all amounts held in their accounts. Participants hired on or after March 1, 2017 are fully vested except for the Company Matching Contribution in which they are vested after completing one year of service.

Forfeitures

Participants who terminate or withdraw from the Plan forfeit any amounts not vested with respect to Company contributions. In accordance with the Plan document, amounts forfeited will be used to offset plan administrative fees or to reduce employer contributions. There was \$73,918 and \$55,489, respectively in forfeitures used to offset employer contributions in 2024 and 2023.

Plan Expenses

The Company pays for some of the Plan's administrative expenses.

Payment of Benefits

At any time, a participant may withdraw after-tax employee contributions and the associated earnings. Employee tax deferred contributions, vested Company contributions, and certain related earnings may be withdrawn if, in the judgment of the Administrative Committee, a participant is suffering a serious financial hardship and other sources of funds are not available to the participant.

There is no limit to the number of non-hardship withdrawals permitted during the Plan Year. Upon attainment of age 59½, a participant may withdraw their full vested account.

Payment of Benefits (Continued)

Accounts of terminated participants may be retained in the Plan until the participant reaches age 65. At age 65, the full account balance must be distributed. The terminated participant may request at any time prior to age 65 to receive a distribution of the total amount in their account. If a terminated participant with a deferred account dies prior to receiving the full value of the account, the account balance will be paid to the participant's beneficiary.

Upon termination of employment by reason of death or total disability, or retirement on or after attaining age 65, or for any other reason, the total value of a participant's account is payable in a lump sum.

Plan Termination

The Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would receive the value of their accounts.

Note 2 - Summary of Accounting Policies

The following accounting policies, which conform with accounting principles generally accepted in the United States of America (GAAP), have been used consistently in the preparation of the Plan's financial statements:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements, in conformity with GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

Investment Valuation and Income Recognition (Continued)

The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net change in the fair value of the investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

The following is a description of the valuation methodologies used for investments:

Mutual Funds

The fair values of participation units or shares in the mutual funds are based on the publicly quoted market prices, which represents the net asset value of shares held at year end.

Common/Collective Trust

Common/Collective Trusts (the Trusts) are valued based on the net asset value of the collective trust divided by the number of trust units outstanding. Investments in collective trusts are typically valued, as a practical expedient, utilizing the net asset valuations provided by the fund, without adjustment, when the net asset valuations of the investments are calculated in a manner consistent with GAAP for investment companies. Investments that are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy and are shown as a reconciling item.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan has performed an evaluation of subsequent events through October 8, 2025, which is the date the financial statements were available to be issued and has considered any relevant matters in the preparation of the financial statements and notes.

Note 3 - Related Party Transactions

The Plan's investments include shares of registered investment companies (mutual funds) and common collective trusts that are managed by The Vanguard Group, Inc. Due to the relationship between VFTC as Plan Trustee and The Vanguard Group, Inc., investment transactions managed by The Vanguard Group, Inc. qualify as party-in-interest transactions. Investments of the Plan in the Vanguard registered investment companies and common collective trusts are exempt from the prohibited transaction rules of ERISA pursuant to a class exemption issued by the U.S. Department of Labor. In addition, the recordkeeping fees and fees associated with the management of these investments by The Vanguard Group, Inc. are included in the net change in fair value of investments.

Note 4 - Tax Status

On November 30, 2017, the Internal Revenue Service (IRS) made a favorable determination that the Plan, as then designed, was qualified under IRC Section 401(a). The determination did not involve a review of the effect on the Plan of certain amendments adopted subsequent to January 1, 2017. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Information Certified by the Plan's Trustee

Certain information related to investment balances disclosed in the accompanying financial statements and ERISA- required supplemental schedule, including investments held as of December 31, 2024 and 2023, interest and dividend income, and net change in fair value of investments for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by VFTC.

Note 6 - Fair Value Measurement

A fair value measurement is determined based on the assumptions that a market participant would use in pricing an asset or liability, based on a three-tiered hierarchy that draws a distinction between market participant assumptions based on (i) observable inputs, that the Plan has the ability to access such as quoted prices in active markets (Level 1); (ii) inputs other than quoted prices in active markets that are observable either directly or indirectly for substantially the full term of the financial instrument (Level 2); and (iii) unobservable inputs that require the Plan to use present value and other valuation techniques in the determination of fair value (Level 3). Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measure. The Plan's assessment of the significance of a particular input to fair value measurements requires judgment and may affect the valuation of the assets and liabilities being measured and their placement within the fair value hierarchy.

Common/Collective Trust

The Plan's investment in common/collective trusts consist of the Vanguard Target Retirement Income Trust II and the Vanguard Target Retirement 2020 through 2070 Trusts II (collectively, the Retirement Date Trusts) as of December 31, 2024.

The investment objective of the Vanguard Target Retirement Income Trust II is to provide current income and capital appreciation for investors currently in retirement. The investment objective of the Retirement Date Trusts is to employ an asset allocation strategy designed for investors planning to retire in or within a few years of the target year stated in the Trust's name. The asset allocation of the Trusts will become more conservative over time as its target date approaches. There are no restrictions on redemptions of the Plan's investment in the Trusts, no unfunded commitments, and participants may redeem investments daily as of December 31, 2024.

Note 7 - Concentrations

Plan investments held in various Vanguard funds approximated 98% and 97% of total investments as of December 31, 2024 and 2023, respectively.
