### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Elwyn Defined Contribution 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### 1. Description of Plan

The following description of the Elwyn Defined Contribution 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan that was established on July 1, 2018 and covers substantively all employees of Elwyn of Pennsylvania and Delaware and, effective September 30, 2024, Elwyn New Jersey (collectively, the Organization). Lincoln Retirement Services Company, LLC (Lincoln Retirement) provides recordkeeping services for the Plan and Lincoln Financial Group Trust Company serves as custodian of the Plan's investments. The Administrative Committee, as Plan administrator, is responsible for the oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Plan Merger*

Effective September 30, 2024, the Elwyn New Jersey 403(b) Plan, a Plan sponsored by Elwyn New Jersey, an affiliate of Elwyn of Pennsylvania and Delaware, merged into the Plan. The net assets of the Elwyn New Jersey 403(b) Plan totaling \$2,420,666 were transferred and are included as transfer in of assets from other plan on the statement of changes in net assets available for benefits. As a result of the merger, the Plan document was amended and restated effective September 30, 2024.

#### *Contributions*

Each year, participants may contribute a portion of their annual compensation, as defined in the Plan document, immediately upon being hired by the Organization. The Plan provides for a 2% automatic contribution arrangement unless a participant make a contrary election. Participants' contributions may be made on a pre-tax basis or Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Contribution elections of former participants of the Elwyn New Jersey 403(b) Plan were automatically transferred to the Plan. Any former participants with no affirmative election from the Elwyn New Jersey 403(b) Plan were automatically enrolled in the Plan with a 2% election.

Participants may also contribute amounts representing distributions from other qualified retirement plans or IRA Accounts (rollover) and plan-to-plan transfers from legacy Elwyn 403(b) vendors. The amount received by the Plan for rollovers and plan-to-plan transfers are shown together as other contributions on the statement of changes in net assets available for benefits.

The Organization makes an employer match equal to the participant contribution up to 2% of participant compensation. All participant contributions, including pre-tax, Roth and catch-up contributions, are eligible for the employer match contribution. Eligibility for the employer match contribution requires the participant to have completed 1,000 hours of service during the Plan year.

The Organization also makes a fixed employer contribution. Eligibility for the fixed employer contribution requires the participant to have completed 1,000 hours of service during the Plan year and to be employed on the last day of the Plan year. The Organization has certain employees covered under one of four collective bargaining agreements. Eligible participants covered by these agreements receive a fixed employer contribution equal to 2% of their eligible compensation and eligible participants not covered by these agreements receive a fixed employer contribution equal to 4% of their eligible compensation.

In addition to the fixed employer contribution, the Organization may elect to make a discretionary contribution based on a pro rata formula of the participant's compensation to total eligible participants' compensation. For 2024, there was a discretionary contribution equal to .05% of compensation.

The Organization may also make qualified non-elective contributions (QNECs) to the Plan, which is a discretionary contribution. The QNEC contribution can be a uniform percentage of Plan compensation, a uniform dollar amount or a target contribution. There were no QNEC contributions made during 2024.

Effective September 30, 2024, employees of Elwyn New Jersey were eligible to receive the employer match based on participant contributions made from October 1, 2024 to December 31, 2024 and the fixed employer contribution based on eligible compensation for 2024 if they completed 1,000 hours of service, including their credited service hours from the Elwyn New Jersey 403(b) Plan. In addition, employees of Elwyn New Jersey were eligible to receive the discretionary contribution based on eligible compensation from October 1, 2024 to December 31, 2024.

The Organization's contributions are made once a year and are recorded as an employer contribution receivable in the accompanying statements of net assets available for benefits.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions and the contributions made by the Organization into various investment options offered by the Plan.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contributions and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Participant accounts are charged an administrative expense based on specific transactions initiated by the participant. The benefit to which a participant is entitled is the vested portion of their accounts.

### ***Vesting***

Participants are vested immediately in their individual deferral, Roth and rollover contributions and the allocated earnings thereon. Vesting in the Organization's employer match and fixed employer contribution portions of their accounts is based on years of continuous service and a participant is 100% vested after three years of credited service. Participants are vested immediately in the Organization's discretionary and QNEC contributions.

### *Notes Receivable from Participants*

Participants actively employed by the Organization may borrow from their deferral, Roth, rollover, plan-to-plan and QNEC accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The repayment period may not exceed five years, unless it is for the purchase of a principal residence, which may not exceed fifteen years. Participants may not have more than one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through payroll deductions or through an automatic repayment program between the participant and Lincoln Financial Group Trust Company.

### *Payment of Benefits*

Upon separation of service due to death, disability, retirement or other reasons, a participant may elect to receive a distribution equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments. Participants may elect to rollover their vested balance to another qualified retirement plan or Individual Retirement Arrangement (IRA). For terminated participants with a vested account balance less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Participants may obtain an in-service distribution upon becoming disabled or after reaching age 59½. Hardship distributions are permitted under certain circumstances as outlined in the Plan document. In-service and hardship distributions may only be obtained from a participant's contribution and rollover accounts as Organization contribution accounts are not eligible for these distributions.

### *Forfeitures*

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$338,933 and \$212,762, respectively. These accounts will be used to reduce future Organization contributions or pay reasonable Plan expenses. Forfeitures applied to the Organization's contributions must be used in the Plan year in which the forfeiture occurs. The forfeitures balance as of December 31, 2023 was utilized to reduce the 2023 Organization's contributions funded in September 2024. The forfeitures balance as of December 31, 2024 was utilized to reduce the 2024 Organization's contributions funded in October 2025.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for fully benefit-responsive (FBR) investment contract, which is reported at contract value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by Lincoln Financial Group Trust Company. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion of the FBR contract.

Investment transactions (purchases and sales) are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

### ***Contributions Receivable***

Participant contributions are recognized in the period during which the Organization makes the respective payroll deduction from the participant's compensation. Employer contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are paid by the Organization and excluded from these financial statements. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Certain transactional fees are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### 3. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule (Schedule of Assets (Held at End of Year)), related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment at Contract Value

The Plan entered into a fully benefit-responsive guaranteed investment contract, Lincoln Stable Value Account (the Contract), with The Lincoln National Life Insurance Company (Lincoln). Contributions are part of the general assets of Lincoln and are used by the Contract to purchase an annuity.

Because the Contract is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the Lincoln Stable Value Account. Contract value, as reported to the Plan by Lincoln, represents accumulated cash contributions, interest credit to the contract less any withdrawals. The crediting interest rate is determined by Lincoln and may not be less than 1%. The contract value of this investment was \$1,446,991 and \$1,368,005 as of December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Upon Contract discontinuance, money may be withdrawn from the Contract based on the selected payment option of the five year book value option or the market value option, which is subject to a market value reduction factor. Participant withdrawals can be taken without a market value adjustment for hardship needs, death, retirement, or separation from service. Participant-initiated periodic elective withdrawals may be limited to a percentage of the guaranteed investment contract or subject to a ninety-day equity wash provision. The standard provision for a ninety-day wash means that there are no transfers allowed to a competing fund. Any other transfers to noncompeting funds must remain in the noncompeting fund for ninety days before being subsequently transferred to the competing fund. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Contract permits Lincoln or the Organization to terminate the agreement with 90 days written notice.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions will be discontinued, and all Plan participants will become fully vested in their account balances.

### 7. Tax Status

The Plan uses a pre-approved plan document sponsored by Lincoln Retirement. Lincoln Retirement received an opinion letter from the IRS, dated March 31, 2017, which states that the pre-approved Plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks, such interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 9. Related Party and Party-In-Interest Transaction

Certain Plan investments are in funds and accounts that are managed by Lincoln Retirement or its subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Lincoln Retirement by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 10. Delinquent Participant Contributions

During 2023, participant contributions for one pay period in the amount of \$181 were not remitted by the Organization within the appropriate time period as prescribed by the Department of Labor (DOL) Regulations. This transaction constitutes a non-exempt party-in-interest or prohibited transaction as defined by ERISA. The Organization self-corrected this transaction during 2024 by remitting related lost earnings to the Plan.
