NOTES TO FINANCIAL STATEMENTS

December 31, 2024

NOTE A -- Description of the plan and significant accounting policies

The following description of The Elkin Company & Affiliates Profit Sharing Plan ("the plan") provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions. The employer, as described below, has adopted The Retirement Advantage, Inc. Non-Standardized Pre-Approved Profit Sharing Plan with an original effective date of September 30, 1968. The employers amended and restated the plan with the most recent restatement effective January 1, 2022.

General

The plan is a defined contribution plan covering eligible employees of Elkin Operations, Inc., American Industrial Leasing Co., Inc., Echo Lake Foods, Inc., Echo Lake Huntington, Inc., Echo Lake Transport, Inc., Aluma-Tec Industries, Inc., The Elkin Company, LLC, Elkin Properties, LLC, Blue Grass Real Estate Co., LLC, Echo Yorkville, LLC, Xenitel, Inc. ELT, LLC and Ailco Equipment Finance Group, Inc. ("the employers") who are age 19 or older and have completed one year of service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for governance of the plan, determining the appropriateness of the plan's investment offerings, and monitoring investment performance.

The plan's federal identification number is 39-1264653, and the plan's number is 333.

Contributions

Each year, participants may contribute up to the maximum allowed by law of their annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. Employer contributions to the plan consist of matching and profit sharing contributions, both of which are discretionary. The employers' discretionary matching contribution ranged from 50% to 66.67% of participant's contributions to the plan up to the maximum of 4% of participant's compensation. Additional profit sharing contributions may be contributed at the option of the employers' board of directors. In 2024 and 2023, the employers made additional profit sharing contributions ranging from 0% to 10% of eligible compensation. During the years ended December 31, 2024 and 2023, the employers made \$200,736 and \$190,579 profit sharing contributions to the plan, respectively. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the company.

NOTE A -- Description of the plan and significant accounting policies (Continued)

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contributions and allocations of (a) the employers’ matching and discretionary contributions, (b) plan earnings and (c) charged with an allocation of administrative expenses. Allocations of plan earnings are based on participant account balances, as defined, and allocation of employers’ contributions are based on participants’ compensation, as provided in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The plan permits the transfer of funds from other qualified plans to a separate participant’s rollover account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employers’ matching and profit sharing contribution portion of their accounts is based on years of continuous service. Participants vest over a six-year period at a rate of 20% per year starting in year two. Participants who leave the plan because of death or disability or reaching normal retirement age, as defined in the plan, are considered 100% vested in all amounts.

Participant loans

Participants may not borrow from their fund accounts.

Benefits

On termination of service due to death, disability, retirement (age 65), or termination of service due to other reasons, a participant with an account valued at less than \$5,000 will receive the value of the vested interest in their account as a lump-sum distribution. For accounts exceeding \$5,000, the participant may elect a lump-sum distribution; installment payments of required minimum distribution purposes only; defer such distribution to any valuation date subsequent to his or her termination, but no later than the valuation date of his or her normal retirement date; or elect to rollover the distribution to another qualified plan. The plan permits in-service distributions at age 59 ½. The plan also permits hardship distributions if certain criteria are met.

Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$378 and \$11,433, respectively. These accounts may be used to pay plan expenses, restore forfeitures or reduce employer contributions (or reallocate as employer contributions). Expenses and employer contributions totaling \$46,861 and \$33,954 were paid from forfeitures in 2024 and 2023, respectively.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the plan are prepared in conformity with accounting standards generally accepted in the United States of America (“U.S. GAAP”) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments valuation and income recognition

The plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The plan pays some of the administrative expenses. The major administrative expenses are recordkeeping and investment fees.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and adjustment to net appreciation/depreciation in fair value of investments. The plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 31, 2025 and 2024, respectively.

Subsequent event

These financial statements have not been updated for subsequent events occurring after October 10, 2025, which is the date these financial statements were available to be issued. The plan administrator has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Information Certified by the Trustee and Asset Custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and interest and dividends and net appreciation for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company ("Principal"), the asset custodian and trustee of the plan.

Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available. The plan has no assets requiring Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.
- Collective trust funds. A fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation/depreciation in fair value of investments.

NOTE D -- Party-in-interest transactions

Principal is the asset custodian and trustee of the plan as of and for the years ended December 31, 2024 and 2023, and is, therefore, designated as a fiduciary and party-in-interest. The plan regularly invests in a collective investment funds, for which Principal and its affiliates are the issuing party. Principal Life Insurance Company is the contract administrator of the plan and is therefore designated as a party-in-interest. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

NOTE E -- Plan termination

Although it has not expressed any intent to do so, the employers have the right under the plan to discontinue their contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their allocated employers' contributions.

NOTE F -- Tax status

The Retirement Advantage, Inc. Non-Standardized Pre-Approved Profit Sharing Plan, that the plan has adopted effective January 1, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The plan has since been amended since the date of the opinion letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risk

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE I -- Excess contributions payable

The plan failed the discrimination test for the years ended December 31, 2024 and 2023. Excess contributions amounting to \$79,541 and \$81,442 at December 31, 2024 and 2023, respectively are recorded as liabilities in the accompanying Statements of Net Assets Available for Benefits and as a reduction to participant-directed contributions for the years and adjustments to net appreciation in fair value of investments. The plan reimbursed these contributions to its participants during 2025 and 2024, respectively. For purposes of the Form 5500, these excess contributions are not recorded until the year paid.

NOTE J -- Subsequent event

Effective June 2, 2025, the Plan sponsor was changed from The Elkin Company, LLC to Echo Lake Foods, LLC. and the plan's name was changed to Echo Lake Foods & Affiliates Profit Sharing Plan. Additionally, Elkin Operations, American Industrial Leasing, Alico, Aluma-Tec, Elkin Properties, LLC and the Elkin Company, LLC ceased participating in the plan.

On April 8, 2025, the Company received an offer letter for the equity purchase of Echo Lake Foods, Inc. ELT, Echo Lake Huntington, Inc., Xenitel, Inc., Echo Lake Huntington 435, LLC, Blue Grass Real Estate Co LLC and Echo Yorkville, LLC from Cal-Maine Foods, Inc. ("buyer"). The offer was accepted and the sale was closed in June 2025. As a result of the acquisition transaction the Plan will be terminated effective December 31, 2025 and all participants account balances will be rolled into the Cal-Maine Foods, Inc. KSOP plan on January 2, 2026.
