### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Silver Point Capital, L.P. Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Silver Point Capital, L.P. Savings & Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.



**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Silver Point Capital, L.P. Savings & Retirement Plan (the "Plan") for eligible employees of Silver Point Capital, L.P. and Argentum Peak, LLC (collectively, the "Employer") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, sponsored by Silver Point Capital, L.P. (the "Plan Sponsor"). The Plan is offered to substantially all employees who have completed three months of service.

Fidelity Management Trust Company (the "Trustee") serves as the trustee of the Plan and its assets, excluding the investment in Silver Point Capital Offshore Fund, Ltd. (the "Offshore Fund"). Trustees of the Plan with regard to the Offshore Fund are certain employees of the Plan Sponsor, as appointed by the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Sponsor is responsible for the oversight of the Plan and determines the appropriateness of investment offerings and monitors the investment performance.

Contributions

*Employee contributions* - The Plan includes a 401(k) provision, which allows for employee deferrals. For the 2024 and 2023 Plan years, participants are allowed to elect a deferral of up to 85% of pre-tax annual salary and up to 100% of pre-tax bonus, as defined in the Plan document, up to the maximum allowed by the Internal Revenue Code ("IRC"). All new eligible employees are automatically enrolled in the Plan at a default percentage of 3% of salary unless they opt out or elect to change the default election deferral.

For the 2024 and 2023 Plan years, the 401(k)-deferral limit was \$23,000 and \$22,500, respectively. Participants in the Plan are eligible to make a catch-up contribution beginning in the calendar year that they reach age 50. The maximum catch-up contribution permitted for 2024 and 2023 was \$7,500. Participants may also make rollover contributions representing distributions from other qualified defined benefit or defined contribution plans.

Employees are eligible to designate some or all of their elective deferral as a Roth deferral contribution funded through after-tax annual compensation. Once made, this election is irrevocable. Pre-tax and Roth deferral contributions are added together to determine the deferral limit.

*Employer matching contributions* - The Employer may make a discretionary matching contribution for each participant in an amount equal to the percentage declared for the contribution period. There were no employer matching contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is increased or decreased, as appropriate, by the participant's contributions, the Employer's contributions, if any, an allocation of investment earnings or losses, administrative expenses, withdrawals, and distributions. Refer to Note 2 for information on investment valuation and income recognition on individual participant's account balances. Participants are entitled to the vested amounts within their accounts.

Investments

Except for the Plan's investment in the Offshore Fund, the Plan's investments are held by the Trustee. Participants direct their contributions into the investment options offered by the Plan which include mutual funds, common collective trust funds and a self-directed brokerage account. Employer contributions, if any, are automatically invested into each participant's selected investment options. Refer to Notes 2, 3 and 4 regarding the Offshore Fund.

The self-directed brokerage account offered by the Plan is the Fidelity BrokerageLink Account, which is intended for sophisticated participants who are willing to take on additional risk and are prepared to assume the responsibility of monitoring their portfolio.

Vesting

Participants are immediately vested in their voluntary contributions as well as Employer matching contributions, if any, plus actual earnings thereon.

Participant Borrowings and Withdrawals

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loan transactions are treated as transfers between the investment fund and the participant loan fund. Loans are repayable over a period of up to five years, unless the proceeds are used to purchase a primary residence, which may extend the loan term beyond five years. The loans bear interest at a rate of Prime plus 1% as determined at the time the loan is approved. Principal and interest are payable ratably through payroll deductions corresponding to the participant's regular payroll terms.

Participants may also obtain a cash withdrawal of all or a portion of the value of their deferral contributions on the basis of hardship as permitted under the Plan.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant, or his/her beneficiaries, may elect to receive a distribution in a lump-sum amount equal to the value of the participant's vested account balance. For termination of service for other reasons, a

participant may receive the value of the vested interest in his/her account as a lump-sum distribution subject to federal withholding requirements, where applicable.

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") and are stated in United States Dollars. The following is a summary of the significant accounting policies used in preparing the financial statements:

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Plan Expenses

Certain expenses of maintaining the Plan are borne by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded as distributions when paid. There were no amounts payable as of December 31, 2024 and 2023 to participants who elected to withdraw from the Plan.

Notes Receivable from Participants

Notes receivable from participants result from participant loans and are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Sponsor deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were no discharged loans included in the benefit payments to participants on the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's investment in the Offshore Fund is recorded at fair value, which represents the Plan's proportionate interest in the capital of the Offshore Fund. See Note 4 for discussion on valuation techniques. As of October 2007, participants may no longer contribute to the Offshore Fund through the Plan.

The Plan offers investment options in common collective trust funds. See Note 4 for discussion on valuation techniques.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

The statement of changes in net assets available for benefits includes the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains (losses) and the change in unrealized appreciation (depreciation) of those investments bought, sold, and held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits. The Plan's investment in the Offshore Fund is not charged management fees.

**NOTE 3. INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income from notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information certified by the Trustee, except for comparing such information with the related information included in the financial statements and supplemental schedule.

Assets invested in the Offshore Fund are not covered under the certification.

**NOTE 4. FAIR VALUE MEASUREMENTS**

In accordance with the authoritative guidance on fair value measurements and disclosures under U.S. GAAP, the Plan follows a standard that establishes a three-level valuation hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels are defined as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets. Since valuations are based on quoted market prices that are readily and regularly available in each active market, valuation of these securities does not entail a significant degree of judgment.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Mutual funds** are valued at the daily closing price as reported by each fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are actively traded and are included in Level 1 of the hierarchy.

**Self-direct option** investments are measured as individual shares held multiplied by the closing price at the valuation date. These accounts include cash and cash equivalents, equities, mutual funds, and other investments with quoted prices in active markets and are included in Level 1 of the hierarchy.

**Common collective trust funds** are valued using the NAV provided by the fund's administrator which represents the value of the underlying assets owned by the common and collective trust fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value since it is unlikely that the investments will be sold for an amount different than the reported NAV.

**The Offshore Fund** is an investment vehicle recorded at fair value using NAV, which represents the Plan's proportionate interest in the capital of the Offshore Fund as of the reporting date. The NAV is used as a practical expedient to estimate fair value as it approximates the distribution amount the Plan would receive if the Plan's investment were liquidated.

The common collective trust funds and the Offshore Fund are measured at fair value using NAV as a practical expedient and therefore these investments have not been categorized in the fair value hierarchy. The Plan Sponsor monitors the Trustee of the Plan, including its valuation policies, and has accepted and adopted those valuation policies. However, the valuation policies of the Offshore Fund are determined directly by the Plan Sponsor.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

- a) The fund seeks to preserve its principal investment while earning a level of interest income that is consistent with principal preservation. The fund seeks to maintain a stable NAV of \$1 per share. The fund invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds.
- b) The fund seeks long-term capital appreciation by investing, under normal market conditions, at least 80% of its net assets in equity securities of United States companies with market capitalization in excess of \$4 billion at the time of purchase. The fund may also invest up to 20% of its net assets in non-United States equity securities.
- c) The objective of the Offshore Fund is to achieve superior risk-adjusted returns by investing in debt, equity or other securities or obligations of misvalued, leveraged or financially distressed companies and in event-oriented and other special situations. The Offshore Fund is valued at the NAV determined by the investment manager, pursuant to the valuation policy and procedures established by the investment manager. The Plan Sponsor, which is also the investment manager, has used NAV as a practical expedient as provided in current Financial Accounting Standards Board ("FASB") guidance.

**NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity Investments Institutional Operations Company, Inc. ("Fidelity"). As defined by the Plan document, the Trustee is an affiliate of Fidelity and, therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

Pursuant to the Plan documents, Fidelity receives revenue from certain mutual fund and common collective trust fund service providers for services it provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan and any excess revenue is remitted to the Plan on a quarterly basis. For the year ended December 31, 2024, there was no excess revenue, and fees paid by the Plan to Fidelity for recordkeeping services amounted to \$2,872 and are included as a reduction to net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits. As described in Note 2, the Plan Sponsor bears all other fees related to the Plan's operations.

The Plan invests in the Offshore Fund, which is managed by the Plan Sponsor. During 2024, the Plan did not subscribe or redeem any investment balances from the Offshore fund. The change in unrealized gain from the Plan's investment in the Offshore Fund is included in net appreciation (depreciation) in fair value of investment on the statement of changes in net assets available for benefits.

**NOTE 6. FEDERAL INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, which stated that the prototype document satisfied the applicable provisions of the IRC. Although the Plan has been amended since the effective date of the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7. RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments, including mutual funds and common collective trusts. The following summary of certain risk factors is not intended to be a comprehensive explanation of all the risks related to investing in the Plan. Investment instruments, in general, are exposed to various risks such as market risk, interest rate risk, foreign market risk and security selection. The relevant prospectus for each of the Plan's mutual fund investments should be reviewed, in its entirety, for further details on risks associated with any particular investment. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. All investments risk the loss of capital.

The Plan's investment in the Offshore Fund (which is historical only, as no new investments are permitted in the Offshore Fund) is subject to various risk factors including, but not limited to, regulatory risk, market risk, credit risk and liquidity risk. The Offshore Fund's investment program involves, without limitation, risks associated with limited diversification and concentration, leverage, investments in speculative assets, currencies, volatility, tracking risks in hedged positions, security borrowing risks in short sales and other risks inherent in the Offshore Fund's activities. Certain investments of the Offshore Fund are considered to be illiquid. There is no guarantee that the fair value determined for any investment will ultimately represent the value that will be realized by the Offshore Fund on the disposition of any investment. The Offshore Fund's activities could result in a loss of some or all of the Offshore Fund's capital. Refer to the Confidential Offering Memorandum of the Offshore Fund for further details on risks associated with an investment in the Offshore Fund.

**NOTE 8. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA.

**NOTE 9. SUBSEQUENT EVENTS**

The Plan's management has evaluated the period from January 1, 2025 to October 9, 2025, the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under FASB Accounting Standards Codification 855, Subsequent Events.
