### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Emeriti Retiree Health Plan for Northwood University (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### ***Basis of Accounting***

Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of modified cash basis financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the modified cash financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

### **Note 1 - Plan Description**

The following description of Emeriti Retiree Health Plan for Northwood University (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan was established in September 2006 as a defined contribution health and welfare plan to provide for the payment or reimbursement of health care benefits for retirees. The Plan covers all full-time employees of Northwood University (the "University") who are age 21 or older except for those employees enrolled in Northwood University Group Health Care Plan and employees covered under a collective bargaining agreement, which include retiree health benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Benefits***

The Plan makes available certain health benefits to retired participants of the Plan. Retirees may elect an emeriti health insurance option as a retiree in the Plan after reaching retirement eligibility, defined in the Plan as attaining the age of 55 and having completed 10 years of consecutive service to the University or after attaining the age of 65 and having completed 5 years of continuous service to the University. The two general types of options for health insurance coverage include a pre-65 option and post-65 option based on the participant's age. Post-65 retirement options include prescription drug coverage, and participants must enroll within 90 days of attaining the age of 65. Monthly insurance premiums are incurred by the selection of a health insurance option and are deducted from the participant's voluntary employees' beneficiary association (VEBA) account. If the participant account is exhausted, participants may retain coverage under the emeriti health insurance option by paying insurance premiums directly from a personal checking or savings account.

A participant is eligible for reimbursement benefits payable from the nonforfeitable balance in his or her VEBA account upon the date the participant ceases to be employed and attains age 55. Retirees who have a balance in their VEBA accounts are immediately eligible for reimbursement. Participants may submit qualified medical expenses claim forms along with the required documentation for reimbursement. In the event of the death of a participant, the dependent named on the account may submit qualified medical expenses for reimbursement until the account is exhausted.

#### ***Special Benefit Circumstances***

If the participant ceases to be employed by the University prior to attaining age 55 and the aggregate balance of the VEBA account is less than \$5,000, then the participant is immediately eligible to use the VEBA accounts for qualified medical expenses.

If the participant has a terminal illness or injury expense, the participant is immediately eligible to use the VEBA account for qualified medical expenses.

If the participant and/or eligible dependents have incurred medical expenses during a single 12-month period that exceed \$15,000, the participant is immediately eligible to use the VEBA account for qualified medical expenses for any amount greater than \$15,000.

#### ***Contributions***

The Plan allows participants to contribute after-tax payroll deductions in specific whole dollar amounts. In the case that a participant's account is exhausted, the participant may retain coverage under the emeriti health insurance option by paying insurance premiums through contributions made directly to the Plan from a personal checking or savings account. The University contributes \$400 a year to each eligible participant, as outlined in the plan document.

### **Note 1 - Plan Description (Continued)**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the University's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are immediately vested in their individual after-tax contributions and earnings thereon. Participants who have satisfied the retirement eligibility requirements, as outlined in the Plan, will avoid forfeiture of the employer contribution account. If retirement eligibility was not met, employer contributions are fully vested after five years of continuous service (partial vesting is not granted under the terms of the Plan).

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. After the death of the participant, spouse, and covered dependents, any remaining account balance is forfeited to the Plan. Forfeitures of employer contributions are used to reduce future university contributions. Forfeitures of approximately \$9,300 were used to reduce university contributions during the year ended December 31, 2024. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$3,300 and \$7,800, respectively.

#### ***Party-in-interest Transactions***

For a portion of the year, all plan assets were in investment funds managed by Teachers Insurance and Annuity Association of America (TIAA) and TIAA Trust, N.A. or their affiliates. TIAA was the service provider of the Plan, and TIAA Trust, N.A. was a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Modified Cash Basis of Accounting***

The accompanying financial statements have been prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). On a modified cash basis of accounting, revenue is recognized when cash is received, and expenses are recognized when paid. On a GAAP basis of accounting, revenue would be recognized as earned and expenses recognized when obligations are incurred. Investments are recognized at fair value, which is consistent with GAAP.

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Benefit Payments***

Benefits are recorded when paid.

### **Note 2 - Summary of Significant Accounting Policies (Continued)**

#### ***Administrative Expenses***

Administrative expenses of approximately \$9,000 for the year ended December 31, 2024 were paid by the University.

#### ***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the modified cash basis financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the modified cash basis financial statements.

#### ***Subsequent Events***

The modified cash basis financial statements and related disclosures include evaluation of events up through and including October 7, 2025, which is the date the modified cash basis financial statements were available to be issued.

### **Note 3 - Tax Status**

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the trust's net investment income is generally exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the plan sponsor believes that the trust continues to qualify and to operate in accordance with applicable provisions of the Code.

### **Note 4 - Certified Information**

In 2024, the Plan changed its custodian from TIAA and TIAA Trust, N.A. to Alta Trust (collectively, the "Custodians"). The Custodians of the Plan held the Plan's investments and executed all investment transactions during the periods under audit. The investment balances and related investment results included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by TIAA, as agent for TIAA Trust, N.A., and Alta Trust.

### **Note 5 - Plan Termination**

Although it has not taken steps to do so, the University has the right under the Plan to discontinue contributions, eliminate any form of benefit, or terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations, and all participants will become fully vested in their account balances.

### **Note 6 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

### Note 6 - Fair Value Measurements (Continued)

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### Mutual Funds

The mutual funds are valued at quoted prices reported in active markets.

#### Money Market Fund

The money market fund is valued at quoted prices reported in active markets.
