INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
MVP Holdings Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MVP Holdings Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Ascensus Trust Company, the trustee of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Document (including the Adoption Agreement) for a more complete description of the Plan's provisions.

General

Prior to 2017, employees were paid and had benefits through Murfin, Inc., 50% owner of MVP Holdings, LLC (the Company). Effective January 1, 2017, certain employees were spun out from Murfin, Inc. to the Company. Coincident with the spin-off, the Company established MVP Holdings Retirement Plan. The participant account balances and assets related to those employees were transferred out from the Murfin, Inc. Retirement Plan into MVP Holdings Retirement Plan.

MVP Holdings Retirement Plan is a defined contribution plan covering substantially all employees, other than those classified as a member of a collective bargaining unit, leased, or temporary employee, of MVP and its subsidiaries. Employees are eligible for participation at date of hire and when they have attained the age of 18. The Plan administrator has appointed Ascensus Trust Company (Ascensus) as the trustee for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides that active participants may make pre-tax and Roth after-tax contributions of up to 75% of their annual compensation to the Plan up to the maximum allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various mutual funds offered by the Plan. Eligible participants may also elect to make catch-up contributions, as defined by the Plan.

The Plan utilizes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contribution invested in a designated balanced fund until changed by the participant.

The Company's Qualified Automatic Contribution Arrangement (QACA) ADP safe harbor match is 100% of the participant contributions and not more than 6% of compensation. The QACA ADP safe harbor match was \$871,007 for the year ended December 31, 2024. Additional qualified matching contributions may be made at the discretion of the Company. QACA ACP safe harbor match may be made if necessary to timely allocate forfeitures in any given plan year. No discretionary qualified match or QACA ACP safe harbor match were made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses. Allocations are based on the provisions of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (Continued)

Vesting

Each participant's contribution to the participant's account is fully vested and nonforfeitable.

Prior to September 1, 2023, Participants became 50% vested in the Company's QACA ADP safe harbor matching contributions plus actual earnings or losses thereon after one year of service and 100% vested after two years of service. Participants are immediately vested in any discretionary qualified matching contributions or QACA ACP safe harbor matching contributions and actual earnings or losses thereon. Effective September 1, 2023, participants are immediately vested in all matching contributions plus actual earnings or losses thereon.

Payment of Benefits

After termination of employment, the Plan provides for benefits which are payable in a single lump sum or non-recurring partial payments if the participant terminates employment after becoming vested, retires, becomes permanently disabled, or in the event of death.

When a participant retires, the payment will be deferred unless the participant elects immediate distribution. Required minimum distributions cannot be deferred later than April 1 of the year following the year in which an employee attains the age of 70½. These required minimum distributions are paid as installments unless the participant elects to receive distributions in one of the forms previously described.

For participants whose balances do not exceed \$5,000, mandatory distributions are required immediately following severance from employment.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts are used to pay reasonable plan expenses and/or to reduce future employer contributions. Unallocated forfeitures of nonvested portions of participants' accounts were \$10,054 and \$368 at December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions were \$245 in 2024.

Notes Receivable from Participants

Participants who are actively employed by the Company may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the borrowing participant's account balance or \$50,000, reduced by the participant's highest outstanding note balance during the one-year period immediately preceding the date as which the note is made. Notes may only be issued for certain purposes, as outlined in the loan policy, and participants are limited to one outstanding note. The note is secured by the balance in the participant's account and bears interest at the prime rate. Principal and interest are paid through payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements of the Plan have been prepared using the accrual method of accounting and present the net assets available for plan benefits and changes in those net assets based on fair value.

Investments

All investments are carried at fair value, which is based on quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid. There were no withdrawals requested but unpaid at December 31, 2024.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participant accounts would immediately become fully vested.

NOTE D - PLAN EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are therefore excluded from these financial statements. Fees related to the payment of benefits and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

NOTE E - CONCENTRATIONS

Four funds with the highest value comprised approximately 52% and 49% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

NOTE F - TAX STATUS

The IRS has determined and informed the prototype's sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The following tables present fair value measurement information for certain financial instruments.

NOTE G - FAIR VALUE MEASUREMENTS (Continued)

FASB ASC 820-10, Fair Value Measurement, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were used by the Plan.

Level 1 Fair Value Measurements

The Plan invests in Vanguard Cash Reserves Federal Money Market Fund, which is a highly liquid money market fund and is considered to be a cash equivalent.

The fair value of money market fund, mutual funds and common/collective trust are based on quoted net asset values of the shares held by the Plan at year end.

Certain Plan assets are managed by The Vanguard Group, Inc. (Vanguard). Ascensus, the trustee and recordkeeper for the Plan, is a subcontractor of Vanguard. Therefore, these transactions qualify as party in interest.

The Plan issues notes to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party in interest transactions.

A member of the Plan Oversight Committee had a note in the amount of \$25,000. This note had a balance of \$8,129 at December 31, 2024.

NOTE K - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued and determined that no additional disclosures were necessary.
