Note 1. Description of Plan

The following description of the Astronautics Corporation of America and Kearfott Corporation Deferred Savings and Profit Sharing Plan (Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that covers employees of Astronautics Corporation of America and Kearfott Corporation (Company), with the exception of leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: There is no age requirement for eligibility. Other provisions are as follows:

Deferred savings: An employee is eligible to participate on the first day of the month coinciding with or following the completion of 60 days of employment.

Company matching: Eligibility requirements mirror the deferred savings.

Non-elective: An employee is eligible to immediately participate after completion of at least 1,000 hours of service during the 1-year period commencing on their initial date of employment.

Contributions: Participants may make pre-tax and Roth contributions, up to 75% of eligible compensation, subject to certain Internal Revenue Code (IRC) limitations. Upon fulfilling eligibility requirements, an employee will automatically be enrolled in the Plan at a 3% deferral percentage. Participants can opt out of participating or choose different deferral percentages. Unless an affirmative election is made, the deferral percentage of auto-enrolled participants will increase by 1% each year, not to exceed 10%.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Discretionary profit-sharing contributions are determined by the Board of Directors and are allocated pro rata to eligible participants based upon the compensation of the participant to the total compensation of all participants. To receive an allocation, a participant must work 1,000 hours and be employed on the last day of the Plan year. These requirements will be waived in the event of death, disability, retirement, or termination of employment as part of a reduction-in-force.

The Company may make discretionary matching contributions. For the year ended December 31, 2024, the Company made a matching contribution of \$0.50 for each dollar a participant contributed to the Plan, limited to the first 6% of the participant's salary deferral.

Note 1. Description of Plan (cont.)

Contributions (cont.): Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common collective trust funds as investment options for participants.

Participant Accounts Each participant's account is credited with the participant's contributions, Company contributions, allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of credited service. Participants vest over the following schedule: 0-1 year-0%; 1 year-25%; 2 years-50%; 3 years-75%; 4 years-100%.

Participants who have not completed an hour of service with the Company on or after September 15, 2015 are subject to an alternate vesting schedule: 0-1 year-0%; 2 years-20%; 3 years-40%; 4 years-60%; 5 years-80%; 6 years-100%.

Participants become 100% vested upon retirement (or after the early retirement age of 60 years) and in the event of death or disability.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at approximate market rates at the loan inception date.

Payment of Benefits: On termination of service due to death, disability, retirement or separation from service, a participant may receive benefits in a lump sum, installments or partial withdrawals equal to the value of the participant's vested interest in his or her account. A participant may also receive in-service distributions beginning at age 59 ½, in cases of financial hardship or if called to active military duty.

The Plan has the ability to make automatic distributions without participant consent for terminated participants who fail to affirmatively elect a distribution and have a vested account balance under \$5,000.

Forfeited Accounts: Forfeited nonvested accounts totaled \$222,476 and \$80,031 as of December 31, 2024 and 2023, respectively. Forfeited balances are first used to pay administrative expenses. Any remaining forfeitures may be used to reduce future Company contributions. During the year ended December 31, 2024, forfeited accounts of \$46,750 were used to pay plan expenses.

Note 2. Summary of Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Refundable: Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed excess contributions to the applicable participants prior to March 15, 2024.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value (NAV).

Common collective trust funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that liquidations will be carried out in an orderly manner.

Note 4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 5. Related-Party Transactions and Party in Interest Transactions

Fidelity Management Trust Company is the non-discretionary trustee as defined by the Plan. Administrative and recordkeeping fees of \$86,436 were paid to Fidelity Investments during the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any Company contributions.

Note 7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
