Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of the Gerry Lane Enterprises 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1 - Description of Plan -

The following description of the Gerry Lane Enterprises 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Description of Plan

The Plan is a defined contribution plan covering all employees of Gerry Lane Enterprises, Inc. and its affiliated companies (collectively referred to as the Company and the Employer) who are age twenty-one or older and have completed at least one year of service. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA). The following affiliated companies related through common ownership have adopted the Plan: Gerry Lane Enterprises, Inc., Gerry Lane Buick-GMC, LLC dba Gery Lane Buick-GMC, Gerry Lane Automotive, LLC, dba Gerry Lane Cadillac, Gerry Lane Chevrolet, LLC, and Gerry Lane CDJR, LLC.

Contributions

Each plan year, participants may contribute pre-tax annual compensation up to the maximum amount allowed by IRS limitations. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all employees who became eligible after January 1, 2016, are automatically enrolled in the Plan unless they affirmably elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until change by participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has a Safe-Harbor match of 100% of employee deferrals that do not exceed 3%, plus 50% of employee deferrals that exceed 3% but do not exceed 5%. The Company may also make discretionary profit-sharing contributions to be determined by the Company. The employer safe harbor contributions totaled \$613,413 for the year ended December 31, 2024. There were no discretionary profit-sharing contributions during 2024.

Participant Accounts

Each participant's account is credited or charged with the participant's contribution and their allocation of the employer’s contribution, the Plan’s investment earnings or losses, and certain plan administration costs not covered by the Company. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also 100% vested in Safe-Harbor contributions made by the Company. Vesting in the Company’s profit sharing contribution, plus earnings, is based on a graduated schedule beginning at 20% vesting after two years of continuous service and becoming fully vested after six years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, retirement or termination, participants are entitled to receive a lump sum payment equal to the value of their vested account balance or periodic installments as stipulated in the plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0-. These accounts can be used to reduce future employer contributions, to pay administrative expenses of the Plan not covered by the Plan sponsor or may be reallocated to participants' accounts. During 2024, forfeited nonvested accounts were used to reduce employer contributions and administrative expenses by \$69.

Note 2 - Summary of Accounting Policies -

Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting. Investments are valued at current fair value as quoted by the custodian of the Plan. All assets of the Plan are participant directed.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, and such differences may be material.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net investment income (loss) includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Risks and Uncertainties

The Plan provides for various investment options in any combination of selected funds and contracts held by the trustee. The funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of the funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees for certain transactions are charged directly to the account of the participant included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 9, 2025, the date which the financial statements were available to be issued.

Note 3 - Plan Termination -

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

Note 4 - Tax Status -

The Company has adopted a prototype plan which received a favorable determination from the Internal Revenue Service. The Plan itself has not separately applied for recognition of tax-exempt status. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 5 - Fair Value Measurements -

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Collective Trusts - Valued at the net asset value (NAV) of units of the collective investment trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is determined to be readily available by management.

Mutual Funds - These funds are valued at quoted market prices in an active market, which represent the net asset values of shares held by the Plan at year end.

Pooled Separate Accounts - The fair values of participation units held in the pooled separate accounts are based on their net asset values as reported by the fund managers as of the financial statement dates and recent transaction prices.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in the changes in net assets available for benefits for the year ended December 31, 2024, are reported as part of net appreciation in fair value of investments.

Note 6 - Guaranteed Investment Contract with Insurance Company -

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$329,897 and \$339,425 as of December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay

the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include:

- (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan),
- (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan,
- (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or
- (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

- (1) an uncured violation of the Plan's investment guidelines,
- (2) a breach of material obligation under the contract,
- (3) a material misrepresentation, or
- (4) a material amendment to the agreement without the consent of the issuer.

Note 7 - Information Prepared and Certified by the Trustee -

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplement schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, qualified institutions as defined by ERISA.

Note 8 - Related Party and Party-In-Interest Transactions -

Certain plan investments including guaranteed interest accounts and pooled separate accounts are managed by an affiliate of Principal Trust Company and Principal Life Insurance Company (collectively “Principal”). Since Principal is the trustee, as defined by the Plan, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net investment income (loss) as they are paid through revenue sharing, rather than a direct payment. The Company pays directly other fees related to the Plan’s operations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 9 - Delinquent Participant Contributions -

For the year ended December 31, 2024, participant deferrals totaling \$362,872, were not timely remitted to the plan in accordance with requirements of the Department of Labor. The contributions were remitted to the Plan upon discovery of the errors.

For the year ended December 31, 2023, participant deferrals totaling \$105,369, were not timely remitted to the plan in accordance with requirements of the Department of Labor. The contributions were remitted to the Plan upon discovery of the errors.
