## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Webb-Stiles Company 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. # WEBB-STILES COMPANY 401(K) PROFIT SHARING PLAN

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Webb-Stiles Company 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan generally covering all eligible employees of Webb-Stiles Company (“Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** To be eligible to participate in the Plan, an employee must have completed one year of service, as defined in the Plan. Employees whose employment is covered by a collective bargaining agreement or who are field workers are not eligible to participate in the Plan. Employees are eligible for participation in the Plan on the first day of the quarter after meeting the service requirement.

**Contributions:** Participants may make voluntary pre-tax and after-tax (Roth) contributions by means of a salary deferral agreement, of up to 100% of their compensation, subject to IRS limitations for the Plan year. The Plan provides for automatic enrollment upon eligibility and, accordingly, employees are treated as having elected to contribute 4% of their earnings as a pre-tax 401(k) contribution, unless an election is made for a different amount or an election is made not to participate. The Plan also permits rollover contributions from other qualified pre-tax retirement plans. Plan participants over the age of 50 are also permitted to make additional pre-tax catch-up contributions to a maximum of \$7,500 in 2024.

The Company may make a discretionary matching contribution equal to a uniform percentage of the employee’s salary deferrals. No discretionary matching contributions were made in 2024 and 2023. The Company may also contribute discretionary non-elective profit sharing contributions to the Plan as determined by the Company’s Board of Directors. In 2024, discretionary non-elective profit sharing contributions by the Company to the Plan totaled \$1,033,654 (10% of eligible compensation), which was remitted to the Plan in 2025. In 2023, discretionary non-elective profit sharing contributions by the Company to the Plan totaled \$479,475 (5% of eligible compensation), which was remitted to the Plan in 2024. Participants must be employed on the last day of the Plan year in order to receive an allocation of the discretionary matching and discretionary non-elective profit sharing contributions.

**Participant accounts:** Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s discretionary matching and discretionary non-elective profit sharing contributions, if any, (b) plan earnings, and (c) revenue sharing and is charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be drawn from the participant’s vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in employer discretionary matching and non-elective profit sharing contributions are based on years of service with the Company, based on the following schedule:

**Notes receivable from participants:** The Plan allows participants to obtain loans from the Plan, which are subject to the following general provisions: participants may borrow up to 50% of the vested interest in their individual pre-tax account up to a maximum of \$50,000, with a minimum of \$1,000, loans must be repaid through payroll deductions over a maximum term of five years unless the purpose of the loan is to purchase the participant’s primary residence, and the loans are secured by the participant’s entire vested account balance. Loans are not available from Roth contributions. Upon termination of employment, loans are immediately due and payable. The interest rate for each loan is based on the bank’s prime lending rate (8.50% and 7.50% at December 31, 2024 and 2023, respectively) on the loan issuance date plus 1%. Interest income is recorded on the accrual basis.

**Payment of benefits:** The Plan permits in-service withdrawals for participants who have attained age 62. In the event of death, disability, termination of employment, or financial hardship, as defined by the Plan, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installments for required minimum distributions only. Account balances of terminated employees totaling less than \$5,000 are distributed as soon as administratively feasible following severance of employment. A hardship distribution may not be taken from a Roth contribution.

A participant’s vested account balance is paid as soon as administratively feasible following termination of employment. In the event of death, the account balance is paid to the participant’s beneficiary.

**Forfeited accounts:** During 2024 and 2023, \$7,725 and \$4,298, respectively, was forfeited from participants’ accounts. Forfeitures are used to reduce the employer discretionary non-elective profit sharing contribution, if any, and pay administrative expenses of the plan with any remaining forfeitures reallocated to remaining participants in the same manner as the Company’s discretionary non-elective profit sharing contributions for the Plan year. During 2024, \$17,937 of forfeitures were used to pay administrative expenses. Forfeitures held in the Plan totaled \$8,190 and \$18,402 at December 31, 2024 and 2023, respectively.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of presentation:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes receivable are written off when deemed uncollectible.

**Investment valuation and income recognition:** Investments are reported at fair value using methodologies described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits paid:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** All third-party administrative expenses are paid by the Plan, unless otherwise paid for by the Company. In 2024, the administrative expenses paid for by the Plan included investment consulting fees and are included in the statement of changes in net assets available for benefits. The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan's administrative expenses. Administrative expenses are directly billed to each participant; therefore, the revenue sharing is returned to plan participants.

**Subsequent events:** In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

### **NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEES**

In accordance with 28 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditors' examination with regard to statements or information prepared and certified by Ascensus, LLC (for the period November 14, 2024 – December 31, 2024) and Newport Trust Company, LLC (for the period January 1, 2024 – November 13, 2024), the trustees. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the trustees:

## NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

1. Mutual funds (registered investment companies): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
2. Investments at net asset value: A common/collective trust composed primarily of fully benefit-responsive investment contracts held in a stable value fund that is valued at the net asset value of units of the collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments relating to this type of investment.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

For 2024 and 2023, there were no transfers between levels 1 and 2 and no transfers in or out of Level 3.

## NOTE 5 – INCOME TAXES

The trust established under the Plan, which holds the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has adopted an Internal Revenue Service pre-approved prototype plan. The prototype plan has received a favorable opinion letter from the IRS, dated March 31, 2014, that it qualifies under IRS Code section 401(a), provided all terms of the plan are followed. The Plan has been amended since adopting the prototype plan. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## NOTE 6 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The reconciling items for contributions receivable is required due to the financial statements being prepared on the accrual basis of accounting and Form 5500 being prepared on the cash basis of accounting. The reconciling item related to allocated insurance contracts results from the contracts being excluded from Plan assets for financial reporting purposes but included for Form 5500.

## NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA; however, each participant would have a nonforfeitable right to his or her total account balance as of the date of termination.

## NOTE 8 – RISK AND UNCERTAINTIES

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## NOTE 9 – PARTY-IN-INTEREST TRANSACTIONS

The Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions.

## **NOTE 10 – LIFE INSURANCE CONTRACTS**

Prior to 2009, the Plan permitted participants to apply a portion of any contributions made to their account toward the purchase of whole life insurance policies which designate the Plan as the owner of the policies; however, the policies were for the sole benefit of the participants or their beneficiaries. Accordingly, for financial reporting purposes the cash surrender value of these allocated policies is not included as a Plan asset, and the investment income earned by the policies is not included in Plan earnings. The cash surrender value of the allocated life insurance contracts is reported as a Plan asset on Form 5500. If participants elect, however, to cancel their policy, the accumulated cash surrender value received is allocated to their other Plan investment account balances in the same manner as contributions. Subsequent to 2009, the Plan does not permit the purchase of additional life insurance policies. In 2024, policies with cash surrender values of \$25,023 were cancelled and the proceeds are included in other contributions in the statement of changes in net assets available for benefits. The cash surrender value of the existing life insurance contracts at December 31, 2024 and 2023 totaled \$238,499 and \$260,422, respectively.
