### ***Opinion on the 2024 Financial Statements***

We have audited the financial statements of Webb Landscape, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Webb Landscape, Inc. Employee Stock Ownership Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion on the 2024 Financial Statements***

## **Note 1 - Description of Plan**

The following brief description of the Webb Landscape, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

Webb Landscape, Inc. (the Company / Employer) established the Plan effective January 1, 2001. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Life Insurance Company is the Plan's prior custodian (Custodian). Fiduciary Services LLC is the current Trustee. Blue Ridge & Associates is the Plan's current recordkeeper. The Plan is administered by the Board of Trustees of the ESOP and the Trustee.

The Plan purchased the Company's common stock by financing the purchase directly with the seller, Douglas W. Webb, President of Webb Landscape, Inc., and holds the stock in a trust established under the Plan. The borrowing was repaid over a period of ten years by fully deductible Company contributions to the trust fund and was repaid in full in 2011. As the Plan made each payment of principal, an appropriate percent of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the Code. The common stock was fully allocated to eligible employee's accounts as of 2011 and no unallocated shares remain.

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed one year of service and are 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service and is employed as of the last day of the Plan year.

### **Entry Date**

Employees may enter the Plan semi-annually on the first day in January or July coinciding or following the date they satisfy the Plan's eligibility requirements.

### **Contributions**

The Plan receives contributions from the Company as determined by the Company's Board of Trustees. Employer contributions, when made, are made in cash or stock of Webb Landscape, Inc. Contributions are subject to Internal Revenue Service limitations. Contributions to the Plan are made by the Company at the discretion of the Company. The contributions are allocated according to the pro rata share of each participant's compensation to total eligible compensation. Participants must have completed 1,000 hours of service and be actively employed at the end of the year, unless terminated due to retirement, death or disability, to receive an allocation of the contribution. In 2024, the Company made a discretionary contribution of \$618,132.

### **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee as defined in the Plan document prior to the time that such rights are to be exercised. Participant voting rights are limited to the following matters: corporate mergers, recapitalization, dissolution of the Company, sale of substantially all of the Company's assets, or other matters prescribed in applicable regulations. The Trustees are required to vote any allocated shares and other matters not specifically identified on behalf of the collective best interest of Plan participants and beneficiaries.

### **Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. The put option shall permit the participant (or beneficiary) to sell such employer stock to employer at any time during two option periods at the then fair market value. The first put option period shall be for at least sixty (60) days beginning on the date of distribution. The second put option period shall be for at least sixty (60) days beginning after the new determination of fair market value (and notice to the participant thereof) in the following Plan year. Employer may allow the Trust to purchase shares of employer stock tendered to Employer under a put option. The payment for any employer stock sold under a put option shall be made within thirty (30) days if the shares are distributed as part of an installment distribution. If the shares are distributed in a lump sum distribution, payment shall commence within thirty (30) days and may be made in a lump sum or in substantially equal annual installments over a period not exceeding five (5) years, with adequate security provided and interest payable at a reasonable rate on any unpaid installment balance (as determined by the Board of Trustees of the ESOP).

### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting**

Vesting in the Company's discretionary contributions plus actual earnings thereon is based on years of continuous service, according to the following schedule:

1	0%
2	20%
3	40%
4	60%
5	100%

Participants are 100% vested in their account balances upon retirement, death, or disability.

**Forfeitures**

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. Forfeited accounts are used to reduce employer contributions or allocated to eligible participants. During the year ended December 31, 2024, forfeited non-vested accounts totaling \$46,800 were allocated to eligible participants. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation for the Plan year.

**Payments of Benefits**

Distributions from the Plan will be made when a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representative), or otherwise terminates employment with the Company. Distributions are made in cash, or if a participant elects, in the form of Company common shares plus cash for any fractional share.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to the trading limitations.

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company's stock into other investments, which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Elections to diversify must be made no later than 90 days after the Plan year in which you have the right to diversify.

### **Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participants or the beneficiary at the time prescribed by the Plan terms and the code. In the event of Plan termination, participants would become 100% vested in their accounts.

## **Note 2 - Significant Accounting Policies and Use of Estimates**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates. Significant estimates include the valuation of the Company's common stock held by the Plan.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 4 for discussion of fair value measurements.

### **Payment of Benefits**

Benefit payments to participants are recorded when paid. During 2024, the Company repurchased from participants 3,152 shares at prices determined from the independent appraisal.

### Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

### Note 3 - Investments

The Plan's investments as of December 31, 2024 and 2023, are in common stock of Webb Landscape, Inc. held in a bank-administered trust fund and in pooled separate accounts.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2- Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stock: The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and estimated fair value of company assets and liabilities, including discount for lack of marketability.

The valuation process involves Plan management's selection of an independent appraiser under contract for a term of four quarters with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with the ESOP Trustee, discuss and review in detail and approves. The result of this process is documented in the minutes of the Plan.

### Note 5 - Certified Information

Other than the shares of Company common stock and the related investment income, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (the prior custodian of the Plan). Investments of \$13,155,065, as of December 31, 2023, and all financial information as of and for the year ended December 31, 2024 were not certified by the custodian.

**Note 6 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated January 21, 2016, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Related Party and Party-in-Interest Transactions**

The Plan invests in Company common stock and is guaranteed by the Company. These are related party and party-in-interest transactions. Corporate officers of the Company are Trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Other Plan investments consist of pooled separate accounts for the year ended December 31, 2023 were managed by Principal Life Insurance Company, the prior custodian, as defined by the Plan. No fees were paid to the Trustee related to Plan operations and investment activity during the year ended December 31, 2024.

**Note 8 - Risks and Uncertainties**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 - Right of First Refusal**

Company stock that has been distributed to a participant and not immediately repurchased by the Company or Trust, may be subject to a right of first refusal if so determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the Trust at fair market value as determined by an independent appraiser appointed by the Board of Directors.
