**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Class Produce Group, LLC Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information. In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan description:

The following description of the Class Produce Group, LLC Profit Sharing Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan originally effective April 1, 1979, and restated on January 1, 2021, covering all employees age eighteen or older with no service requirement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor is responsible for oversight of the Plan, for determining the appropriateness of the Plan's investment offerings, and for monitoring investment performance.

Administration:

The Plan is sponsored by Class Produce Group, LLC (the Company). The Plan is administered by T. Rowe Price Trust Company. At December 31, 2024 there was one trustee.

Contributions:

The Plan is a qualified profit-based contribution plan established under the provisions of Internal Revenue Code Section 401(k) covering substantially all eligible employees electing to participate. The Company makes periodic discretionary contributions covering substantially all eligible employees electing to participate. Participants may also make rollover contributions. The employer contributions are subject to ERISA limitations.

The employees may contribute up to \$23,000 (\$30,500 for participants age 50 and over) to the Plan annually. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company provides matching contributions equal to 100 percent first five percent, and 50 percent of the next five percent of the employee contribution. A discretionary contribution, to be determined by the Company, may also be made. For 2024, the Sponsor made matching contributions of \$757,808 and discretionary contributions of \$370,205. The employee and employer contributions are subject to ERISA limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts:

Each participant's account is credited with the participant's contribution, the Company's contribution (see "Contributions") and an allocation of net investment earnings. Allocations are based on account balance as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Each participant's account is divided into sub-accounts known as a voluntary contribution account, an employer match account, a profit sharing contribution account, and where applicable, a rollover contribution account. The Plan permits each participant to direct their investment to any of the 31 funds held by T. Rowe Price Trust Company.

Vesting:

Participants are immediately vested in their voluntary contributions, matching contributions, and rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of service.

1. Plan description (continued):

Notes receivable from participants:

Plan participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000, reduced by any outstanding loan balance, or fifty percent (50%) of their vested balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25 to 9.50 percent, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably each pay day through payroll deductions.

Payment of benefits:

On termination of service, a participant whose vested account balance does not exceed \$5,000 will receive a lump sum payment. For balances exceeding \$5,000, a participant may elect any of the following methods: lump sum, part lump sum and part installments, or installment payments.

Forfeited accounts:

If not used to pay Plan expenses, after the amount of forfeiture is determined, the forfeitures are reallocated among those participants eligible to receive an employer discretionary contribution for the Plan year. Total forfeitures at December 31, 2024 and 2023 were \$4,346 and \$2,166, respectively. Also, in 2024, sponsor contributions were reduced by \$16,064 from forfeited nonvested accounts.

2. Summary of significant accounting policies:

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Notes receivable from participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan is in default, the participant loan balance is reduced and a deemed distribution is recorded.

2. Summary of significant accounting policies (continued):

Investment valuation and income recognition:

Investments are reported at fair value except for the T Rowe Price Stable Value Common Trust Fund, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation /depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid.

Operating expenses:

All expenses of maintaining the Plan including the audit fees are paid by the Plan.

Revenue sharing:

T Rowe Price provides certain administrative services to the Plan. T Rowe Price receives revenue from mutual fund service providers for services T Rowe Price provides to the funds. This revenue is used to offset certain amounts owed to T Rowe Price for its administrative services to the Plan. T Rowe Price remits the excess to the Plan. \$55,762 of this revenue was received during 2024.

3. Contract administrator's certification:

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, investment income or loss for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplementary information, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T Rowe Price Trust Company (T Rowe Price). The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

4. Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Tax status:

The T Rowe Price prototype plan document, which the plan has adopted via a non-standardized adoption agreement, obtained its latest determination letter on August 19, 2020, in which the IRS stated that the prototype plan and related trust, as then designed, was acceptable in accordance with applicable sections of the Internal Revenue Code (the IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, no uncertain positions are taken or expected to be taken that would require recognition of a liability (or asset) of disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

6. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

7. Fair Value Measurements:

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: (1) Quoted prices for similar assets or liabilities in active markets; (2) Quoted prices for identical or similar assets or liabilities in inactive markets; (3) Inputs other than quoted prices that are observable for the asset or liability; and (4) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Common/collective trusts: The fair values of common/collective trusts are obtained from the insurance company and are based on quoted prices and account balances. These investments are classified as level 2.

Registered investment companies: The fair values of mutual fund investments are obtained from the fund manager and are based on quoted prices. These investments are classified as level 2.

8. T Rowe Price Stable Value Common Trust Fund:

In 2015, the plan entered into a benefit-responsive guaranteed investment contract with T Rowe Price Trust Company (T Rowe Price). T Rowe Price maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value. Contract value, as reported to the plan by T Rowe Price, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. T Rowe Price has represented that fair value and contract value are equal.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$6,241,282 and \$6,394,063 respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

8. T Rowe Price Stable Value Common Trust Fund (continued):

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan sponsored events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

9. Related party transactions:

Certain Plan investments are shares of mutual funds managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$71,452 for the year ended December 31, 2024.

10. Subsequent events:

The Plan has evaluated subsequent events through October 9, 2025, the date the report is available for issuance. No events requiring recognition or disclosure in the financial statements were identified.

11. Other income:

Other income consists of \$55,762 of refunded fees and \$8,137 of income adjustments.
