## Independent Auditor's Report

To the Retirement Plans Committee and Participants of the  
Snap-on Incorporated Union Retiree Health Benefit Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Snap-on Incorporated Union Retiree Health Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Snap-on Incorporated Union Retiree Health Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

As of and for the years then ended December 31, 2024 and 2023

---

### 1. Description of the Plan

**General** — The following brief description of the Snap-on Incorporated Union Retiree Health Benefit Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

The Plan is a partially-insured health and welfare plan that provides health benefits to union retirees. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan is sponsored by Snap-on Incorporated (the “Company” or “Sponsor”). U.S. Bank, N.A. (“U.S. Bank” or the “Trustee”) is the Plan’s trustee and holds the investment assets and executes investment transactions.

Plan benefits may either be paid directly by the Company or by the Snap-on Incorporated Amended and Restated Benefit Trust for Collectively Bargained Employees (the “Trust” or “VEBA Trust”). In 2024 and 2023, the majority of benefit payments were paid directly by the Company. All amounts are included in the financial statements.

**Benefits** — The Plan provides health benefits (medical, hospital, surgical, major medical), Retiree Reimbursement Accounts (“RRA”), and reimbursement of Medicare Part B premiums. RRAs are Company funded and are used to reimburse participants for qualified post-retirement health care costs. If the RRA account is exhausted, the participant can continue health care coverage on an employee-pay-all basis. Any existing RRA account is forfeited upon the death of the participant. During the years ended December 31, 2024 and 2023, forfeited amounts totaled \$264,079 and \$140,972, respectively.

**Eligibility** — Only employees who were or are subject to a collective bargaining agreement are eligible to participate in the Plan. Certain active and retired employees hired before dates ranging from December 31, 1997 to January 1, 2000, are eligible to receive reimbursement for retiree health care costs for themselves and their spouses, and reimbursement of Medicare Part B premiums. Bargained employees hired after those dates are not eligible to receive retiree health care cost reimbursement or reimbursement of Medicare Part B premiums.

Effective January 1, 2008, bargained employees are eligible to enroll in retiree medical coverage and pay 100% of current applicable premiums if they are 50 years of age with five years of continuous service, or are age 65 at retirement.

Only employees who meet specific age and service requirements and who were employed before the dates outlined in Appendix B of the Snap-on Incorporated RRA for Active Employees Summary Plan Description may become eligible to participate in the Snap-on Incorporated RRA for Retired Employees Plan.

**Participant Accounts** — An individual account is maintained for each participant who is eligible to receive RRA benefits. The account is charged for benefits paid and credited with an annual Company benefit that is capped and allocated an interest credit equal to 6% of the account balance.

**Contributions** — The Company funds the obligation for the RRA accounts, certain retiree medical costs and Medicare Part B premiums. Participants who elect other retiree medical coverage make contributions to the plan on an employee-pay-all basis.

**Administrative Expenses** — The Trust pays trustee, investment and audit fees. The Company pays other allocated and direct expenses of the Plan. The Company provides accounting and other administrative services to the Plan at no charge.

## 2. Summary of Significant Accounting Policies

**Basis of Accounting** — The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates** — The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Management considers the postretirement benefit obligation and fair value of the hedge fund to be significant estimates. Actual results could differ from these estimates and are subject to change in the near term.

**Investment Valuation and Income Recognition** — The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought, sold, and held during the year.

The plan invests in a series of alternative investments that do not have readily available market data and the value of these investments is determined based on the best information available at the time of the Plan's trustee's investment certification. Management reviews the market values subsequent to year-end largely relying on the latest available audited financial statements or most recently published fund statement, taking into account contributions made or distributions received by the Plan following statement distribution or valuation. These estimates are subject to change in the near term based on the alternative investments' final reported figures which is often received well after the investment certification. The differences between the certified balances and the final audited investment balances were immaterial in all years presented.

**Fair Value Measurement** — The fair value measurements hierarchy prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority (“Level 1”) to unadjusted quoted prices in active markets for identical assets and liabilities and the lowest priority (“Level 3”) to unobservable inputs. Fair value measurements primarily based on observable market information are given a “Level 2” priority.

**Payment of Benefits** — Premiums paid by either the Company or the VEBA Trust are recorded as benefit payments in the accompanying Statements of Changes in Net Assets Available for Benefits. Benefit payments are recorded when paid by the claims administrator.

**Subsequent Events** — Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

### **3. Fair Value Measurement**

The mutual fund is valued at the quoted per share or unit market price for which an official close or last trade pricing on an active exchange is available and is categorized at Level 1 in the fair value hierarchy.

The common/collective trust fund is valued at the net asset value (NAV) per share or unit multiplied by the number of shares or units held as of the measurement date, as reported by the fund manager. The share or unit price is quoted on a private market and is based on the underlying investments, which are primarily based on observable inputs; such investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The investment objective of the common/collective trust fund is to match the performance of a particular equity index. The fund invests primarily in U.S. and non-U.S. equity securities with the objective of approximating as closely as practicable the capitalization weighted total return of the markets in certain countries for publicly traded equity securities. The fund held by the Plan offers daily liquidity with a two-day notification period.

The hedge fund is stated at the NAV per share or unit (based on the estimated fair market value of the underlying investments) multiplied by the number of shares or units held as of the measurement date, as reported by the fund managers. This investment is measured at fair value using the NAV per share (or its equivalent) practical expedient and has not been classified in the fair value hierarchy. The strategy of the hedge fund(s) is to pursue its investment objective by allocating capital among various portfolio managers through investments in collective investment vehicles and individually managed accounts. The collective investment vehicles may engage in the trading of equity and debt securities of U.S. and non-U.S. corporations, U.S. and non-U.S. government securities, futures contracts, options, options on futures, partnership interests, money market instruments and other derivative instruments. The Plan can redeem part or all of its investment in the hedge fund by providing written notice of the withdrawal request at least 100 days in advance of the last day of the calendar year; the Plan can also redeem up to 25% of its investment in the hedge fund by providing written notice of the withdrawal request at least 100 days in advance of a quarterly redemption date (March 31, June 30, and September 30). There are no unfunded commitments.

The columns labeled “Investments Measured at NAV” in the following tables are measured at fair value using the NAV per share (or its equivalent) practical expedient and have not been categorized in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit a reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Contributions to provide benefits under the Plan are made by the Company and Plan participants; Company contributions may be reimbursed by the Trust. The Company was reimbursed by the Trust for eligible contributions made in the 2024 and 2023 plan years totaling \$731,215 and \$765,526, respectively.

## 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan, in certain circumstances, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, the net assets of the Plan will be allocated for payment of plan benefits to the participants in an order of priority determined in accordance with ERISA, applicable regulations thereunder and the plan document. Upon termination, no part of the VEBA Trust may inure to the benefit of the Company or be used for purposes other than for the payment of designated benefits.

Whether all participants receive their benefits should the Plan be terminated at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits, the priority of those benefits to be paid, and the financial condition of the Company at that time. Some benefits may be fully or partially provided for by the then existing assets while other benefits may not be provided for at all.

## 6. Benefit Obligations

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents; and (2) active employees and their beneficiaries after retirement from service with the Sponsor. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of expected postretirement obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

There were no significant changes in the assumptions used to estimate the actuarial present value of benefit obligations. An increase in the assumed medical trend rate of 1% in each year would increase the accumulated postretirement benefit obligation by approximately \$164,000 as of December 31, 2024.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of benefit obligations.

## **7. Federal Income Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated April 7, 2010, that the Trust was designed in accordance with the applicable regulations of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter; however, the Company and Management believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the Plan and related Trust continue to be tax-exempt.

The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain income tax positions. Therefore, no provision for income taxes has been included in the Plan’s financial statements. The Plan is subject to routine audits by taxing jurisdictions and there are currently no audits in progress.

## **8. Information Certified by the Trustee**

Certain information related to the Plan’s investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years ended December 31, 2024 and 2023, was obtained or derived from information certified as complete and accurate by the trustee of the Plan.

## **9. Risks and Uncertainties**

Investments are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates and employee demographics. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these assumptions will occur in the near term and that the effect of such changes could be material to the financial statements.

## **10. Related-Party or Party in Interest Transactions**

Reimbursements of qualified payments were made from the Trust to the Sponsor, and the trustee of the Trust executes investment transactions on behalf of the Sponsor. These transactions are related party and party in interest transactions under ERISA.
