To the Pension Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Preferred Primary Care Physicians, Inc. 401(k) Profit-Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTE 1: DESCRIPTION OF PLAN

The following description of the Preferred Primary Care Physicians, Inc. 401(k) Profit-Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan established by Preferred Primary Care Physicians, Inc. (the “Company”) for the benefit of eligible employees of the Company. The Plan excludes union employees, nonresident aliens, and employees who are classified as professional interpreting physicians. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Company’s board of directors is responsible for the oversight of the Plan. The pension committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Company’s board of directors.

Eligibility – Any employee is eligible to participate in the salary deferral and match components of the Plan on the first day of the month coinciding with or next following the employee’s reaching age 18 and completing 90 days of employment. Participants are generally eligible for the profit sharing and non-elective contributions if they meet the eligibility requirements and are employed on the last day of the plan year. In order for the Plan to meet non-elective testing requirements, the Plan waives the number of hours worked and last day of the year employment criteria for non-highly compensated employees.

Plan Administration – Prior to March 31, 2023, the Plan’s custodian was Capital Bank and Trust Company, and its affiliate, American Funds Trust Company, provided certain accounting and administrative services with respect to participants’ balances. From March 30, 2023, the Plan’s custodian/trustee is Fidelity Management Trust Company, and its affiliate, Fidelity Investments, provides certain accounting and administrative services, with respect to participants’ balances.

Contributions – An eligible employee may contribute an amount up to 100% of his or her compensation received during the contribution period, not to exceed maximum allowable deferral limits established by the Internal Revenue Service (IRS) in any given year. All elective deferrals made for a plan year must satisfy the ADP test; however, the Plan’s safe harbor allocation satisfies the ADP testing requirements. Elective deferrals that do not satisfy the ADP test will be deemed excess contributions and will be returned. An eligible participant may make Roth contributions. Participants may also contribute amounts from other qualified plans as rollover contributions to the Plan.

The Plan requires employer matching contributions equal to 50% of the elective deferrals not in excess of 7% of employee compensation. Matching contributions made for a plan year must satisfy the ACP test for that plan year. The Company may also make a discretionary contribution to the Plan.

For the years ended December 31, 2024 and 2023, the Company made matching contributions of \$917,881 and \$705,436, respectively, and discretionary contributions of \$967,841 and \$912,143, respectively.

Safe Harbor Contributions – The Company may elect by written resolution and issuance of a safe harbor notice to administer the Plan pursuant to the safe harbor provisions of Internal Revenue Code (IRC) Section 401(k)(12) or IRC Section 401(m)(11). For the years ended December 31, 2024 and 2023, the safe harbor contributions amounted to \$1,095,047 and \$963,644, respectively.

Participant Accounts – The Plan maintains individual accounts for each of the Plan’s participants to reflect a participant’s contributions and related employer contributions, as well as a participant’s share of the Plan’s income and any related administrative expenses.

Vesting – Participants’ vested interest in all elective deferrals and non-elective contributions and the earnings thereon will be 100% at all times. Vesting in the safe harbor contribution is also 100% at all times. Vesting in the employer’s matching and discretionary contributions is based on years of service.

A participant shall have a vested interest, based on years of continuous service, in the percentage of his or her account balance derived from the Company’s matching and discretionary contributions and actual earnings thereon as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Payment of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant’s account balance does not exceed \$5,000, the plan administrator will authorize the benefit payment without the participant’s consent. The Company will authorize the cash payment of balances less than \$1,000, and for balances between \$1,000 to \$7,000, the Company will authorize that such benefit payment be rolled into an individual retirement account in the participant’s name.

The Plan records benefits when paid.

Investment Options – Participants may direct the investment of their accounts. Participants can choose from any investment alternatives designated by the trustees. The trustees maintain the right to limit a participant’s choice of investment vehicles and firms. All earnings and losses on a participant’s directed investments will be credited to his or her account. A participant may switch between investment alternatives as often as permitted under the chosen investment vehicles.

Participants’ Notes Receivable – Participants may borrow from the Plan. The minimum amount that can be borrowed is \$1,000. The maximum amount is equal to the lesser of \$50,000 or 50% of a participant’s vested account balance. If a loan is approved, the participant’s account must be pledged as security. The loans bear interest at a rate established at the inception of the loan of the prime lending rate of a commercial U.S. bank plus 1%. Interest rates on loans outstanding as of December 31, 2024 and 2023, ranged from 4.25% - 9.5%. The term of repayment may not be greater than 5 years unless the loan qualifies as a residential mortgage loan. The loan must provide for repayment on a level amortization schedule by regular payroll deduction repayments not less than quarterly. The interest paid will be credited directly to the participant’s account. The Plan carries participants’ notes receivable at their outstanding balances, which approximate fair value.

Forfeited Accounts – Forfeitures may be used to pay administrative expenses of the Plan. Any forfeitures not used for this purpose will be used to reduce any matching contribution, the non-elective contribution, or any safe harbor contribution for the current plan year or subsequent plan years. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,127 and \$1,168 respectively. During 2024 and 2023, the Company used \$40,412 and \$79,783, respectively, of forfeited nonvested accounts to fund employer contributions as permitted by the Plan.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting and Income Recognition – The Plan prepares its financial statements using the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and liabilities of the Plan and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to the Plan’s assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investments – The Plan records its investments at fair value. The Plan carries mutual funds and exchange traded funds at daily closing prices as reported by the funds. The Plan carries money market mutual funds at cost, which approximates fair value.

The Plan records purchases and sales of securities on a trade-date basis, interest income on the accrual basis, and dividends on the ex-dividend date. The Plan presents the net appreciation (depreciation) in the value of its investments, which consists of the realized gains and losses and the unrealized appreciation (depreciation) of those investments in the statement of changes in assets available for benefits.

Administrative Expenses – The Company pays certain expenses of maintaining the Plan, and the Plan excludes such expenses from the financial statements. Administrative expenses include fees and charges to participants' accounts related to the administration of notes receivable and benefit payments. Administrative expenses include certain investment related expenses.

Subsequent Events – The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements became available to be issued, and determined that no adjustments or additional disclosures are necessary.

NOTE 3: INVESTMENTS

The Plan's methods to measure fair value of its investments may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. The Plan's management used Level 1 inputs to measure fair values of its investments in mutual and exchange traded funds because of the nature of those investments. For the Plan's investment in a collective trust fund, management used the net asset value per share practical expedient for the fund.

Prior to March 30, 2023, the Plan maintained self-directed brokerage accounts for certain participants. The investments in such accounts consisted of mutual funds, money market mutual funds, and cash. The Plan's management used Level 1 inputs to measure the fair values of those investments. On March 30, 2023, the Plan distributed those accounts to the participants. After that date, the Plan did not maintain any self-directed brokerage accounts.

NOTE 4: TAX STATUS

The Plan had previously received a favorable determination letter from the IRS. The Plan has been

amended since receiving the determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan's management evaluates tax positions taken by the Plan and recognizes any tax asset or liability if management believes the positions to be uncertain and more likely than not would not be sustained upon examination by the IRS. No provision for income taxes has been included in the Plan's financial statements.

The IRS may examine the Plan's annual informational returns for each of the years in the four-year period ended December 31, 2024. Should the Plan be subject to any penalties or interest assessed by the IRS, the Plan may account for such expenses as an administrative expense or may seek reimbursement from the Company.

NOTE 5: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in any portion of their accounts that are not so vested.

NOTE 6: RISKS AND UNCERTAINTIES

The Plan invests principally in various mutual and exchange-traded funds, including money market funds. Mutual and exchange traded funds are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain mutual and exchange traded funds, it is reasonably possible that changes in the values of mutual and exchange traded funds will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7: RELATED PARTY TRANSACTIONS

As indicated in note 1, Capital Bank and Trust Company was the Plan's custodian, and its affiliate, American Funds Trust Company, managed mutual funds held by the Plan through March 30, 2023. From March 31, 2023, onward, Fidelity Management Trust Company is the Plan's trustee, and its affiliate, Fidelity Investments, manages mutual funds held by the Plan. Accordingly, transactions in investments managed by the affiliates qualify as party-in-interest transactions.

NOTE 8: UNAUDITED INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

The Plan's management prepared the 2024 and 2023 statements of assets available for benefits, the investment activities included on the 2024 and 2023 statements of changes in assets available for

benefits, the accompanying notes to financial statements, and the supplemental schedule of assets held for investment purposes in part or entirely from information certified by the trustee/custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The trustee/custodians certified total investments and participants' notes receivable of \$77,212,086 and \$74,528,718 on December 31, 2024 and 2023, respectively, and related investment income of \$10,579,759 and \$10,852,032 for the years ended December 31, 2024 and 2023, respectively.
