Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Auria.Space, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of the Auria.Space, LLC 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General — The Plan is a defined contribution plan covering eligible employees of Auria.Space, LLC, employees of Ascension Engineering Group, LLC effective April 1, 2023, and employees of Orbit Logic Incorporated and La Jolla Logic effective January 1, 2024 (collectively, the Company). Employees who are not collective bargaining employees, non-resident aliens, leased employees or residents of Puerto Rico are eligible to participate in the Plan. Employees may contribute and receive safe harbor employer matching contributions on the first day of the following month after their initial employment date. Employees must complete one year of service, be employed on the last day of the year and have 1,000 hours of service during the year to receive Company non-elective contributions. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective August 1, 2024, the Plan changed its name from Boecore, LLC 401(k) Profit Sharing Plan and Trust to Auria.Space, LLC 401(k) Profit Sharing Plan.

Plan Mergers — On April 1, 2023, the Ascension Engineering Group, LLC 401(k) Plan (the AEG Plan) was merged into the Plan. Assets of \$2,671,641 were transferred into the Plan from the AEG Plan as a result of the merger.

On January 1, 2024, the Orbit Logic Incorporated 401(k) Plan (the Orbit Logic Plan) was merged into the plan. Assets of \$11,451,758 were transferred into the Plan from the Orbit Logic Plan as a result of the merger.

On January 1, 2024, the La Jolla Logic 401(k) Plan (the La Jolla Plan) was merged into the Plan. Assets of \$3,053,135 were transferred into the Plan from the La Jolla Plan as a result of the merger.

Contributions — A participant may elect to have a portion of their compensation withheld by the Company and contributed to the Plan on their behalf as an elective contribution in lieu of receiving such amount as compensation. Such contributions may not exceed the limits established in the Internal Revenue Code (IRC).

Effective April 1, 2023, the Company makes safe harbor contributions matching 100% of employee contributions up to the first 4% of employee contributions. Prior to April 1, 2023, the Company made safe harbor contributions matching 100% of the first 3% and 50% of the next 2% of employees' contributions.

The Company may also make discretionary non-elective contributions to the Plan.

Participant Accounts — Each participant shall have one account and such account will be credited with the participant's contributions, an allocation of the Company's contributions, and an allocation of the Plan's earnings and losses. The Plan's earnings or losses, excluding that related to participants' loans, are allocated to the participants' accounts based upon the proportion that each participant's account bears to the total participants' account balances related to that fund. Earnings resulting from loans to participants are credited to the respective participants' accounts. Participants must invest contributions among investment options as provided for by the Plan.

Notes Receivable From Participants — Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 2% above the Wall Street Journal prime rate. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits — Upon separation of service, the Plan will distribute vested account balances not exceeding \$5,000 in a lump-sum as soon as administratively practicable. Upon separation of service, a participant with a vested account balance greater than \$5,000 may elect to receive a lump-sum payment or maintain the vested balance in the Plan. A participant may also elect to receive an account distribution if the participant has attained age 59½ or incurred a hardship in accordance with the Plan provisions.

Vesting — Participants are 100% vested in the amounts they contribute, and the safe harbor contributions made by the Company. Effective April 1, 2023, participants vest in discretionary Company contributions on a vesting schedule over a five-year period. Prior to April 1, 2023, participants vested in discretionary Company contributions on a vesting schedule over a six-year period. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Forfeitures — Forfeitures are applied to reduce employer contributions. Forfeitures of \$13,699 and \$0 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, unused forfeitures were \$6,583 and \$13,956, respectively.

Administrative Expenses — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are allocated to participants' accounts based on their proportion of holdings in each investment option.

Plan Termination — Although they have not expressed an intention to do so, the Company has the right to terminate the Plan at any time. In the event of Plan termination, funds in the participant accounts become 100% vested.

Tax Status — The Plan is a prototype plan of Pentegra Services, Inc. (Pentegra). Pentegra obtained its latest prototype determination letter dated June 30, 2020, stating that the prototype plan is qualified under Section 401 of the IRC.

The Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The plan administrator has concluded that as of December 31, 2024, the Plan has no material uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared on the accrual basis of accounting.

Valuation of Investments and Income Recognition — Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the asset custodian. See Note 3 for information on fair value measurements. Fully benefit-responsive investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the EI Fixed Account - Series Class VI represents a fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments — Benefits are recorded when paid.

Use of Estimates — Preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events — The Plan has evaluated subsequent events for recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available for issuance.

3. INVESTMENTS AND FAIR VALUE MEASUREMENTS

EI Fixed Account - Series Class VI - As described in Note 2, since the EI Fixed Account - Series Class VI is fully benefit-responsive, contract value is the relevant measurement attribute for this investment contract. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest earned on the EI Fixed Account - Series Class VI is compounded daily to the effective annual interest rate.

The interest rate to be credited is determined quarterly. Amounts may be transferred from the participant's account balance in the EI Fixed Account - Series Class VI at any time. Termination of the agreement or full Plan withdrawal from this account could restrict the liquidation of account balances. Management believes this is unlikely to occur.

Fair Value Measurements — Generally accepted accounting principles require the Plan to use a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Prices determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Prices determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered Investment Companies – Valued at the quoted prices of the shares held by the Plan at year-end. The shares are actively traded.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. PARTY-IN-INTEREST TRANSACTIONS

Plan investments include the EI Fixed Account - Series Class VI of Empower Annuity Insurance Company of America. This is an investment vehicle of the custodian of the investment, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

7. NON-EXEMPT PROHIBITED TRANSACTIONS – DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit employee contributions to the plan as soon as they can be reasonably segregated from the employer's general assets. During 2024 and 2023, contributions totaling \$616 and \$12,934, respectively, were not timely remitted. Lost earnings on these contributions were remitted in 2025.

8. SUBSEQUENT EVENTS

Subsequent to year-end, the Plan was amended to add automatic deferral provisions. Effective January 1, 2025, eligible employees will be automatically enrolled in the Plan at 2% of eligible compensation.
