INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Osher Marin JCC 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Osher Marin JCC 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Osher Marin JCC 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Osher Marin JCC 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Osher Marin JCC 403(b) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of the Osher Marin JCC 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Bernard Osher Marin Jewish Community Center (the "Center" or "Employer") pursuant to Section 403(b) and related provisions of the Internal Revenue Code (IRC), was adopted on November 9, 2007, and became effective January 1, 2008.

The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, or termination of employment. The Plan covers all eligible employees of the Center who meet certain eligibility requirements. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, related to participant loans and distributions. The Organization has until December 31, 2025, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Center is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Center contracted with Newport Trust Company, LLC and one of its affiliates, (collectively "Newport" or "Predecessor Trustee") to provide trustee and recordkeeping services. On April 8, 2022, Newport merged with Ascensus LLC and Ascensus Trust Company, and effective April 17, 2024, the assets held by Newport were transferred to Ascensus Trust Company ("the Trustee"). Upon merger, Newport delegated responsibility for servicing the Plan to Ascensus LLC and engaged the Trustee to serve as a sub-custodian of the Plan. The Predecessor Trustee certified the investments and investment activity for the period prior to the transfer, January 1, 2024, through April 17, 2024, and as of and for the year ended December 31, 2023. Ascensus LLC, as an for the Trustee certified the investments and investment activity as of December 31, 2024, and for the period from April 18, 2024, through December 31, 2024. Newport and the Trustee are hereafter collectively referred to as the "Trustees".

Eligibility

All employees of the Center, excluding employees who normally work less than 20 hours per week and nonresident aliens are eligible to participate in the salary deferral contributions on their date of hire. Eligible participants become eligible to receive Employer matching contributions after they complete one year of service and have completed at least 1,000 hours of service during the year, as defined in the plan documents. Eligible union employees become eligible to receive Employer non-elective contributions after they complete one year of service and have completed at least 1,000 hours of service during the year, as defined in the plan documents. Non-union employees are not eligible to receive an allocation of Employer non-elective contributions.

Contributions

Participants may elect to contribute through payroll deductions amounts up to 100% of their annual compensation, as defined by the Plan, on a tax-deferred basis, up to a maximum amount allowed by the IRC. The maximum allowed deferral amount was \$23,000 for 2024. Participants age 50 or over may also contribute an additional \$7,500 in catch-up contributions to the Plan for both the years 2024 and 2023.

Participants may also elect to rollover contributions from other qualified employer-sponsored retirement plans and individual retirement accounts into the Plan.

The Center can make discretionary Employer matching contributions based on a rate established by the Center not to exceed 3% of each participant's compensation. In addition, the Center can make a discretionary, Employer non-elective contribution based on a percentage of eligible compensation using a pre-determined formula that takes into consideration the years of service and age for union employees eligible as of December 31, 2007. Employer discretionary matching contributions totaled \$63,691 and Employer discretionary nonelective contributions totaled \$73,134, for a total of \$136,825, net of forfeitures, for the year ended December 31, 2024.

Contributions (continued)

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions (including rollovers from participants' previous plan), and allocations of Employer contributions, if any, and investment earnings, and charged with any withdrawals or distributions requested by the Plan participant, investment losses and an allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined in the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, and rollovers, plus actual earnings or losses thereon.

Discretionary Employer matching and discretionary Employer non-elective contributions, plus earnings thereon, vest according to the following schedule:

For vesting purposes, the Plan credits up to three years of service for prior service performed under certain qualified organizations, as defined. If the participant incurs a severance from employment as a result of death or is employed on or after attainment of the normal retirement age of 65, the participant will become fully vested.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is used to reduce discretionary Employer matching or non-elective contributions to the Plan or can be used to pay Plan administrative expenses not paid by the Center. As of December 31, 2024 and 2023, the forfeitures account had a balance of \$2,534 and \$20,523, respectively. During 2024, \$0 were used to offset recordkeeping fees and \$23,425 were used to reduce Employer contributions.

Payment of benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum distribution or installment payments under various options equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may leave the account in the Plan or may elect to receive the value of vested interest in his or her account as a lump sum distribution. In-service withdrawals from a participant's account are permitted to participants who are 59 ½ or older. Upon termination of employment, if a participant's account balance is equal to or less than \$1,000 and the participant does not elect a distribution, the balance may be automatically distributed in a lump-sum cash payment without the participant's consent. If a participant's account balance is greater than \$1,000 and less than or equal to \$5,000 upon termination, the balance may be automatically distributed into an Individual Retirement Account as designated by the Plan administrator. If the account balance is over \$5,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents. Depending upon the event, the withdrawal may be subject to early withdrawal penalties imposed by the IRC and the California Revenue and Taxation Code. Minimum required distributions for participants who have reached age 73 also apply per the IRC.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investment in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's net gains and losses on investments bought and sold during the year as well as held at year-end.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Contributions and contributions receivable

Participant contributions are recorded based on the date the contributions have been separated from a participant's pay, which is the pay date. Discretionary Employer matching and non-elective contributions, if any, are recorded in the year they are due to participants. The Plan records receivables contribution based upon the contribution recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions are recorded when they are received by the Plan and allocated to participants' accounts.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses for the Plan are recorded when incurred. Certain administrative expenses of the Plan, including recordkeeping and audit fees, were paid directly by the Center for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are indirectly paid out of the assets of the Plan.

Subsequent events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued. Plan management is not aware of any other subsequent events which would require recognition or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical asset or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are as follows:

- *Level 1* - inputs are quoted prices in active markets for identical assets or liabilities,
- *Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- *Level 3* - inputs are unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market and mutual funds: Valued at the closing price reported on the active market of which the funds are traded. Money market and mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These money market and mutual funds are required to publish their daily net asset value and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Trustees, determined to be qualified institutions by the Plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year) ("supplemental schedule"). The Trustees have certified that the following investment information included in the financial statements and supplemental schedule is complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments and interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and;
- Investments reflected on the supplemental schedule as of December 31, 2024.

5. TAX STATUS

The Plan adopted the Newport Group Inc. Volume Submitter 403(b) Plan Basic Plan Document #20 (the "volume submitter plan"). The Newport Group Inc., as sponsor of the volume submitter plan, was notified by the Internal Revenue Service by a letter dated March 31, 2017, that the volume submitter plan was designed in accordance with applicable sections of the IRC and is suitable for use by employers for the benefit of their employees. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue all contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, amounts allocated to participants' accounts become fully vested.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines a party-in-interest similarly to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Parties-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain fees and expenses of the Plan are paid by the Center. The Plan is not required to repay expenses paid by the Center on its behalf.

The Trustees retain as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Certain fund-level fees incurred by the funds in which the Plan invests for such services as record-keeping are paid through fund-level revenue-sharing agreements. These fees reduce the fund earnings, thereby impacting the investment return applied to participant's accounts.
