## Notes to Financial Statements

Year Ended December 31, 2024

1. Description of Plan:

The following description of the Rincon Research Corporation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

Rincon Research Corporation (Sponsor or Company) established the Plan in January 2001. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with the appropriate sections and regulations of the Internal Revenue Code (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In conjunction with establishing this employee stock ownership plan, the Sponsor established a money purchase pension plan. Both Plans are governed under the same Plan document, and are qualified as employee stock ownership plans by the Internal Revenue Service. All of the Plan's assets are held in the money purchase pension plan and the ESOP has no assets.

The Plan is administered by an appointed Trustee. Additionally, the Company formed an ESOP committee consisting of members appointed by the Rincon Research Corporation Board of Directors to oversee the administration of the Plan.

Eligibility and vesting:

The Plan covers all employees of the Company that have at least one hour of service, and does not include collectively bargained employee groups and casual employees. Participants are fully vested after one hour of service.

Employer contributions:

Employer contributions are made to the Trust in such amounts as determined by the Company's Board of Directors, provided they do not exceed the maximum amounts deductible under the IRC. Allocations of the employer contributions are made pro-rata based upon eligible compensation as defined in the Plan.

Contributions can be made in cash, shares of Company stock or a combination of both as determined by the Company's Board of Directors. Shares of Company stock are valued at their fair value at the end of the Plan year. As of December 31, 2024, the Company's Board of Directors has elected not to make any contributions to the Plan.

1. Description of Plan (continued):

Participants' accounts:

Each Participant's account is credited with the Participant's allocated shares of common stock, at fair value. Allocations of shares are based on the ratio of the Participant's beginning cash account balance plus the Participant's current year cash contributions to total beginning cash account balance plus the total current year cash contributions. S-Corp distributions received from the Sponsor are allocated based on the ratio of the participant's beginning share balance to the total Plan shares. Participant accounts are also credited with their pro-rata share of employer contributions, based on the participant's eligible compensation to total compensation. Plan earnings are allocated based on the participant's cash contribution as a percentage of the Plan's average other investments balance, as defined in the Plan document. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Payment of benefits:

No distributions from the Plan are made until a Participant retires, dies, is disabled, or otherwise terminates employment with the Company or elects to diversify a portion of their account. Distributions can be made in either stock or cash. Distributions based upon retirement, disability or death or for Participants who terminate employment after attaining age 55 shall be made in one lump sum during the Plan year following the Plan year in which the employee is no longer employed. For terminated employees, distribution is delayed until the third Plan year following the Plan year in which the employee is no longer employed by the Sponsor. For Participants whose account balance exceeds \$5,000, the Participant can elect to receive a lump sum distribution. For Participants whose account balance is less than \$5,000, the distribution will be made in a lump sum as soon as administratively possible during the Plan year which follows the Plan year in which the employee terminates. If the Participant's account balance is less than \$1,000, a distribution can be made without the consent of the Participant.

Any part of a Participant's company stock account and other investments account which is retained in the Trust after the third Anniversary Date coinciding with or immediately following the date on which the Participant terminates employment (starting with the Anniversary Date December 31, 2007), shall be treated as an "Undistributed Account". Effective January 1, 2025, any part of a Participant's company stock account and other investments account shall be treated as an "Undistributed Account" after the Participant's first Anniversary Date following termination. In any year that a Participant maintains an undistributed account, the Trust shall exchange any cash or other liquid assets held in the other investments accounts of Participants for the shares of Company stock held in the undistributed account, at the most recent appraised fair value of Company stock. Such exchange shall be made pro-rata based on the Participants' other investments account balances.

### 1. Description of Plan (continued):

#### Diversification:

Diversification is offered to Participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who meet certain age and participation requirements are allowed the option of diversifying the investment of their Company stock account. Participants who are qualified to diversify must be 55 years old and have participated in the Plan for ten years. Once both requirements have been met, the option allows the Participant to diversify up to 25% of their Company stock account for the five years following qualification. Starting in the sixth year in which the option is available, the Participant may diversify up to 50% of their Company stock account. Distribution in the form of cash is issued to those Participants who elect to diversify.

#### Voting rights:

Eligible Participants are entitled to direct the voting on all issues subjected to vote by the shareholders of the Company. In accordance with instructions from the Committee, the Trustee is permitted to vote any shares for which such instructions have not been given by a Participant.

#### Put option:

The Company stock that is held by the Plan and its Participants is subject to a put option. In the event that a Participant receives a distribution in Company stock which is not immediately repurchased by the Company, the Participant will be offered the option. The put option grants the Participant the right for a sixty day period after the stock is distributed to require the Company to purchase stock included in the Participant's account at fair value. If the put option is not exercised within the first sixty days, the Participant will have an additional sixty days in the following Plan year. The purpose of the put option is to ensure that the Participant has the ability to ultimately obtain cash.

### 2. Summary of significant accounting policies:

#### Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Trustee to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of significant accounting policies (continued):

#### Investment valuation and income recognition:

The Plan's investments are stated at fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

#### Payments of benefits:

Benefits paid to Participants are recorded when paid.

#### Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Company.

#### Subsequent events:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through October 9, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

### 3. Federal income tax status:

The Internal Revenue Service has determined and informed the Company by a letter dated June 13, 2017, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Trustee and the Plan Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related Trust was tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

### 4. Fair value measurements (continued):

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### 5. Plan termination:

Although it has not expressed any intent to do so, the Company has the right to discontinue contributions and to terminate the Plan at any time, subject to Plan provisions. Upon such termination, the interest of each Participant will be distributed to them or their beneficiary at the time prescribed by the Plan terms and applicable regulations.
