The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE A - DESCRIPTION OF PLAN

The following description of Meaden & Moore Employees' 401(k) Retirement Savings Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees of Meaden & Moore, LLP, Meaden & Moore, Ltd., M&M Business Solutions, Ltd., Meaden & Moore Management, Ltd., Meaden & Moore Financial Services, Ltd., Management Development Group, Ltd. and Meaden & Moore Forensic Services, LLC (the "Company") who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for the oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan or such dollar limit established by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions and Employer matching contributions into various investment options offered by the Plan. The Company may make contributions to each eligible participant's account by matching a percentage of the Participant's elective deferral for the Plan year. For the Plan years 2024 and 2023, the matching contributions are 25% of the first 6% of a participant's compensation. In addition, the Company may make a discretionary profit-sharing contribution to the Plan and the contribution is allocated in accordance with the Plan document. The profit-sharing contributions for Plan years ended December 31, 2024 and 2023 were \$1,185,425 and \$1,072,726, respectively.

Participant Accounts – Each participant's account is credited with the participant's contribution, the Employer's matching and discretionary profit-sharing contribution and an allocation of Plan earnings. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – All participants are immediately vested in their elective deferrals, qualified non-elective contributions (QNECs), and rollover contributions made to the Plan plus actual earnings and losses thereon. Vesting in the Company's matching contributions is based on years of service earning 20% each year after the completion of 1 year of service. Vesting in the Company's discretionary profit-sharing contribution is 100% after three years of service.

Notes Receivable From Participants – Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement. The loans are secured by the balance in the participant's account and bear interest at prevailing rates ranging from 3.25% - 8.50%. Principal and interest are paid ratably through payroll deductions.

Payment Of Benefits – On termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant or beneficiary receives a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan does allow in-service distributions for eligible participants and hardship withdrawals as permitted in accordance with the Internal Revenue Service guidelines.

NOTE A - DESCRIPTION OF PLAN - CONTINUED

Forfeited Accounts – Forfeitures due to termination from the Plan before a participant is 100% vested may be used as a reduction of the employer's contribution and to offset Plan expenses. For the years ended December 31, 2024 and 2023, forfeitures utilized were \$13,800 and \$13,513, respectively. The ending forfeiture balance at December 31, 2024 and 2023 was \$8,769 and \$2,741, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Valuation of Investments And Income Recognition – Investments in registered investment companies, the collective investment fund and self-directed investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Use Of Estimates – The preparation of financial statements in conformity with the generally accepted accounting principles of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment Of Benefits – Benefits are recorded when paid.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Plan Expenses – The Company absorbs certain administrative expenses of the Plan. Expenses that are paid by the Company are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants and distributions from the plan are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 9, 2025, the date the financial statements were available to be issued.

NOTE C - INVESTMENTS

All investment information and notes receivable from participants included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by the trustee, Charles Schwab Trust Bank.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust - Valued at the daily closing price as reported by the fund. The fund is required to publish their daily NAV and to transact at that price. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. For the 2024 Plan year, this fund is deemed to be actively traded. For the 2023 Plan year, the fund was not deemed to be actively traded therefore, the practical expedient of NAV was utilized. Participant transactions (purchases and sales) may occur daily. Were the fund to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly manner. There are no unfunded commitments.

Self-Directed Investments - The self-directed brokerage account is a retirement account which allows participants to invest in individual securities outside of the Plan's funds. Investments include common stocks, mutual funds, preferred stocks, unit investment trusts and money market funds. All of the self-directed investments are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PARTIES-IN-INTEREST TRANSACTIONS

The Plan invests in funds managed by Charles Schwab Bank, the trustee for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were \$71,806 and \$62,716 for the years ended December 31, 2024 and 2023, respectively.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE G - TAX STATUS

The Plan obtained its latest opinion letter on September 21, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

NOTE H - RISKS AND UNCERTAINTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.
