## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Alma Tire 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Alma Tire 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Alma Tire 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**GENERAL**

The Plan is a single-employer defined contribution plan established by Alma Tire Service, Inc (the “Company”) under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed one full month of service are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**PLAN ADMINISTRATION**

This plan is administered by Alma Tire Service, Inc. The Plan’s trustee, John Hancock Life Insurance Company, is responsible for the custody and management of the Plan’s assets.

**CONTRIBUTIONS**

**Employee Contributions** - Participants may elect to contribute up to the maximum of \$23,000 of pre-tax annual compensation in 2024, which is the permissible limit established by the Internal Revenue Code. Participants who will attain the age 50 by the end of the plan year are entitled to contribute an additional "catch-up contribution" up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan currently offers several different mutual funds as investment opportunities which are directed by participants.

**Employer Safe Harbor Contributions** - The Company is required to make a safe harbor contribution to the Plan on behalf of each eligible employee. The required contribution has a matching formula of 100% of each participant’s deferrals up to 4% of their compensation for the year. The Company may make a discretionary contribution to the Plan and has discretion over the amount, formula, and timing of any contribution made.

**PARTICIPANT ACCOUNTS**

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related employer contributions, as well as the participants share of the Plan’s income, and any related administrative expenses. Allocations of income and expense are based on the proportion that each participant’s account balance bears to the total of all participant account balances.

**VESTING**

Participants are immediately vested in their contributions, Safe Harbor contributions, and the discretionary match contributions.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms cannot exceed 60 months, except in the case of a primary residence purchase. The loans are secured by the balance in the participant's account and bear a fixed rate of interest ranging from 7.75% - 8.50% for the life of the loan. The interest rate is based on prime rate. Loans are repaid by means of payroll deduction. A fee related to administering a loan under the Plan may be deducted from the participant's account.

**PAYMENT OF BENEFITS**

Upon termination of service, disability or retirement, a participant (or the participant's beneficiary in the event of death) will receive a lump-sum distribution, unless otherwise requested, equal to the value of the participant's vested interest in his or her account. Distributions from the plan after termination for reasons other than death, can also elect partial withdrawals.

**HARDSHIP WITHDRAWALS**

Participants may take a hardship withdrawal for any of the following reasons:

1. To pay for medical care of the participant, his or her spouse, children or other dependents,
2. To purchase (excluding mortgage payments) the principal residence for the participant,
3. To pay tuition, related educational expenses, and room and board expenses for the next twelve (12) months of post-secondary education for the participant, his or her spouse, children, or other dependents,
4. To prevent eviction from, or foreclosure on the mortgage of, the participant's principal residence,
5. To pay for burial or funeral expenses for the participant's deceased parent, spouse, children or other dependents, or
6. To pay for the repair of damage to the principal residence of the participant.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**DATE OF MANAGEMENT'S REVIEW**

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

**BASIS OF ACCOUNTING**

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

**ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**ADMINISTRATIVE EXPENSES**

The company paid administrative expense of \$26,437 related to the Plan for 2024.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**EXCESS CONTRIBUTIONS REFUNDABLE**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable to participants totaled \$0 for the year ended December 31, 2024. The Plan is required to distribute the excess contributions to the participants by March 15<sup>th</sup> of the following year or follow additional corrective measures to maintain the Plan's tax-exempt qualification.

**RECLASSIFICATIONS**

Certain reclassifications have been made to the prior year financial statements to conform to the classifications used in the current year. Net assets available for benefits at the end of the year was unchanged due to the reclassifications.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. As of December 31, 2024, the Plan had no assets which were required to be measured using Level 2 or Level 3 inputs.

**NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$24,337 for the year ended December 31, 2024.

KDP Retirement Plan Services is the third party administrator for the Plan and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for recordkeeping services amounted to \$2,100 for the year ended December 31, 2024.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive the balance in the participant account. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. Generally, the Plan's tax fillings remain open for three years for Federal income tax examination.

The Company adopted a Prototype Non-Standardized 401(k) Profit Sharing Plan which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and therefore the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 – SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the SECURE Act 2.0. This act contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provision to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2024 financial statements.
