Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1: PLAN DESCRIPTION

The following description of the Bill Luke Chrysler Jeep & Dodge, Inc. 401(k) Plan (plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

The plan was established effective January 1, 1994 and is a defined contribution plan covering all full-time employees of Bill Luke Chrysler Jeep & Dodge, Inc., Bill Luke Tempe, L.L.C., Bill Luke Santan, L.L.C., and Bill Luke Marana, L.L.C., (the Companies) who have one year of service with a minimum of 1,000 hours of service during a twelve month period and are age twenty-one or older. The entry date is on the first day of the calendar quarter after meeting those requirements. The plan is subject to the provisions of ERISA.

Contributions

Each year, participants may contribute up to the limits as prescribed in the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and an insurance contract as investment options for participants. The Companies contribute a matching contribution equal to 9% of the first \$10,000 of elective deferrals and 3% thereafter. The Companies may contribute an additional discretionary matching and/or a non-elective contribution. During the years ended December 31, 2024 and 2023 the Companies elected not to make an additional discretionary match. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Participant Loans

The plan does not currently allow for participant loans.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant whose vested account balance exceeds \$5,000 can elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or elect to receive annual installments. Participants with an account balance of more than \$1,000 but less than or equal to \$5,000 that do not request a lump-sum distribution will have their account balance automatically rolled over to an individual retirement account (IRA). Participants with an account balance of less than \$1,000 must receive a lump-sum distribution.

A participant may also withdraw money from their account in the event of financial hardship. Hardship withdrawals may not exceed the amount of the participant's cumulative deferral and the participant may not make additional deferrals for a period of six months after the date of the withdrawal. A participant may not receive a hardship distribution of less than \$1,000.

A participant may also request an in-service withdrawal from their account after they reach the age of 59 1/2, if they become disabled or if the withdrawal qualifies as a reservist distribution.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Forfeited Accounts

Forfeitures of non-vested accounts may be applied to reduce future employer contributions or plan expenses. As of December 31, 2024 and 2023, there were \$5,183 and \$12,536 of unallocated forfeitures, respectively. In addition, \$300 of the forfeitures were used to pay Plan expenses and \$14,427 was used to pay employer contributions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments

Subsequent Events

The plan was amended with an effective date of January 1, 2025.

The plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Sentry Life Insurance Company, (the custodian of the Plan).

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed Fund/Deposit Administration Fund (DA Fund): A secondary market providing the opportunity to sell the contract held by the Plan does not exist. Contract value represents contributions made under the contract, plus interest, less funds used to pay benefits and expenses. The contract is an unsecured general obligation of Sentry Life Insurance Company. See Note 5.

Pooled Separate Accounts: Investments in pooled separate accounts represent ownership of units of participation (Units), rather than ownership of specific assets. The value of any one pooled separate account is determined by aggregating the value of all of the Units held by the Plan. The value of a single Unit is the total value of the pooled separate accounts underlying investments plus other assets less liabilities divided by the number of Units outstanding. Investments in the pooled separate accounts are valued at fair value which is generally determined by the quoted market price of the underlying investments. The value of the pooled separate is not publicly quoted.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Guaranteed Investment Contract with Sentry Life Insurance Company

In 2005, the Plan entered into a traditional fully benefit-responsive investment contract with Sentry Life Insurance Company (Sentry). The Fund maintains the contributions in a general account. The account is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The Sentry Life Insurance Company Guaranteed Fund is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value, which Sentry represents, is the most reasonable estimate of fair value. Contract value, as reported to the plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract, which Sentry represents, is the most reasonable estimate of fair value, at December 31, 2024 and 2023 was \$2,497,658 and \$2,446,580 respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting. Sentry Insurance reports the contract at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan document including complete or partial plan termination or merger with another plan, (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for the exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6: Related-Party Transactions

Certain plan investments are units in pooled separate accounts managed by Sentry Life Insurance Company. Sentry is the custodian as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan for the investment management services amounted to \$1,338 for the year ended December 31, 2024.

Sentry receives separate account administrative fee payments from mutual fund service providers which is retained by Sentry and are used to offset expenses.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

Note 8: Tax Status

On June 30, 2020, the IRS stated that the volume submitter plan adopted by the Plan, as then designed, qualifies under section 401(a) of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the last opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to the routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 11: Early Participation Correction

During 2023, the Company erroneously allowed a participant to begin to contribute to the plan in the fourth quarter of the year, when in fact they were not eligible until January 1, 2024. The Company made corrections in 2024, and the contribution amount of \$913 had been accrued as excess contributions payable, on the 2023 financial statements.

Note 12: Employee Elective Deferral Failure

During 2023, the Company discovered that they failed to continue an elective deferral for a single employee from October of 2021 to June of 2023. The Company made voluntary self-corrections for this error in the amount of \$663, plus lost earnings, which did not post to the participant account until January of 2024. The amounts included the qualified non-elective contribution made by the employer and employer matching contribution.

Note 13: Non-Exempt Prohibited Transactions

During 2023, the Company failed to remit an employee contribution to the Plan in a timely manner. The amount is \$3 for the final payroll of a terminated employee. This correction was made in 2024.

During 2024, a submission for a particular employee was returned by Sentry. It was determined that it should not have been returned. The employee and employer contributions, \$353 and \$32 respectively, were accrued on the 2024 financial statements.
