## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The RoviSys Company 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Description of Plan**

The following is a summary of certain provisions of The RoviSys Company 401(k) Retirement Plan (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Participation** – The Plan is a defined contribution plan, established as of January 1, 1994, covering substantially all full-time employees of the Plan sponsor, The RoviSys Company, RoviSys Building Technologies, LLC and RoviSys Federal Solutions, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**Administration** – The Company is responsible for controlling and managing the operations and administration of the Plan.

**Contributions** – Participants may elect to defer up to 100% of their compensation, in whole percentages only, subject to certain limits imposed by the Internal Revenue Service ("IRS"). The Company matches 50% of the first 6% of the eligible compensation deferred by the employee.

The Company may also make discretionary non-elective contributions. These contributions are allocated among participants eligible to share in the contribution for the Plan year. These contributions are allocated to each eligible participant's account under an integrated contribution formula as defined by the Plan. There were no such contributions made for the years ended December 31, 2024 or 2023.

**Participant Accounts** – The Plan maintains an individual account for each participant. These accounts are credited with the participants' contributions, Company contributions, and related earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants elect to maintain their aggregate participant contributions in the investment funds offered by the Plan. Separate accounting for each of the funds is made pursuant to the participant's designated election. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable From Participants** – The Plan allows loans to participants subject to certain regulatory restrictions. The amount of the loans cannot exceed the lesser of \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of all loans on any day during the one year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the participant's loan is made, or 50% of the participant's vested balance. Interest is charged based on the prevailing rate at the time of the loan. Loan terms must provide for equal payments to be made not less frequently than quarterly over a period generally not to exceed five years; however, if the loan is for the purchase of the participant's principal residence, the administrator may permit a longer repayment term. Principal and interest are paid ratably through payroll deductions. Repayments of principal and interest are credited to the participant's separate account within the funds as elected by the participant. Until such repayments are received, the notes receivable are accounted for in the participant loan fund.

Vesting – Participants are at all times vested in their contributions and earnings thereon. Employer contributions and actual earnings thereon follow a vesting schedule as follows:

Payment of Benefits – Participants who terminate under the Plan are paid the current vested value of their account balances. All distributions are in the form of lump-sum cash payments. The Plan provides for the immediate payout of a participant's account upon retirement, death, or other termination unless the balance of the account exceeds \$5,000. In this instance, payout will not occur without the consent of the participant and his/her beneficiary, if applicable.

Forfeitures – Forfeitures are used to offset future Employer contributions or administrative expenses at the Company's discretion. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$38,287 and \$27,706, respectively. For the years ended December 31, 2024 and 2023, \$98,978 and \$84,785, respectively, were used to reduce Employer contributions or to offset administrative expenses.

Termination Provisions – The Company anticipates and believes that the Plan will continue indefinitely. However, the Company reserves the right to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, participants would become 100% vested in their accounts and the assets then remaining in the funds would be allocated and distributed to participants in accordance with the terms and provisions of the Plan.

**Note 2. Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Interest income including interest on participant loans is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 2. Summary of Significant Accounting Policies (Continued)**

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from such estimates.

Risks and Uncertainties – The Plan holds various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative expenses of the Plan are paid by the Company or the Plan at the option of the Company except for fees related to participant loans and distributions, which are paid by the affected participants.

Subsequent Events – The Company has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

**Note 3. Unaudited Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The plan administrator received a certification from Ascensus LLC ("Ascensus") acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the statement of net assets available for benefits at December 31, 2024, the supplemental schedule of assets (held at end of year) at December 31, 2024, and the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the period November 14, 2024 to December 31, 2024, and investment related information in the accompanying notes to the financial statements. The plan administrator received a certification from Newport Trust Company ("Newport") acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the statement of net assets available for benefits at December 31, 2023, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the period January 1, 2024 to November 13, 2024 and the year ended December 31, 2023, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 4. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

- The fair value of registered investment companies is determined based on their quoted closing market prices in active markets for identical investments and is classified as Level 1.
- The investment in the common/collective trust fund is held and managed by T. Rowe Price. The fair value of the investment held in this account is based on its reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments is classified as Level 2.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Common/Collective Trust Fund**

The Plan holds an investment in the T. Rowe Price Stable Value Fund, which is a common/collective trust fund.

Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balances. Transfers of assets from the T. Rowe Price Stable Value Fund to a competing investment vehicle are restricted. Company initiated withdrawals are subject to a 12-month advance notice requirement.

**Note 6. Tax Status**

The prototype on which the Plan is based obtained an opinion letter dated November 30, 2020, in which the IRS stated that the prototype document on which this Plan is based was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype plan, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

The Company has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 7. Party-in-Interest Transactions**

Administrative expenses were paid to Newport (the Trustee for the year ended December 31, 2023 and for the period January 1, 2024 to November 13, 2024), Newport Group, Inc. (the Recordkeeper for the year ended December 31, 2023 and for the period January 1, 2024 to November 13, 2024), and Ascensus (the Trustee and Recordkeeper for the period November 14, 2024 to December 31, 2024). These amounts represent administrative fees and fees charged directly to participants for participant loans and distributions; therefore, these transactions qualify as party-in-interest transactions.
