Note 1: Description of Plan

The following description of the Monroe Truck Equipment, Inc. Profit Sharing and Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established as a qualified defined contribution plan and associated exempt trust. Participants of the Plan include all employees of Monroe Truck Equipment, Inc., Monroe Towmaster, LLC, and Carolina Custom Center, Inc. (collectively the "Employer") who are at least 18 years old and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants

Each participant is permitted to make pre-tax and Roth contributions pursuant to a salary reduction agreement between the participant and the Employer authorizing the Employer to defer eligible wages through this Plan. Participants can contribute up to \$23,000 for 2024. In addition, participants age 50 or over can make additional catch up contributions up to \$7,500 in 2024. A participant may also contribute amounts representing distributions from other qualified plans or a qualified individual retirement account (rollovers).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a group annuity contract as investment options for the participants.

The Plan includes an auto enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation with an annual automatic deferral increase of 1% up to a maximum deferral percentage of 10%.

Note 1: Description of Plan (Continued)

Contributions (Continued)

Employer

The Employer may match participants' salary reduction contributions at such rate or amount as is established at the discretion of the Employer. The Employer made discretionary matching contributions of 50% of participant deferrals up to 3% of eligible compensation for the year ended December 31, 2024.

The Employer may make discretionary nonelective contributions to the Plan. These contributions are allocable among eligible participants based on relative compensation. No discretionary nonelective contributions were made by the Employer for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, and allocations of (a) the Employer's discretionary nonelective contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions. Discretionary Employer matching and nonelective contributions and the actual earnings thereon for participants shall vest in the following manner:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25%-9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Loan repayments will be made in equal installments through regular payroll deductions for a term that shall not be greater than five years with the exception of a home loan, for which the repayment may not exceed a period of 15 years.

Payment of Benefits

On termination of service, a participant may receive a single lump-sum payment, ad-hoc distributions, or installment payments equal to the value of the participant's vested interest in their account. Hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. In addition, the Plan also allows in-service distributions upon attaining age 59 1/2.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$149,007 and \$111,650. These accounts will be used to pay any administrative expenses or be used to reduce any Employer discretionary matching contributions. During the year ended December 31, 2024, \$24,297 of forfeited nonvested accounts were used to reduce Employer discretionary matching contributions.

Note 2: Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts) (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to recordkeeping, investment advisory, and investment management are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Fully Benefit-Responsive Group Annuity Contract

The Plan invests in a FBRIC with Empower Annuity Insurance Company of America ("Empower") in the form of a group annuity contract that invests in traditional investment contracts. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan (1.71% and 1.51% in 2024 and 2023). The group annuity contract is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan's ability to transact at contract value with Empower including plan termination and other events as specified in the group annuity contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The group annuity contract does not permit Empower to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Trustee and Custodian

The Plan administrator has elected the method of annual reporting compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the Trustee and Custodian of the plan.

Note 6: Party-In-Interest Transactions

Certain plan investments are managed by Empower. Empower is a Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Expenses incurred and paid by the Plan for recordkeeping, investment advisory, and investment management were \$127,482 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 8: Tax Status

The Employer adopted a nonstandard pre-approved document with an Internal Revenue Service notification letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
