### Note 1 - Plan Description

The following description of Wyoming Machinery Company Employee Medical Benefit Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

#### **General**

The Plan was established in January 1975 for the purpose of providing health and other benefits to eligible employees of Wyoming Machinery Company (the "Company" or the "Employer"); participants electing Consolidated Omnibus Budget Reconciliation Act (COBRA) coverage; and a limited number of former employees who elected early retirement.

Certain plan assets were held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Benefits**

The Plan provides health (medical, vision, dental, and prescription drugs), life and accidental death, and short-term and long-term disability benefits.

Employees working at least 1,000 hours per year are generally eligible for medical, vision, dental, and prescription drug insurance benefits the first day following 30 days of continuous full-time employment. Employee beneficiaries and covered dependents become eligible for benefits on the same day the employee becomes eligible. An employee is eligible for disability benefits following two years of full-time employment. The Plan also provides continuation of certain benefits upon termination of employment to certain qualifying retirees and through COBRA.

Certain former employees who turned 60 years of age during 2016 and accepted a voluntary early retirement program are also eligible until their 65th birthday or until they become eligible for Medicare, Medicaid, or any other group health insurance plan through their or their spouse's employment and provided they pay the required normal, active contributions, as described below. The Plan includes coverage to covered employees who are absent from work due to a temporary layoff from 30 to 60 days.

#### **Insured Benefits**

The Plan fully insures the life insurance, vision, accidental death benefits, and short- and long-term disability. The Company purchases annual insurance contracts for these insured benefits.

#### **Stop-loss and Self-insured Benefits**

##### **Self-insured Benefits**

All other plan benefits (medical, dental, and prescription drugs) are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under an administrative services only (ASO) arrangement. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the Company for claims in excess of pharmacy rebates received by the third-party claims processor relating to the plan. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

##### **Stop-loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits related to medical and prescription drug claims (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). For the years ended December 31, 2024 and 2023, the individual stop-loss was \$200,000 and the aggregate stop-loss was \$1,000,000.

### Note 1 - Plan Description (Continued)

#### Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop-loss insurance, net of rebates receivable for pharmacy prescriptions.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

The Plan gives participants the option to choose between three types of coverage, one generally covering 90 percent of the participant's medical costs and the others covering 70 percent, with one having a high deductible health plan option. The participant's monthly contribution varies according to the plan selected.

Additionally, qualifying retired employees and terminated employees under COBRA contribute to the Plan.

Benefits provided under the Plan are funded by employer and participant amounts contributed to the Plan and by the payment of premiums on a stop-loss medical insurance contract.

#### Party-in-interest Transactions

The Plan is administered by Blue Cross Blue Shield of Wyoming (BCBSWY). BCBSWY is the contract administrator of the Plan and, therefore, qualifies as a party in interest, as defined by ERISA. BCBSWY is paid a per participant monthly administration fee, as described in the service agreement between BCBSWY and the Employer. BCBSWY was also paid a fee for negotiating discounts with providers. Fees paid by the Plan to BCBSWY totaled \$452,184 and \$417,638 for the years ended December 31, 2024 and 2023, respectively.

Wyoming Machinery Company provides certain accounting and administrative services to the Plan, for which no fees are charged.

### Note 2 - Summary of Significant Accounting Policies

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Benefit Payments*

Claim payments are recorded when paid by the third-party claims processor.

#### *Stop-loss*

Premiums for stop-loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits and changes in benefit obligations. Stop-loss refunds totaled \$0 for the years ended December 31, 2024 and 2023.

#### *Claims Incurred but not Reported*

Benefit obligations at December 31, 2024 and 2023 consist of claims approved but unpaid and estimated health claims incurred by active participants but not reported at that date. This estimate is based upon subsequent disbursements for claims incurred as of December 31, 2024 and 2023.

#### *Claims Payable*

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as claims payable in the accompanying statement of net assets available for benefits and benefit obligations.

#### *Risks and Uncertainties*

The benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including October 8, 2024, which is the date the financial statements were available to be issued.

### Note 3 - Tax Status

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the trust's net investment income is generally exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the plan sponsor believes that the trust continues to qualify and to operate in accordance with applicable provisions of the Code.

### Note 4 - Plan Termination

Although it has not taken steps to do so, the Company has the right under the Plan to amend and terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.
