We have performed audits of the financial statements of Brewer Science, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 And 2023**

### **1. Description Of The Plan**

The following description of the Brewer Science, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan, which has been adopted by Brewer Science, Inc. (the Company or Plan Administrator), is a defined contribution profit sharing plan that includes a 401(k) provision. The Plan covers all employees of the Company who have attained the age of 21, and does not cover nonresident aliens, leased employees, and employees classified as interns. Participants enter the Plan on the first day of the month following employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may defer salary up to an annual maximum amount allowed by law. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans. Further, participants may designate all or a portion of their elective deferrals as Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for automatic enrollment with contributions of 8% of eligible compensation unless the participant elects to opt out of participation or elect a different deferral percentage.

The Company may make discretionary matching contributions to the Plan for the benefit of its participants based on eligible participant contributions to the Plan. From January 1, 2023 through February 15, 2023, the Company matched 50% of the first 8% of elective deferrals. From February 15, 2023 through December 31, 2023, the Company matched 12.5% of the first 8% of elective deferrals. During 2024, the Company matched 50% of the first 8% of elective deferrals. The Company's discretionary matching contribution totaled \$1,115,767 and \$395,018 for the years ended December 31, 2024 and 2023, respectively.

### Notes To Financial Statements *(Continued)*

In addition, each year the Company may make a discretionary profit sharing contribution to the Plan. The Company will determine the amount, if any, for each Plan year. The Company did not make a discretionary profit sharing contribution during the years ended December 31, 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of Company discretionary profit sharing contributions, Plan earnings, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range up to five years, or ten years if the loan qualifies as a home loan. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Loan repayments of principal and interest are made through payroll withholdings.

#### **Vesting**

Participants are vested immediately in their contributions and Company discretionary contributions plus actual earnings thereon.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct the investment of their account to any of the investment options available to Plan participants.

#### **Administrative Expenses**

Administrative expenses are paid by the Plan, which includes recordkeeping fees, trust fees and investment advisor fees. Investment related expenses are included in net change in fair value of investments.

#### **Payment Of Benefits**

Upon termination of service, death, total disability, a participant (or beneficiary) may elect distribution of his or her account as a single lump sum or a retirement annuity. Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

### Notes To Financial Statements (*Continued*)

Upon termination of service, if the total vested account balance does not exceed \$5,000, the participant's account balance will be distributed in a lump sum, unless otherwise elected. If the total vested account balance equals or exceeds \$5,000, the Plan will make a distribution to the participant as soon as is administratively feasible following the participant's election to begin payment.

#### **Participant Hardship Withdrawals**

Participants may withdraw from the Plan that portion of their account resulting from salary deferrals and rollover contributions and earnings thereon in the event of undue financial hardship, as defined in the Plan Agreement. The maximum hardship withdrawal is the total of a participant's contributions or the amount of the financial hardship, whichever is less. Hardship withdrawals are subject to the terms of the Plan Document and provisions of the Internal Revenue Code (IRC).

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or pay to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized and unrealized gains and losses.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Agreement.

#### Payment Of Benefits

Benefits are recorded when paid.

#### Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### 3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Newport Trust Company, the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### Registered Investment Companies

These funds are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

#### Collective Trust Funds

Valued at the NAV of units of the individual fund. The NAV, as provided by the trustee of the invested fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Risks And Uncertainties

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

### **7. Tax Status**

The Plan adopted a pre-approved plan document sponsored by Newport Group, Inc. The pre-approved plan obtained an opinion letter dated June 30, 2020 in which the IRS state that the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan and the related trust are tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal tax returns for tax years 2021 and later remain subject to examination by taxing authorities.

### **8. Party In Interest Transactions**

The Plan pays for substantially all administrative fees, including professional and recordkeeping fees. In addition, certain participants have outstanding loans as of These transactions qualify as exempt party in interest transactions.
