## CYCLONE DRILLING, INC. 401(K) PLAN NOTES TO FINANCIAL STATEMENTS

---

### Note A. Description of Plan

The following description of the Cyclone Drilling, Inc. (“Company”) 401(K) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the Company who have at least six months of service and are age eighteen or older. After the participant has met these requirements they are eligible to be admitted on the next entry date. The entry dates under the Plan are January 1 and July 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Board of Directors is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions - The Company will contribute an amount determined by the Company's Board of Directors and the Company may make special qualified non-elective contributions on behalf of non-highly compensated participants that are sufficient to satisfy the actual deferral percentage test or the average contribution percentage test, or both, pursuant to regulations under the code. The Company's matching contributions are made annually after the last day of the Plan year for those employees who made elective deferrals during the period and who are employed on the last day of the period. The Company has elected to match 100% of the first 5 percent of an employee's compensation that a participant contributed to the Plan for the years ended December 31, 2024 and 2023. Participants annual deferrals may not exceed a dollar limit that is set by law. Participants may also make ROTH 401(K) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The employer will make employer profit sharing contributions to the Plan on behalf of qualifying participants based on a discretionary formula for each Plan year which the Board of Directors elects to contribute an amount to be determined from year to year. The employer profit sharing contribution will be allocated in the ratio that each qualifying participant's compensation for the Plan year bears to the total compensation of all qualifying participants for the Plan year. To be eligible the participant must be an employee of the employer on the last day of the Plan year. However the last day requirement will be waived if any of the following apply: the participant's death, the participant's termination of employment after having incurred a disability or, the participant's termination of employment after having reached the normal retirement age. The Company elected to not make a profit sharing contribution for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of, a) the Company's contribution and, b) Plan earnings (losses), and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions and related earnings of their accounts is based on years of service. A participant is 100 percent vested after five years of credited service. A year of service for vesting is each Plan year in which an employee has 1,000 hours of service with the Company.

## NOTES TO FINANCIAL STATEMENTS

---

### Note A. Description of Plan (Continued)

Payment of Benefits - On termination of service, employment, due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts - At December 31, 2024 and 2023 forfeited nonvested accounts totaled approximately \$30,000 and \$28,400, respectively. These accounts are used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by approximately \$33,300 from forfeited nonvested accounts.

### Note B. Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note C for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable - At December 31, 2024 and 2023, liabilities of \$288,413 and \$89,756, respectively, are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the IRS. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the following year.

Payment of Benefits - Benefits are recorded when paid.

Operating Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Costs absorbed by the Company totaled approximately \$32,500 and \$30,000 for the years ended December 31, 2024 and 2023, respectively.

Subsequent Events - The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

### Note C. Fair Value Measurement

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

## NOTES TO FINANCIAL STATEMENTS

### Note C. Fair Value Measurement (Continued)

#### Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

### Note D. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus as agent for Ascensus Trust Company (the trustee of the Plan). The information certified includes total investments of \$18,035,609 and \$14,273,996 at December 31, 2024 and 2023 respectively, and investment income of \$2,174,765 and \$2,382,871 for the years ended December 31, 2024 and 2023, respectively.

### Note E. Related-Party Transactions and Party-in-Interest Transactions

Ascensus, LLC. and Ascensus Trust Company provide administrative services as well as manages certain Plan investments which are shares of mutual funds in the Plan. LPL Financial, LLC also provides investment management services to participants in the Plan. These service providers provide services as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services totaled approximately \$88,800 and \$69,100 for the years ended December 31, 2024 and 2023, respectively.

### Note F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## NOTES TO FINANCIAL STATEMENTS

### Note G. Tax Status

The Company adopted a non-standardized pre-approved profit sharing plan with CODA, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
