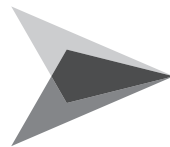

We have performed audits of the financial statements of C. J. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(c) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the C. J. Moyna & Sons, LLC (the “Company”) 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

1. **General.** The Plan was established March 1, 1995, and is a defined contribution plan covering all full-time employees of the Company who have one year of service (two years for employer’s match), one thousand hours of service, and who are 18 years of age. Employees can enter the Plan on January 1 and July 1 of each year. If an employee does not elect a deferral percentage or decline participation in the Plan, the employee is automatically enrolled with a deferral rate of 4%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was last amended effective September 30, 2024.
2. **Contributions.** Each year, participants may contribute an amount not to exceed a specific dollar amount determined by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a common commingled trust account as investment options to participants. The Company contributes 25% of the first 4% of base compensation that a participant contributes to the Plan. The matching Company contribution is invested into the various investment options offered by the Plan. In addition to the employer match, participants which remain employees at year end are eligible for a discretionary profit sharing contribution. These amounts are reflected on the financial statements. Additional amounts may be contributed at the option of the Company’s board of trustees and are invested in the same investment options as mentioned above for participant and Company matching contributions. Discretionary contributions were \$455,406 for the year ended December 31, 2024.
3. **Participant Accounts.** Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) Plan earnings and reduced by administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
4. **Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is vested immediately, as well.
5. **Participant Loans.** The Plan does not allow participant loans.
6. **Forfeited Accounts.** Employee and Company contributions are immediately vested. As a result, the Plan has no forfeited accounts.

7. *Payment of Benefits.* On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period not to exceed the life expectancy of the participant or survivor. In-service distributions are allowed for hardship and attainment of age 59½ as explained in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants receive a mandatory cash out after severance if balance is less than \$5,000.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles.

Investment Valuation and Income Recognition - The Plan's investments are valued at fair value, except for the common collective trust which is reported at net asset value. Net asset value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to common collective trusts. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Date of Management Review - Management has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued.

Note 3 - Investments in Common Collective Trust

The Plan invests in common collective trusts (CCTs) which are valued at their net asset value (NAV) as a practical expedient. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of units outstanding. The NAV is provided by the trustee of the CCT and is used as a basis for the valuation of the Plan's investment.

The investments in CCTs are not subject to any restrictions on redemptions and can be redeemed at NAV per share at the measurement date. There are no unfunded commitments related to these investments.

Note 4 - Fair Value Measurement

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at quoted market prices, which represent the fair value of shares held by the Plan at year-end.

Note 6 - Tax Status

The Internal Revenue Service has determined and informed the Company by letter, dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Administrative Expenses

For the years ended December 31, 2024 and 2023, substantially all administrative expenses associated with the Plan are paid directly by the Plan.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

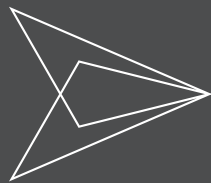
