### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Acclara 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Acclara 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Note 1 - Description of Plan**

The following brief description of the Acclara 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering qualified employees of Acclara Solutions, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Eligibility**

Employees were eligible to participate after completing three (3) months of service and attainment of age 21, excluding union, nonresident aliens, leased, residents of Puerto Rico, part-time (as defined by the Plan), temporary, seasonal, and certain Code Section 410(b)(6)(C) transition employees (until specifically authorized to participate).

### **Entry Date**

Employees could enter the Plan immediately following the date they satisfied the Plan's eligibility requirements.

### **Contributions**

Participants could elect to contribute up to 75% of their pretax annual compensation, as defined by the Plan. Contributions were subject to certain Internal Revenue Code (IRC) limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan allowed participants to designate contributions as Roth contributions. Participants could also contribute amounts representing distributions from other qualified plans (rollovers). The Company contributed 100% of the first 4% of eligible compensation that a participant contributed to the Plan. The Company could, at its sole discretion, contribute an additional amount to the Plan that was allocated to the participants based upon an individual's eligible compensation compared to total eligible compensation for all participating employees. During the year ended December 31, 2024, the Company made no discretionary contribution to the Plan.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation, unless they elected otherwise. Such contributions were directed to a specified fund based on the employee's current age and when the Plan's normal retirement date will be reached. The initial automatic deferral amount increased by 1% on the first day of each plan year up to a maximum of 15% of compensation.

### **Participant Accounts**

Each participant's account was credited with the participant's contributions and the Company's safe-harbor contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled was the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment to the Plan, a participant could direct deferrals and employer contributions in any of the funds offered by the Plan. Participants could change their investment options daily.

### **Vesting**

Participants were 100% vested immediately in their contributions and the Company's safe-harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions was based on years of service with the participant 0% vested until attaining three years of service. At that time, the participant became 100% vested.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$106,855, respectively. Forfeitures could be reallocated as an additional employer contribution, used to reduce Company contributions and/or used to pay Plan expenses. During the year ended December 31, 2024, plan expenses were reduced by \$3,487 from forfeited non-vested accounts.

### **Notes Receivable from Participants**

As per the Plan documents, notes receivable from participants are not permitted. The notes receivable balance in the financial statements includes loans that were transferred into the Plan as a result of the 2023 mergers with the Acclara Solutions, LLC Retirement Savings Plan and the St. Joseph Health and Covenant Health Systems 401(k) Plan. These loans were originally issued under the terms of the respective merged plans and were carried over to the current Plan upon merger.

### **Payment of Benefits**

Benefits were paid to the participant or their beneficiary as either a lump sum payment or installment payments as defined by the Plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$1,000 could be automatically paid out by the Plan upon termination. Distributions could be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined by the Plan document.

### **Plan Termination**

The Plan merged into the R1 RCM Holdco Inc. 401(k) Plan in 2024. The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the ERISA. In the event of Plan termination, participants became 100% vested in their employer contributions.

## **Note 2 - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investments and Income Recognition**

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and other third parties. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and the related Company safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

### **Subsequent Events**

The Plan Sponsor has evaluated subsequent events through September 29, 2025, the date which the financial statements were available to be issued.

### **Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Note 4 - Certified Information**

Certain information related to investments disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

#### **Note 5 - Tax Status**

The Plan uses the Transamerica Retirement Solutions LLC's Non-standardized Pre-Approved Profit-Sharing Money Purchase Plan with a cash or deferral arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS and the prototype has been amended since receiving the opinion letter. However, The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 - Contract with Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with Transamerica Life Insurance Company (Transamerica). Transamerica maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and there is no minimum guaranteed interest rate under the Contract. Such interest rates are reviewed on a semi-annual basis for resetting.

Because the investment contract is fully benefit-responsive, contract value is the relevant measure, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Transamerica represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023, was \$0 and \$370,688, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### **Note 7 - Related Party and Party-in-Interest Transactions**

Certain Plan investments are shares in funds managed by Transamerica, the recordkeeper as defined by the Plan, or related entities. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Plan Amendments**

Effective January 1, 2024, the Plan was amended and restated with the following key changes:

1. Plan Merger: The Advata 401(k) Plan was merged into the Plan.
2. Service Period Inclusion: Periods of service with Advata are included for determining eligibility and vesting.
3. Immediate Vesting: Participants of the merged Advata 401(k) Plan are 100% immediately vested in both transferred and future Employer Match and Employer Nonelective contributions.

Effective June 30, 2024, the Employer ceased making safe harbor contributions to the Plan.

#### **Note 10 - Plan Transfers In**

Effective January 1, 2024, the Plan was amended to merge Advata 401(k) Plan with the Acclara 401(k) Plan. Eligible employees of Advata 401(k) Plan were automatically enrolled into the Plan on the respective dates. Participant account balances of \$3,583,718 were transferred into the Plan on January 31, 2024.

#### **Note 11 - Plan Termination and Transfer to R1 RCM Holdco Inc. 401(k) Plan**

Effective December 31, 2024, the Plan was terminated and merged into the R1 RCM Holdco Inc. 401(k) Plan. Concurrent with the official merger date into the R1 RCM Holdco Inc. 401(k) Plan, the plan was amended to reinstate the safe harbor contribution. All plan assets transferred to the surviving plan on December 31, 2024.

**Note 12 - Delinquent Participant Contributions**

During 2019, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$30,224 within the period prescribed by DOL regulations. Delays in remitting contributions to the custodian were due to administrative errors, and the Company will make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delay.

During 2023, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$547,099 within the period prescribed by DOL regulations. Delays in remitting contributions to the custodian were due to administrative errors, and the Company made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delay.
