Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Blue Cross and Blue Shield of Florida, Inc. 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution, including in their role as agent as directed custodian for certain assets of the Plan, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

1. Description of Plan

The following description of the Blue Cross and Blue Shield of Florida, Inc. 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a safe-harbor defined contribution plan covering substantially all employees of Blue Cross and Blue Shield of Florida, Inc. d/b/a Florida Blue (“Sponsor”) and certain affiliated companies including GuideWell, Inc. d/b/a GuideWell Connect, (collectively, “Employer” or “Company”) who meet the eligibility requirements as outlined in the Plan. The Plan does not cover contractors or interns. The Plan is a single-employer program and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The National Employee Benefits Committee of the Blue Cross and Blue Shield Association (the “Administrator”) administers the Plan. Fidelity Management Trust Company (“Trustee”) is the trustee and Fidelity Workplace Services LLC is the recordkeeper for the Plan.

Contributions

Newly eligible and rehired employees are automatically enrolled in the Plan at a participant contribution rate of 3% unless they elect not to participate or to contribute at a different rate. Participants’ contributions automatically increase 1% annually if they are contributing 4% or less of their compensation, unless the participant opts out of the automatic increase. Participants may contribute up to 50% of pretax annual compensation as defined by the Plan. The Company makes a matching contribution equal to 100% of the first 3% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. Participants may elect to make Roth (after-tax) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, money market funds, and common and collective trust funds (“CCT”). Additionally, the Plan offers a self-directed brokerage account option entitled “Brokeragelink,” which allows participants to invest in a wide array of individual securities.

In addition, an enhanced, discretionary Plan contribution is available to all participants. The Company has the discretion to make an additional nonelective contribution that is not contingent on the employee’s contribution. This additional contribution ranges from 2% to 5% of the employee’s eligible compensation, based on years of service. Effective January 1, 2018, participants have immediate eligibility for the nonelective contribution. Active employment on December 31 of the Plan year is required. The nonelective contribution is funded annually after the close of the Plan year. The Company chose not to fund the nonelective contribution for the 2024 Plan year due to cost saving measures across the enterprise.

Additional discretionary amounts may be contributed at the option of the Company to the accounts of those participants who were actively employed during the plan year. There were no additional discretionary contributions in 2024. Employee and employer contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, the additional discretionary, nonelective contribution, and allocation of investment

earnings or losses. Certain participant transaction charges, such as loan initiation fees and loan maintenance fees, are charged to the participant's account. Investment earnings or losses are based on the participants' account balances and their investment elections, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are vested immediately in their contributions and the Company's matching contributions plus actual earnings thereon. Effective January 1, 2018, there is a two-year vesting period for the nonelective contribution. Prior to 2018, participants were vested immediately in the nonelective contribution.

Forfeitures

Forfeited nonvested balances are used to reduce future Employer contributions. Forfeited nonvested balances available for use were approximately \$1,305,000 and \$715,300 at December 31, 2024 and 2023, respectively. No forfeitures were used to reduce employer contributions in 2024.

Employer Contributions Receivable

The employer contributions receivable at December 31, 2023 is comprised of the discretionary nonelective contribution. There is no receivable at December 31, 2024 as the Company did not make a non-elective contribution in 2024.

Notes Receivable from Participants

At the approval of the Trustee, participants are permitted to borrow from the Plan. If approved, a loan must be adequately collateralized and bear interest at the prime rate as published by Reuters on the last business day of the prior month plus 1%. Interest rates ranged from 4.25% to 10.00% for loans outstanding at December 31, 2024. No more than 50% of the participant's vested account balance can be considered by the Plan as collateral for the outstanding loan balance of all Plan loans made to a participant. The minimum loan permitted under the terms of the Plan is \$1,000, subject to Plan rules. The maximum amount of a participant's account balance that can be on loan at any given time is the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are generally required to be repaid within five years. Loans used to acquire a principal residence may be repaid over a maximum term of 30 years. Loan repayments are deducted from the participant's payroll over the term of the loan.

Payment of Benefits

Upon leaving employment, death, disability, or retirement, a participant with a vested account balance greater than \$5,000 may elect to receive a lump-sum distribution or installment payments of the vested balance. Participants with a vested account balance of \$5,000 or less will receive a mandatory lump sum distribution. Lump sum distributions may be in the form of a cash payment or a rollover to another retirement plan. In-service benefit payments are permitted for various reasons as outlined in the Plan document.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are generally stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in fair value of investments which consists of the realized gains and losses and the unrealized appreciation and depreciation on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Notes Receivable from Participants

Notes receivable from participants are recognized as the outstanding principal balance, plus any interest accrued. The notes are fully collateralized by the balance in the participant's account, and as such, no allowance for uncollectible accounts has been recorded in the Plan's financial statements.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. The market value of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults, and asset rating downgrades. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events have been evaluated through September 12, 2025, the date that the financial statements were available to be issued, to determine whether circumstances warranted recognition and disclosure of those events in the financial statements as of December 31, 2024.

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement* ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

On a recurring basis, the Plan is required to measure marketable securities at fair value. The fair values of marketable securities are determined based on quoted market prices in active markets and based upon the marketability of those assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common and Collective Trust Funds

A CCT is a comingled pool of investments, not a mutual fund, with the objective of preserving principal while earning interest income, dividend income, and appreciation. The fair values of the Plan's interest in the CCTs are based on the net asset value ("NAV") reported by the fund manager as of the financial statement dates. The beneficial interest in the net assets of the trust is represented by units. Issues and redemption of units are recorded upon receipt of the unit holder's instructions in good order based on the next determined NAV per unit. NAV per unit is determined each business day.

One of the investment options offered by the Plan is a stable value CCT. The stable value CCT is fully invested in a stable return fund, which is primarily invested in contracts deemed to be fully benefit-responsive. A holding in this stable value CCT is considered an indirect investment in fully benefit-responsive contracts, which should be measured at fair value. However, the NAV of this fund is measured at contract value and can be used to approximate the fair value as a practical expedient. The stable value CCT generally permits participant-directed withdrawals on any business day. The stable value CCT requires a 12-month notice for liquidation of the underlying assets in the case of any nonparticipant directed withdrawals. An example of a nonparticipant directed withdrawal is if the sponsor decided to no longer offer the stable value CCT as an investment option. There are no unfunded commitments to the stable value CCT. The Plan's participants are permitted to redeem investment units at NAV on any business day.

Mutual Funds

Mutual funds, or registered investment companies, are public investment vehicles valued using the NAV provided by the administrator of the fund and calculated daily at the close of business. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in mutual funds are classified within Level 1 of the fair value valuation hierarchy. The mutual funds can be redeemed on any business day and there are no unfunded commitments to these mutual funds.

Money Market Fund

These investments are valued at amortized cost-plus accrued interest, which approximates fair value. Investments in money market funds are classified within Level 1 of the fair value valuation hierarchy.

Brokerage Accounts

Participant-directed brokerage accounts are primarily invested in registered investment companies (mutual funds and unit investment trusts), common stock, and cash. Interactive Data Corporation ("IDC") provides pricing for the majority of these holdings.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party Transactions

At December 31, 2024 and 2023, there were outstanding notes receivable due from Plan participants of approximately \$39,900,000 and \$34,960,000, respectively. All notes were made in accordance with the Plan agreement. None of these notes were determined to be prohibited transactions as defined by ERISA.

Certain Plan investments are managed by the Trustee. Accordingly, these investments are deemed to be party-in-interest transactions. Administrative fees paid by the Plan for services performed by the Trustee for the year ended December 31, 2024 were approximately \$1,915,000. Moreover, the Company's personnel and facilities were used by the Plan at no charge.

The Company is an independent licensee of the Blue Cross and Blue Shield Association (the "Association"). The Association owns the Blue Cross and Blue Shield service marks and establishes national policies. It sets certain operating and financial guidelines for the independent Blue Cross and Blue Shield Plans. The Association is not an affiliate or guarantor of the Company. As part of the guidelines, National Employee Benefits Association ("NEBA") is established to oversee the respective benefit plans of independent licensees. On a quarterly basis, NEBA bills the Company for estimated administrative expenses to monitor the Plan. During 2024, the Company paid expenses of approximately \$117,000 to NEBA on behalf of the Plan. Certain other administrative expenses related to the Plan were paid by the Sponsor.

6. Plan Termination

Although no intent to do so has been expressed, the Company has the right under the Plan to discontinue its contributions at any time and/or to terminate the Plan subject to the provisions of ERISA. Participants are vested in their accounts regardless of a Plan termination. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine which is in compliance with ERISA.

7. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated November 2, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC") for amendments effective on or before January 1, 2015. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not

be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
