Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Psomas Retirement Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of Psomas Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan was established on February 1, 1985, and covers all employees who are 18 or older. The Plan is subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as amended, and is exempt from federal and state taxes on income under the current provisions of the *Internal Revenue Code* (IRC) and state taxation codes, respectively. There were 993 and 933 participants in the Plan at December 31, 2024 and 2023, respectively. Of these participants, 774 and 748 were active participants at December 31, 2024 and 2023, respectively. Any employee on Psomas (the Company)'s payroll may join the Plan on the first pay period of any month after 30 days of employment. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

Administration The Plan is administered by the Company. Professional fees related to the administration of the Plan are paid by the Company.

Contributions Participant contributions to the Plan are elective, wholly vested, and invested in accordance with the participant's instructions. Participants may elect to make salary deferrals up to the maximum dollar amount allowed annually as defined by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Effective July 1, 2000, the Company established the Psomas Employee Stock Option Plan (ESOP), a qualified retirement plan. The Psomas ESOP invests primarily in Company shares purchased from selling principals. The Company made discretionary matching contributions of \$1,963,841 and \$1,775,554 for the years ended December 31, 2024 and 2023, respectively.

Rollovers The Plan allows participants to rollover accounts from other qualified plans into the Plan. Participants elected a total of \$2,244,513 and \$1,181,352 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts Each participant's account is credited with his/her contributions, employer discretionary matching contributions, actual earnings (losses) on investments, and administrative expenses that are paid by the Plan, which are allocated exclusively to the electing participant. The benefit to which a participant is entitled is the amount that can be provided from the participant's account.

Vesting Participants are fully (100%) vested in elective contributions, catch-up contributions, rollover contributions, discretionary matching contributions, and earnings (losses) credited to their accounts. The participant's vested account is nonforfeitable.

Notes Receivable From Participants Participant loans are permitted under the Plan. Participants may borrow no less than a minimum of \$1,000 and up to a maximum of the lesser of 50% of the participant's nonforfeitable account balance, or \$50,000. The loans are secured by the balances in the participants' accounts and bear interest ranging from 4.25% to 9.50%. Interest rates are set by the administrator and are determined using a reasonable rate of interest at the time of the loan. Principal and interest are paid through weekly or biweekly payroll deductions. All loans are repayable within five years, except for home loans, which may be repaid over ten years.

Investment Options The Plan holds its investment options through Fidelity Management Trust Company (Fidelity). Plan participants may allocate their account balances between one money market fund and a variety of stock and bond mutual funds.

Payment of Benefits Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the taxing authorities. Upon termination of service, retirement, disability, or death, a qualified participant with a vested account balance of \$1,000 or less will receive their account balance in a lump-sum payment. For vested balances exceeding \$1,000, the participant or beneficiary may elect, in writing, to receive payment in lump-sum or in a systematic withdrawal plan under a fixed reasonable period of time. At December 31, 2024 and 2023, no amounts were allocated to employees who elected to withdraw from the Plan but have not been paid.

Plan Termination Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: These assets are valued at the net asset value (NAV), generally \$1 per share, and are reported on the active market on which securities are traded.

Self-Directed Brokerage Accounts: The Plan allows participants to invest in self-directed brokerage accounts. Accounts primarily consist of common stock, money market funds and stock options which are valued on the basis of readily determinable market prices.

Mutual Funds: Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as distributions in accordance with the terms of the Plan agreement.

Payment of Benefits Benefits are recorded when paid.

Expenses Certain operating expenses of the Plan are deducted from participant accounts and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY FIDELITY

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Fidelity, except for comparing such information to the related information included in the financial statements and supplementary schedule. The Plan administrator has obtained certifications from Fidelity indicating that the information provided by Fidelity is complete and accurate. Such information includes:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends

Fidelity is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company is the administrator of the Plan. The Plan's administrator may designate other persons to carry out the day-to-day operations of the Plan. The Plan has an investment contract with Fidelity. Fidelity, as the Plan's broker, qualifies as a party in interest with respect to the investments managed by them; however, they are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments.

Fidelity provides certain administrative services to the Plan pursuant to an agreement between the Company and Fidelity, which amounted to \$7,288 and \$5,300 for the years ended December 31, 2024 and 2023, respectively. Fidelity receives revenue from mutual funds and other service providers for services provided to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative service to the Plan. If the revenue received by Fidelity exceeds the amount owed, Fidelity remits the excess to the Plan's trust on a quarterly basis. The Plan or the Company may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

The Company also paid other administrative fees for the Plan of \$16,000 and \$13,500 for the years ended December 31, 2024 and 2023, respectively.

6. TAX STATUS

The Plan has adopted a pre-approved defined contribution plan established by Fidelity. The pre-approved plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the pre-approved plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENT

Effective September 1, 2025, the Plan was amended to allow partial withdrawals for participants whose employment has been terminated and their account is distributable in accordance with the Plan.
