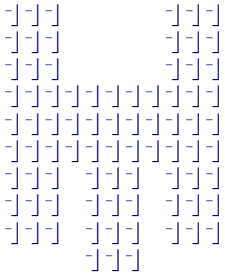

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
Mizner Country Club Retirement Plan  
Delray Beach, Florida

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mizner Country Club Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 27, 2024, and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024, to December 27, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mizner Country Club Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 27, 2024, and December 31, 2023, and for the period January 1, 2024 to December 27, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mizner Country Club Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mizner Country Club Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Mizner Country Club Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Mizner Country Club Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. **Description of Plan**

The following description of Mizner Country Club Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- a) *Merger* – On November 5, 2024, the Board of Governors of Mizner Country Club, Inc., the Plan Sponsor, adopted a resolution to merge the Plan with the Club Retirement Plan, a multi-employer plan sponsored by the Club Managers Association of America, Inc. (CMAA). Transfer of Plan assets started shortly after the Plan merger was approved with the final liquidation completed on December 27, 2024. As a result, the Plan has been effectively terminated on December 27, 2024.
- b) *General* – The Plan was a defined contribution plan covering all employees of Mizner Country Club, Inc. (the "Club"), except members of a collective bargaining unit, leased employees, and non-resident aliens, who had at least 500 hours of service to the Club in a six-month period. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 2013, and restated in its entirety on January 1, 2022, as required by the Internal Revenue Service's (IRS) restatement cycle. Effective December 27, 2024, the Plan transferred all assets to a Multiple Employer Plan sponsored by Club Management Association of America, Inc. and held with Empower Retirement. Following this transfer, the Plan ceased operations.
- c) *Plan Administration* – The Plan was administered by the Board of Governors of the Club and by My Benefits, LLC, a third-party administrator (TPA). The Plan's trustees were members and/or employees of the Club. As of December 27, 2024, and December 31, 2023, the custodian and the party that directed the custody and management of the Plan's assets was John Hancock Life Insurance Company (USA) (John Hancock).
- d) *Contributions* – Through December 27, 2024, participants could make pretax and/or Roth 401(k) contributions to the Plan of up to 100% of their annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. Participants could also contribute amounts representing distributions from other qualified plans. The Club, at its discretion, could make matching contributions and profit-sharing contributions. The Club contributed 25% of the first 6% of the employee elective deferral, as a matching contribution. For the period January 1, 2024, to December 27, 2024, the Club did not make any profit-sharing contributions.
- e) *Participant Accounts* – Each participant's account was credited with participant's contribution, the employer's matching contribution, and Plan earnings. In addition, participant accounts were credited with an allocation of employer non-matching contributions, and forfeitures of terminated participants' non-vested accounts.
- f) *Vesting* – Participants were immediately vested in their salary deferral contributions and rollovers, plus actual earnings thereon. Vesting in the Club's contributions was based on years of credited service. A participant became 100% vested in matching contributions after 1 year of credited service, and after 5 years for profit sharing contributions or immediately upon death or disability.

1. **Description of Plan, continued**

- g) *Administrative Expenses* – The Plan administrator elected to pay the administrative costs associated with Plan operations and compliance. Individual participants paid for loan fees, investment fees, assets charges, and associated expenses.
- h) *Investment Options* – Upon enrollment in the Plan, a participant could direct employee contributions in any of the investment options offered in the John Hancock programs and determined by the Plan administrator. Participants could change their investment options via phone or internet access to John Hancock at any time.
- i) *Participant Notes Receivable* – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their individual vested account balance. Loan transactions were treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms ranged from 1-5 years or up to 30 years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the loan administrator at the time the loan was taken (Prime Rate plus 1%). The interest rate on participant notes receivable as of December 31, 2023, ranged from 4.25% to 9.50%. Principal and interest were paid ratably through bi-weekly payroll deductions. Participant notes were reported at their unpaid principal balances plus any accrued interest. The loan balances were secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary.
- j) *Payments of Benefits* – Upon retirement, disability, death, or termination of service, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions were permitted for employees attaining age 59½. Hardship distributions were permitted from all accounts that were fully vested, except for Qualified Non-Elective Contribution accounts.
- k) *Forfeited Accounts* – Forfeitures on non-vested accounts could be used to reduce future employer contributions. Total forfeitures available as of December 27, 2024, and December 31, 2023, amounted to \$0. For the period January 1, 2024, to December 27, 2024, there were no forfeitures by employees.

2. **Summary of Significant Accounting Policies, continued**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies, continued**

- c) *Valuation of Investments and Income Recognition* – The Plan’s investments (mutual funds held in pooled separate accounts), before the transfer of assets to the MEO Plan, were valued at fair value as determined from quoted market prices, if available, of a national securities exchange on the last business day of the year. Investment options that did not have readily available market quotations were valued according to quotations from the custodian. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date.
- d) *Payment of Benefits* – Benefits were recorded when paid.
- e) *Plan Risk and Uncertainties* – Through December 27, 2024, the Plan and the Plan assets were sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Certain Plan investments were shares of mutual funds managed by the custodian. Change in the custodian’s management could have also affected operating results of the funds adversely. Additionally, the financial position of the Plan Sponsor, Mizner Country Club, Inc., could have had a significant impact on the Plan. Specifically, the ability of the Plan Sponsor to continue to make contributions to the Plan and/or the stability of the Plan Sponsor’s operations. Other external factors which could have affected the Plan, and the Plan assets include legislation or regulations established by the IRS, ERISA, and/or Department of Labor (DOL). Since all assets were transferred to the MEO Plan as of December 27, 2024, these risks no longer impact the Plan.

3. **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

**3. Fair Value Measurements, continued**

*Level 2 – Inputs to the valuation methodology include (continued):*

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input had to be observable for substantially the full term of the asset or liability.

*Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.*

The asset’s fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions provide the valuation methodologies used for assets measured at fair value before the transfer of assets to the MEO Plan:

- a) *Mutual funds held in pooled separate accounts* – Valued at quoted market prices of a national securities exchange on the last business day of the year, of units held by the Plan at year end.

**4. Information Certified by the Plan’s Custodian**

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, the custodian certified that the data included in the accompanying financial statements was complete and accurate. The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**5. Related Party Transactions**

Certain Plan investments included units of mutual funds held in pooled separate accounts managed by John Hancock Life Insurance Company (USA). John Hancock was the investment manager and custodian as defined by the Plan, during the period from January 1, 2024, to December 27, 2024, and therefore, these transactions qualified as party-in-interest transactions. However, they were not considered prohibited transactions in accordance with appropriate ERISA exceptions.

**6. Tax Status**

The Plan was utilizing a Non-Standardized Pre-Approved Profit Sharing Plan document (Profit Sharing Plan), provided by its TPA, My Benefit, LLC. The Profit Sharing Plan reflected the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Plan had received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan had been amended since receiving the opinion letter, the Plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan was qualified and was tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

**7. Plan Termination**

Although the Club intended the Plan to be permanent and continuing, the Club had the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants became 100% vested in their accounts, and accrued benefits, to the extent funded or required to be funded, must be distributed to the participants. Although the Plan was terminated, it was through a merger, not liquidation. Therefore, in addition to the assets being transferred to CMAA, the vesting percentages and requirements followed. For any employer contributions that were made to the Mizner Country Club Retirement Plan the existing vesting schedules were applied. As a result of the transfer, the Plan had no net assets available for benefits as of December 27, 2024, and these financial statements represent the final reporting period for the Plan.

**8. Subsequent Events**

The Plan's management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued, and determined no additional disclosures were required to be presented in these financial statements.
