Cargill Philanthropic Services, LLC 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the Margaret A. Cargill Philanthropic Services, LLC 401(k) (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Margaret A. Cargill Philanthropic Services, LLC (the “Company”). The Company is the administrator of the Plan. To be eligible to participate, an employee must have attained one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

In 2022, Minnesota Life Insurance Company (“Minnesota Life”) and Standard Insurance Company (“The Standard”) entered into a Reinsurance Agreement and other related agreements that transferred administrative, payment, and investment responsibilities with respect to certain insurance contracts from Minnesota Life to The Standard, on a coinsurance basis in the case of general account liabilities and on a modified coinsurance basis in the case of separate account liabilities. Pursuant to the agreements, The Standard is responsible for all administrative services, including the preparation and certification of the plan’s annual reporting on behalf of Minnesota Life. Minnesota Life remains the issuer and retains liability for the insurance contracts that are reinsured and administered by The Standard.

Contributions

Participants may contribute up to 100% of their gross annual compensation on a before-tax or Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company shall make a safe harbor matching contribution to the Plan on behalf of each participant who made contributions during the year in an amount equal to 100% of the first 5% of the participant’s contribution. The Company may make a discretionary matching contribution equal to a uniform percentage of each tier of each participant’s salary deferrals, not to exceed 4% of participants’ annual compensation. No discretionary matching contributions were made in 2024. The Company may also make a discretionary qualified non-elective contribution to the Plan on behalf of each participant who is an active employee on the last day of the Plan year. For the year ended December 31, 2024, the Company made a discretionary, non-elective contribution to the Plan for all eligible participants in the amount of 10% of eligible wages, which was remitted to the Plan in 2025.

Participant Accounts

Participants can direct the investment of their accounts on a daily basis into the investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions, Company contributions and allocations of the Plan’s earnings. Allocations of the Plan’s earnings to each participant’s account are based on account balances. The benefit to which a participant is entitled is the benefit that can be funded from the participant’s vested account.

The Plan holds a group variable annuity contract with Minnesota Life Insurance Company (a Securian Company) that offers participants the option to invest in underlying investments that provide both guaranteed income at retirement with additional market growth opportunity based on the performance of its underlying portfolio. The group variable annuity contract does not have any restrictions.

Vesting

Participants are immediately vested in their pre-tax or Roth salary deferrals plus actual earnings thereon. Participants are also immediately vested in the Company's safe harbor matching contributions and earnings thereon. Vesting in Company discretionary matching plus earnings is based on years of service, as are Participants' vesting in discretionary non-elective Company contributions plus earnings, according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms generally range from one to five years. However, if the loan is for the purchase of a primary residence, the Administrator may permit a repayment term up to what is currently available for a commercial home loan. The loans are generally secured by the participant's vested interest in the Plan and bear interest at fixed rates that are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through bi-weekly, monthly, or semi-monthly additions to participants' respective Plan accounts. Participants may only have one active general loan and one active residential loan at any one time.

Payment of Benefits

Upon termination of service due to termination, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, installment payments or an annuity as defined by the Plan. Active participants may also take distributions from the Plan for reasons of financial hardship or upon attainment of age 59 1/2. In-service withdrawals are subject to certain limitations.

Forfeited Accounts

Forfeitures result from non-vested Company contributions remaining in the Plan from terminated employees in accordance with the Plan agreement. Forfeitures are to first be used to pay administrative expenses under the Plan. To the extent that forfeitures are not used to pay administrative expenses under the Plan, forfeitures will be used to reduce Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5,444 and \$6,302, respectively. During the year ended December 31, 2024 and 2023, \$6,376 and \$9,312 were used to pay administrative expenses, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Fully Benefit-responsive Investment Contract

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Except for the Plan's investment option in the Minnesota Life Guaranteed Return Account (note E), the Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Investment gain / loss includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Net Appreciation (Depreciation) in Fair Value of Investments

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Plan Expenses

Participants are charged transaction fees for loan and withdrawal processing. The Company, at its discretion, pays substantially all other administrative expenses and record-keeping fees.

NOTE C - INVESTMENTS

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE D - FAIR VALUE MEASUREMENTS

Except for the Plan's investment option in the Minnesota Life Guaranteed Return Account (note E), the Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: The fair value of participation units held in the pooled separate accounts are based on the net asset value ("NAV") per unit, as a practical expedient, as provided by The Standard on behalf of Minnesota Life pursuant to reinsurance and administrative services agreements between Minnesota Life and Standard Insurance Company. The investment objectives of the pooled separate accounts are consistent with the investment objective identified in the names of the funds such as growth funds, bond funds, international funds, large cap funds, small cap funds, and specialty funds. Each separate account provides for daily redemptions by the Plan with no advance notice requirements and there are no unfunded commitments.

Plan assets and liabilities are measured at fair value using a three-level hierarchy for fair value measurements based upon the transparency of inputs to the valuation of an asset or liability. These levels are as follows:

Level 1 - Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 - Inputs, other than quoted prices, that are observable for the asset or liability either directly or indirectly, including inputs from markets that are not considered to be active.

Level 3 - Inputs that are unobservable.

All investments at fair value as of December 31, 2024 and 2023 were valued using NAV as a practical expedient and are not categorized within the fair value hierarchy.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides the Minnesota Life Guaranteed Return Account. Because this account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this account. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses, and is the amount the Plan participant will receive if he or she transfers or surrenders his or her funds out of the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include (1) transfers of assets from the fund into a competing investment option and (2) when total distributions and transfers in the fund exceed certain levels. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

NOTE F - INFORMATION CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company on behalf of Minnesota Life Insurance Company, the Plan's custodian, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE G - TAX STATUS

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code ("IRC") and, therefore, the related trust is tax-exempt. In accordance with Revenue Procedures 2010-6 and 2005-16, the Plan sponsor has determined that it is eligible, and has chosen, to rely on the current IRS prototype plan advisory letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments, all of which are indirectly owned through the Plan's group annuity contract, are units of pooled separate accounts or a guaranteed investment contract issued by Minnesota Life Insurance Company, d/b/a Securian, the custodian of the Plan's investments and managed by affiliates of Standard Insurance Company pursuant to reinsurance and administrative services agreements between Minnesota Life and Standard; therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from Plan participants qualify as party-in-interest transactions.
