**INDEPENDENT AUDITOR’S REPORT**

To the Administrators and Participants of the  
Solutionreach 401(k) Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Solutionreach 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). *General.* The Plan is a defined contribution plan. All employees who have attained age 18 and have completed 3 months of service are eligible for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan Management is responsible for oversight of the Plan.

*Contributions.* Employees are automatically enrolled in the Plan with a 3% deferral amount once eligibility requirements are met. Participants may elect to change their deferral amount at any time. The Company may, at its sole discretion, make a matching contribution to the Plan. During 2024, the Company matched employee contributions 50% up to 6% for a maximum matching contribution of 3%. For the year ended December 31, 2024, Company matching contributions totaled \$408,418. All contributions are subject to certain IRS limitations.

*Participant Accounts.* Each participant’s account is credited with the participant’s contribution and allocations of Plan earnings and charged with an allocation of administrative expenses related to recordkeeping. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting.* Participants are fully vested at all times in their own contributions and actual earnings thereon. Company contributions and earnings are subject to a graded vesting schedule based on years of service and are fully vested after four years of service.

*Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest at a reasonable rate of interest, determined by reviewing the interest rates charged for similar types of loans by other lenders. All loans are secured by the participant’s account and, regardless of term, become due and payable upon termination of the participant’s employment.

*Payments of Benefits.* Distributions and withdrawals are generally payable upon termination, financial hardship, total disability, death, or the attainment of the normal retirement age of 65. Distributions are made in a lump-sum payment. Participants are eligible to begin receiving distributions of all vested account balances when reaching 59½ years of age.

### 1. Description of Plan (continued)

For the year ended December 31, 2024, the Plan reported \$8,401,700 of Plan assets that were allocated to participants that had withdrawn from the Plan, but for which disbursement of funds from the Plan had not yet been made.

*Forfeitures Accounts.* At December 31, 2024 forfeited non-vested accounts totaled \$3. There were no forfeited non-vested accounts with a balance at December 31, 2023. Any remaining balances at each year end are eligible to be used to reduce future employer contributions or to pay Plan expenses. During 2024, \$6,060 of forfeited non-vested accounts were used to offset Plan expenses and \$41,968 were used to offset Company matching contributions.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting, consistent with accounting principles generally accepted in the United States of America.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**2. Summary of Significant Accounting Policies (continued)**

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Subsequent events*

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

**3. Certified Investments**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Bank (the trustee of the Plan).

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> <li>• quoted prices for similar assets or liabilities in active markets;</li> <li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>• inputs other than quoted prices that are observable for the asset or liability;</li> <li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li> </ul> If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Noninterest-bearing cash:* Valued at the account balance at year end.

*Mutual funds:* Valued at fair value based on quoted redemption values on the last business day of the Plan year.

*Common/collective trusts:* Pricing provided by various sources such as issuer, investment manager, fund accountant, client, etc., or default price if a price is not provided. Prices provided approximate fair value at year end.

*Stable value funds:* Valued at contract value, which approximates fair value at year end. Refer to Note 5.

**4. Investments at Contract Value**

At December 31, 2024, investment options in the Plan included the Standard Stable Asset A Fund (the “Fund”), available through a rider to Standard Insurance Company’s group annuity contract. The Fund is a general liability against Standard Insurance Company (“The Standard”) on the Plan’s behalf. There are no particular segregated or identifiable assets of The Standard ascribed to the Fund. Net deposits invested in the Fund become part of The Standard’s general account. Net deposits and interest credited become liabilities against The Standard on the Plan’s behalf.

Crediting rates for the Fund are set quarterly by The Standard using a process similar to that used by banks or other insurance companies for similar products. The Fund’s declared crediting rate will never be below 1% annually.

At December 31, 2024 and 2023, the contract value of the Fund was \$268,438 and \$198,561, respectively. At December 31, 2024 and 2023, the crediting rates were 3.04% and 2.78%, respectively, calculated as the percentage increase in the Fund’s NAV of the Fund over the plan year then ended.

### **5. Party-in-Interest Transactions**

Certain plan investments are shares of funds managed by Charles Schwab Bank, trustee, Certain plan investments are shares of a fund managed by The Standard Insurance Company, the custodian. Participant loan and distribution processing fees are paid by participants. The Plan paid certain fees from forfeited non-vested accounts. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **8. Tax Status**

In an opinion letter dated June 30, 2020, the Internal Revenue Service ruled that the Plan Volume Submitter Document qualifies under Section 401(k) of the Internal Revenue Code ("IRC") and is, therefore, not subject to tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor ("DOL"). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risks, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
