Independent Auditor's Report

To the Administrative Committee and Management of Sharecare, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sharecare, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sharecare, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes To Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following description of the Sharecare, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement and Summary for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 2011 as a defined contribution plan and is sponsored by Sharecare, Inc. (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On June 5, 2024, the Plan changed its custodian and recordkeeper. Nationwide Trust Company has been appointed to hold, control, and manage the assets of the Plan. Nationwide Trust Company has also been appointed to act as the recordkeeper of the Plan. Prior to June 5, 2024, Reliance Trust Company was appointed to hold, control, and manage the assets of the Plan as well as act as recordkeeper.

Participation

Employees are eligible to make elective deferrals and to receive employer matching contributions after attaining the age of 18 and upon completion of 3 months of service.

Contributions

Contributions to the Plan may come from employee salary reduction contributions and rollover amounts from other qualified retirement plans, employer matching contributions, and employer profit-sharing contributions. If an employee elects to participate in the Plan, he or she may contribute through salary deferrals up to 99% of compensation on a pre-tax or after-tax Roth basis in any Plan year, subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Company makes matching contributions of 50% of the first 5% of the Participant's compensation that a Participant contributes to the Plan, not to exceed \$2,300. The matching employer contributions are invested in the same manner as the Participant's elective deferrals. The employer matching contributions totaled \$1,288,830 in 2024.

The Company may elect to make an employer profit-sharing contribution. No profit-sharing contributions were made for 2024.

Participants may also rollover amounts from qualified retirement plans into their accounts. Rollover amounts from other qualified plans totaled \$1,087,313 in 2024.

The Plan records employer and employee contributions receivable when compensation is paid. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

NOTE 1.**DESCRIPTION OF PLAN (CONTINUED)****Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of plan administrative expenses based on the value of their account balances. Investment management expenses are based on the value of the participant account balances. Other administrative expenses are based on the number of participants in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their own contributions and the investment earnings thereon. Employer matching and profit-sharing contributions and earnings thereon are vested according to the following schedule:

Allocation of Plan Income Earned

Net income earned and unrealized gains or losses on investments are allocated to a participant's account based on the ratio that the individual account bears to all participants in the same investment as of each valuation date. Accounts are valued on a daily basis.

Investments

All contributions are deposited into investment funds administered and managed by Nationwide Trust Company. Each participant makes a selection as to how his or her contribution is allocated among the funds. The general investment policy of the funds is established by the Custodian.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balances with a minimum loan request of \$1,000 and a maximum of \$50,000 reduced by the excess (if any) of: (i) the highest outstanding balance of loans from the Plan during the twelve (12) month period ending on the day before the loan is made, over (ii) the outstanding balance of loans from the Plan on the date the loan is made. Loan terms may not exceed five years except when used for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear an annual interest rate of prime plus 1%. The interest rate is fixed on the day the loan is processed and will remain constant during the term of the loan. Principal and interest are paid ratably through payroll deductions.

The initial loan application fee is \$100, which is deducted from the Participant's account balance in the Plan and will not reduce the proceeds of the loan.

Hardship Withdrawals

A participant may elect to withdraw the balance of their account attributable to their salary reduction amount provided such withdrawal is to meet their immediate and significant needs.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Upon a participant's death, disability, normal retirement, or other termination of employment from the Company, a participant may elect to receive the value of the vested interest in his or her account as a lump sum distribution.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants as soon as possible after December 31, 2024.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,296 and \$339,369, respectively. These amounts may be used to pay Plan expenses or reduce employer matching contributions. Forfeitures totaling \$12,500 and \$210,429 were used to pay Plan expenses and reduce employer contributions in 2024.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. Mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on a cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses for maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

NOTE 3. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement according to accounting literature establishes a fair value hierarchy that prioritizes the use of observable inputs in measuring fair value. The level of a fair value measurement is determined entirely by the lowest level input that is significant to the measurement.

The three levels are:

Level 1 – Quoted prices in active markets for identical assets or liabilities, accessible to the entity at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 – Unobservable inputs that are not corroborated by market data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds and mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments were managed by the custodians as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Certain administrative fees related to the administration of the Plan, including advisory services, were paid by the Plan which totaled \$222,527 in 2024.

NOTE 6. PLAN TERMINATION

While it is the Company's intention to continue the Plan indefinitely, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the Plan Agreement. In the event of Plan termination, no such action may deprive any participant or beneficiary under the Plan of any vested right.

NOTE 8. SUBSEQUENT EVENTS

The Plan sponsor has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

NOTE 9. TAX STATUS

The Company adopted a prototype standardized profit-sharing plan with a cash deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on October 6, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable provisions of the Internal Revenue Code.

Participants in the Plan are not subject to income taxes on their contributions, earnings, or appreciation on investments held in the Plan until withdrawn by the participant or distributed to the participant's named beneficiary in the event of death.

NOTE 10. RISKS AND UNCERTAINTIES

The Plan's participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances.
