1. Plan Description

The following description of the Accurus Aerospace Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible full-time employees of Accurus Aerospace Corporation (the "Company" or "Employer") and other participating affiliates (Accurus Aerospace Tulsa, LLC fka Precise Machining & Manufacturing, LLC; Accurus Aerospace Athens, LLC fka McCann Aerospace Machining, LLC; Accurus Aerospace Kent, LLC fka La Croix Industries, LLC and Accurus Aerospace Wichita, LLC fka ZTM Aerospace, LLC, Ferra Aerospace Inc.) who are 21 years of age or older and have at least 60 days of service. Residents of Puerto Rico, interns, temporary employees and seasonal employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In April 2023, assets amounting to \$1,869,435 were transferred to the Plan from the Ferra Aerospace Inc. 401(k) Plan.

Contributions

Each year, participants may contribute up to 90% of their annual eligible compensation on a pre-tax or after-tax (Roth) basis, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an QACA auto-enrollment provision whereby all newly eligible employees are automatically enrolled. Unless a participant elects otherwise, the Plan provides for QACA automatic enrollment at a contribution rate of 3% of a participant's eligible compensation and will increase each year by 1% up to a maximum of 6% of a participant's eligible compensation.

The Employer will make a QACA enhanced safe-harbor matching contribution to the Plan equal to 100% of a participant's elective deferrals up to that do not exceed 2% of their eligible compensation, plus 50% of a participant's elective deferrals that exceed 2% of the participant's eligible compensation but do not exceed 6% of their eligible compensation. The Employer may also make a discretionary matching or non-elective contribution to the Plan for employees employed on the last day of the Plan year. For the 2024 plan year, no discretionary matching or non-elective contributions were made to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description (*continued*)

Vesting

Participants are fully vested in their contributions plus actual earnings thereon. Vesting in Company matching and discretionary contributions is based on years of continuous service. A participant is 100% vested in the Company's QACA enhanced safe-harbor matching contributions after two years of credited service. Vesting in Company discretionary matching and non-elective contributions are based on years of continuous service as follows:

Forfeitures

If a participant terminates employment and is less than 100% vested in their Employer safe-harbor matching or discretionary matching or non-elective contributions, the participant will forfeit the non-vested portion of their account. The Company uses forfeited non-vested amounts to pay Plan expenses. Any remaining amounts will be used to reduce Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,505 and \$52,542. During 2024, forfeitures of \$129,418 were used to reduce Employer contributions and \$10,245 was used to reduce Plan expenses from forfeited non-vested accounts.

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of 50% of a participant's vested account balance or \$50,000, subject to the approval of a loan application. Participants may not have more than two loans outstanding at any time. The interest rate will be prime rate plus 2%. Loans are repaid through payroll deductions within a five-year period, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a thirty-year period.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("US GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to US GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is valued at contract value. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The common/collective trusts are valued at the NAV, as provided by the trustee, which is used as a practical expedient for fair value based on the fund's underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies *(continued)*

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of maintaining the Plan may be paid by the Company and excluded from these financial statements, or the Plan, at the Employer's discretion. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 8, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, qualified institutions.

The Plan had investments in a benefit-responsive group annuity contract, which is stated at contract value. The group annuity contract amounted to \$107,273 and \$187,272 at December 31, 2024 and 2023.

5. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the "PFIGO") is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant's account balances. This net crediting rate is after a deduction of fees for administrative and record-keeping services provided to the Plan. The rate is reset on a semiannual basis.

5. Group Annuity Contract (*continued*)

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for Plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination. An employer level liquidation or employer initiated transfer of the Plan's interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the Employer chooses. Notification of a Plan's intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. If this scenario occurs, the surrender charge will be billed to the Employer.

6. Common/Collective Trusts

The Plan offers non benefit-responsive common/collective trusts called the Brandywine Target Funds (the "Funds"). These Funds include: the Brandywine Target 2030; Brandywine Target 2040; Brandywine Target 2050; Brandywine Target 2060 and Brandywine Target Retirement. In addition, the Plan holds common/collective trusts with Summit called: Summit SmallCap Growth Founders and Summit LargeCap Growth Founders. The unit value of each of these Funds is determined on a daily basis. Units are issued and redeemed daily at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. There are no unfunded commitments on the Funds at December 31, 2024 and 2023.

7. Party-In-Interest Transactions

Certain investments of the Plan are managed by Principal Life Insurance Company, Principal Trust Company, or Principal Global Investors Trust Company, all of whom are members of Principal Financial Group. Principal Life Insurance Company and Principal Trust Company are trustees as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

A separate account is maintained by the Principal Life Insurance Company which receives payments from the Principal Life Insurance Company pursuant to a written agreement with the Employer. Under the agreement, the Employer can use the amounts in the account to pay for administrative expenses incurred by the Plan. The account is not considered a Plan asset since any unused amounts on or before March 15th following the calendar year in which the amount was received reverts back to the Principal Life Insurance Company. These transactions are considered allowable party-in-interest transactions. Administrative expenses of \$39,272 were paid from this account during 2024.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

9. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

10. Prohibited Transactions

During the 2023 Plan year and prior, the Employer failed to remit to the Plan certain participants' contributions and loan repayments within the period described by the Department of Labor regulations. Delays in remitting the contributions and loan repayments to the Plan were due to administrative oversight. The Employer is in the process of calculating and remitting lost earnings for the delinquent participant contributions and loan repayments of \$46,031.

11. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
