Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ambulatory Medical Practices Management Services Organization, Inc. 401K Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements
December 31, 2024

1. Description of Plan

The following description of the Ambulatory Medical Practices Management Services Organization, Inc. 401K Plan (the "Plan") is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Ambulatory Medical Practices Management Services Organization, Inc. (formerly CCW Management Corp.), Medical Reimbursements Associates, and Hudson Heart Management, LLC (the "Employer" or "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

All employees who have attained 21 years of age and have completed 30 days of service are eligible to participate in the Plan on the first day of the month immediately following the completion of the eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 4% of their eligible compensation. The amount will be contributed on a pre-tax basis. Each year, the deferral rate will be automatically increased by 1% until the participant reaches 10% of their eligible compensation.

The Employer may make a discretionary matching contribution equal to a percentage of a participant's elective deferrals up to a percentage of their eligible compensation. For the 2024 plan year, the Employer made a discretionary matching contribution equal to 50% of a participant's elective deferrals up to 2% of their eligible compensation.

The Employer makes a safe harbor contribution for eligible participants equal to 100% of the first 3% of the participant's eligible compensation contributed to the Plan.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is 100% vested in their contributions as well as the employer's safe harbor contribution plus allocated earnings thereon at all times. Participants are vested in the Employer's discretionary contribution portion of their accounts after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined by the Plan administrator. A participant may only have one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years unless for the purpose of a principal residence whereby they are repayable over a period not to exceed ten years.

Payment of Benefits

In-service withdrawals are permitted in the case of demonstrated financial hardship or after attaining age 59½. Upon termination of service, a participant may elect to receive a lump sum amount equal to the value of his or her vested account. In the event of death of the participant, the value of the account will be paid to the spouse or other named beneficiary in a lump sum. In the event of termination for any reason other than retirement, death or disability, the vested account balance will also become distributable to the participant.

Forfeited Accounts

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to: reduce Plan expenses; reduce future Employer contributions; or allocate back to participants. At December 31, 2024 and 2023, forfeited accounts totaled \$21,578 and \$12,331. During 2024, \$36,128 of forfeitures were used to pay certain plan expenses and \$244 of forfeitures were used to reduce Employer contributions. No forfeitures were allocated back to participants.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. The group annuity contract is valued at contract value, which represents contributions, plus earnings, less participant withdrawals and administrative expenses. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily Net Asset Value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases making loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 9, 2025.

3. Information Certified (Unaudited)

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required schedule, Schedule H, Part IV, Line 4i- Schedule of Assets (Held at End of Year), including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

4. Investments (*continued*)

The group annuity contract, which is valued at contract value, amounted to \$6,626,375 and \$6,306,458 at December 31, 2024 and 2023.

5. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the "PFIGO") is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO. Contract value represents contributions, plus earnings, less participant withdrawals and administrative expenses.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant's account balances. The rate is reset on a semiannual basis.

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A1 as of November 2024), S&P Global (A+ as of November 2024), A.M. Best Company (A+ as of November 2024) and Fitch Ratings (AA- as of November 2024).

6. Party-in-Interest Transactions

Certain investments of the Plan are managed by Principal Life Insurance Company, a member of Principal Financial Group, or Principal Global Investors, an indirect subsidiary of Principal Financial Group. Principal Trust Company, the trustee of the Plan, is also a member of Principal Financial Group. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Tax Status

The IRS has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

7. Tax Status (*continued*)

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
