NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Management Consulting, Inc. Health and Welfare Plan –Two (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General: The Plan provides health and other benefits to eligible employees of Mancon, LLC (“Company”) and their covered dependents or designated beneficiaries in the event of death, illness, medical expense, hospitalization, or similar occurrences. The Plan covers certain employee classes of the Company. The remaining employee classes are covered under a separate plan that provides benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits: The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, and accidental death and dismemberment (AD&D) benefits to full-time employees of the Company who have completed at least 30 days of service. Part-time employees (those with less than 30 hours of service per week) are eligible for medical benefits only. All eligible employees are automatically enrolled in the Plan for employee-only coverage. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). No benefits are extended to retired employees.

Insured benefits: The Plan fully insures the benefits for life insurance, vision, and AD&D. Premiums are paid to the insurance company from the assets of the trust.

Stop-Loss Coverage: The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-insured benefits: All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under an administrative services-only (ASO) arrangement. The claims processor pays claims directly to or on behalf of participants and is then reimbursed by the Plan’s trust account. Despite the Plan’s utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

Contributions: The Company contributes the full cost of life insurance, AD&D, vision, and stop loss insurance premiums. Employees may contribute specified amounts, determined periodically by the Plan, to extend health coverage to their spouse and eligible dependents, based on Plan provisions. The Company makes contributions to the Plan as needed to fund healthcare claims or fees in excess of participants’ contributions. Any deficiency of the Plan’s net assets over current benefit obligations is funded by the Company on a pay-as-you-go basis.

2. Summary of Accounting Policies

Basis of accounting and Use of Estimates: The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Premiums paid by the trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claims payments are recorded when submitted to the Plan for reimbursement by the third-party claims processor. Liabilities for healthcare claims submitted directly to the third-party claims processor by covered participants as of December 31, 2024 and 2023 but not paid until subsequent to that date, are included in the accompanying statements of benefit obligations.

Cash: The Plan's cash balance at December 31, 2024 and 2023 includes an aggregate bank balance of \$167,740 and \$165,676, respectively, on deposit with a federally insured depository institution, which is subject to the \$250,000 Federal Deposit Insurance Corporation ("FDIC") insurance limit.

Stop-Loss: Premiums paid for stop-loss insurance are included in the accompanying statement of changes in net assets available for plan benefits. No stop-loss refunds were received by the Plan for the year ended December 31, 2024.

Rebates: Refunds from the Plan's PBM are recorded when received by the Plan. Pharmacy rebates totaling \$434,655 have been netted with healthcare claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Subsequent Events: The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. Claims Incurred but not Reported

Plan obligations at December 31, 2024 and 2023, for healthcare claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and professional fees related specifically to the Plan. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

5. Tax Status

The Plan has not applied for a determination from the Internal Revenue Service (IRS) that it is exempt from income tax. However, the Plan's management and the Plan's tax counsel believe that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code and the Plan's income qualifies as tax-exempt based on the restrictive nature of its use. The plan administrator believes that the Plan is being operated in compliance with the applicable requirement of the Internal Revenue Code and, therefore, believes the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to or contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

In the event of termination, all previous contributions made by the Company shall continue to be used for the purpose of paying benefits under the provisions of the Plan with respect to claims arising before such termination; or shall be used for the purpose of providing similar health benefits to covered participants until all such contributions are exhausted.

7. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
