Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Blue Matter Consulting 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Blue Matter Consulting 401(k) Plan's internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 - Description of plan

#### General

Effective January 1, 2013, Blue Matter Consulting, LLC. (the "Company", "Plan Administrator", and "Plan Sponsor") adopted a defined contribution 401(k) and profit sharing plan (the "Plan") covering all eligible employees who are age 21 or older.

On September 29, 2023, the Company transferred Plan assets to a new trustee and custodian and the Plan's recordkeeping function to a new third-party administrator. Plan assets transferred to the new custodian were mapped into funds comparable to those offered by the former custodian. The Plan was amended and restated effective as of October 1, 2023. Unless otherwise noted in the disclosures below, the key plan provisions in the newly adopted Plan Document remain comparable to the previous Plan Document.

Subsequent to the year ended December 31, 2024 and effective January 1, 2025, the Plan was amended to add Sam Brown LLC, a wholly owned subsidiary of Blue Matter Consulting, LLC's parent company, as a participating employer and to exclude interns and seasonal employees from eligible participants.

The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions and the adopting employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Administration

The Company has appointed an Investment Committee (the "Committee") to manage the operations and administration of the Plan. From January 1, 2023 through September 14, 2023 the Plan contracted with Plan Administrators, Inc. and PAi Trust Company, Inc. (collectively "PAi") to act as the trustee, custodian, and third-party administrator, responsible for processing Plan transactions, maintaining participant records, and monitoring compliance with governmental regulatory requirements. In 2022, PAi merged with Ascensus. On September 15, 2023, the Plan converted to the Ascensus recordkeeping platform, assigning and transferring the Plan assets to Ascensus Trust Company. Ascensus Trust Company contracted with Ascensus LLC (collectively, "Ascensus") to provide administrative and recordkeeping functions. Effective September 30, 2023, the Company contracted with Fidelity Management Trust Company to act as the trustee and custodian. Fidelity Management Trust Company contracted with Fidelity Workplace Services, LLC to act as the administrative and recordkeeping agent. Fidelity Management Trust Company and Fidelity Workplace Services, LLC (collectively, "Fidelity") process and maintain participant data and accounting records, and monitor compliance with governmental regulatory requirements. During 2024 and 2023, the Company also contracted with Forest Capital Management, LLC to provide advisory and investment consulting services.

#### Contributions

Participants may elect to defer up to 100% of their annual gross compensation as defined in the Plan Document. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds and self-directed brokerage accounts to its participants. The Plan allows Roth contributions and Roth rollover contributions into the Plan.

### Note 1 - Description of plan (continued)

#### Contributions (continued)

Through September 29, 2023, the Plan had an auto-enrollment provision whereby all newly eligible employees were automatically entered in the Plan with their deferral rate set at 4% of eligible compensation unless they affirmatively elected not to participate in the Plan. Their contributions were invested in a designated balanced fund until changed by the participant. The adoption of the new Plan Document on October 1, 2023, removed the auto-enrollment provision.

The Plan utilizes a “safe harbor” design under the IRS 401(k) plan regulations in which employee pre-tax and employer safe harbor matching contributions are not subject to discrimination testing. The Plan Sponsor makes a safe harbor contribution of 100% of the first 4% of eligible compensation contributed by participants. The Plan also allows for additional employer discretionary matching contributions and employer non-elective discretionary contributions. Employer safe harbor contributions for the years ended December 31, 2024 and 2023 were \$1,210,194 and \$1,049,867, respectively. There were no additional discretionary or non-elective discretionary employer contributions. Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions, Plan Sponsor matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions, the employer safe harbor contributions, plus actual earnings thereon. Vesting in employer discretionary contributions and employer non-elective discretionary contributions, and any earnings thereon, is based on years of continuous service. Participants become 100% vested upon the completion of three years of qualified service. Employees become 100% vested in the employer portion of their accounts upon retirement, death or disability, as defined in the Plan Document.

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in the Participant's account during the prior twelve-month period. For loans qualifying under the Disaster Tax Relief and Airport and Airway Extension Act of 2017, Tax Cuts and Jobs Act of 2017, and the Bipartisan Budget Act of 2018, or for loans qualifying under the Coronavirus Aid, Relief, and Economic Security Act the dollar limit may be increased to \$100,000 or 100% of the participant's account balance and loan repayment may be delayed for one year for a qualified individual within the applicable time periods.

#### Notes receivable from participants (continued)

The loans are secured by the balance in the participant's account and bear an interest rate commensurate with the rates available for similar loans from commercial lending institutions, which remains fixed during the entire period of the note. The interest rate for loans outstanding as of December 31, 2024 ranged from 4.25% to 8.50%. Loan terms range up to five years or may exceed five years for the purchase of a primary residence. Through September 29, 2023, there was no limit to the number of outstanding loans a participant could have. Effective October 1, 2023, the newly adopted Plan provisions limit the number of loans outstanding a participant may have only one outstanding loan at any time. Principal and interest are paid ratably through payroll deductions.

#### Payment of benefits

Upon reaching the age of 59½ and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Upon termination, if the participant's or beneficiary's vested account balance is \$5,000 or less, the Plan allows the trustee to distribute the vested account balance to an Individual Retirement Account ("IRA") for the participant's benefit. This limit increased to \$7,000 or less effective January 1, 2024 as a result of the increase in the statutory limit per Internal Revenue Code (IRC) Section 411(a)(11)(A). Vested balances of \$1,000 or less will be distributed as a lump-sum amount without the participant's consent.

#### Forfeiture accounts

Forfeiture accounts consist of overpayments of employer safe harbor matching contributions and may first be used to pay Plan expenses. Any remaining amounts can be used to reduce employer contributions. Forfeitures in the amount of \$39,380 for the year ended December 31, 2024 were used to reduce employer contributions. No forfeitures were used to reduce employer contributions in 2023. The forfeiture account balances were \$811 and \$37,665, respectively, as of December 31, 2024 and 2023.

### Note 2 - Summary of accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Note 2 - Summary of accounting policies (continued)

#### Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was deemed necessary by the Plan Sponsor based on an assessment of the outstanding notes receivable from participants at December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Document.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan and investment advisory service expenses are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees paid by the Plan for investment fund expenses are included as a reduction of the return earned on each investment fund and charged to participant accounts. The Plan's investment advisor receives fees calculated as a percentage of the plan's asset value, which was paid directly by the Plan Sponsor in 2024 and 2023.

From January 1, 2023 through September 29, 2023, fees related to the administration of notes receivable from participants, issuance of benefit payments, and custodial fees at seven basis points of total plan assets, and monthly recordkeeping fees, were charged directly to the participant's account. Effective October 1, 2023, fees related to the recordkeeping and administration services are calculated at 14 basis points of total plan assets, charged quarterly to participant's accounts, and fees related to the administration of notes receivable from participants and issuance of benefit payments are calculated as flat fees charged directly to the participant's account. All such fees are reflected in administrative expenses of \$21,502 and \$14,551, respectively, for the years ended December 31, 2024 and 2023.

Pursuant to a revenue sharing agreement with Fidelity, the Plan receives revenue from mutual fund service providers for services Fidelity provides to these funds. This revenue may be used to offset certain amounts owed to Fidelity for its administrative services to the Plan or allocated to applicable participant accounts.

#### Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by PAi, a qualified institution and the trustee and custodian of the plan from January 1, 2023 through September 14, 2023, by Ascensus, a qualified institution and the trustee and custodian of the plan from September 15, 2023 through September 29, 2023, and by Fidelity, a qualified institution and the trustee and custodian of the plan from September 30, 2023 through December 31, 2024.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in money market and mutual funds are valued at the daily closing price as reported by these funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV), and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Self-directed brokerage accounts are valued on the basis of readily determinable market prices of the underlying investments.

### Note 4 - Fair value measurements (continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

No assets were noted at Levels 2 and 3 for the years ended December 31, 2024 and 2023.

During 2024, rollover contributions of \$567,472 came from other plans and related to nine participants. During 2023, rollover contributions of \$585,980 came from other plans and related to eight participants.

### Note 6 - Related party transactions and party-in-interest transactions

Certain plan investments in shares of mutual funds were managed by PAi for the period January 1, 2023 through September 14, 2023, by Ascensus from the period of September 15, 2023 to September 29, 2023 and by Fidelity starting September 30, 2023. PAi, Ascensus and Fidelity were trustees and custodians for those respective periods and, therefore, these transactions qualify as party-in-interest transactions.

Refer to **Note 2 - Expenses** for expenses of the Plan paid by the Plan Sponsor and the Plan participants to the parties-in-interest. All these transactions are considered party-in-interest transactions under ERISA regulations, but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan Document to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### Note 8 - Tax status

The Internal Revenue Service has determined and informed Fidelity by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan's third-party administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement date and through the date of issuance of the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks related to geopolitical tensions, economic instability, and changes in international trade policies, including the imposition of new tariffs, could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Note 10 - Plan compliance matters**

During the year ended December 31, 2023, it was discovered that the definition of eligible compensation was not consistently applied for calculating employee deferrals on the bonuses paid in March 2023. Plan management corrected the error in 2024. The effect of this error is recognized in 2024 when the corresponding qualified non-elective contribution was funded by the Plan Sponsor.

The Plan Sponsor's fidelity bond on behalf of the Plan was not in compliance with ERISA requirements at December 31, 2023. Management has corrected this noncompliance by procuring an ERISA bond conforming to ERISA requirements in October 2024 and does not believe that this matter has a significant impact on these financial statements.
