Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Heritage 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1) Summary of Significant Plan Provisions

The following description of Heritage 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees (excluding union, nonresident aliens, key and highly compensated as well as leased employees) of Heritage Hotels and Resorts, Inc. (the “Employer”) who have completed one month of service. Participation commences as soon as administratively feasible after meeting the eligibility requirements. The Plan was established January 1, 2021, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan provides for employee contributions pursuant to a tax-deferred savings agreement. Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan, as well as after-tax Roth contributions, not to exceed annual limits set by the Internal Revenue Code. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions.

Discretionary employer matching or profit-sharing amounts may be contributed at the discretion of the Employer for eligible employees who are employed on the last day of the plan year. In no event shall the aggregate of Employer tax-deferred contributions, matching contributions, and profit-sharing contributions, exceed the amount allowable as an employer deduction for income tax purposes. The Employer made a discretionary matching contribution for 2024 and 2023 of 25% of the employee’s deferrals for a total of \$123,249 and \$96,169, respectively.

Additionally, the employer made a QNEC through the DOL VFCP program for missed employee contributions for 2023 which resulted in additional employer contributions of \$14,728.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, an allocation of any Employer discretionary contributions, and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

The Plan does not allow for loans to be made to participants.

Vesting

Participants are immediately vested in their contributions, plus earnings thereon.

Vesting in the Employer's discretionary matching and profit-sharing contribution portion of their accounts plus earnings thereon is based on years of service, as defined by the Plan. Employer discretionary matching and profit-sharing contributions vest according to the following schedule:

Forfeitures

Forfeitures available for allocation under the Plan are applied to reduce the amount of Employer contributions otherwise committed for the Plan year or to pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,022 and \$5,795, respectively.

For the year ended December 31, 2024, \$11,022 in forfeitures was used to offset the employer contribution receivable and related employer contributions. No forfeitures were used to offset the employer contribution and no administrative expenses were paid from forfeited nonvested accounts for the year ended December 31, 2023.

Investment Options

Upon enrollment in the Plan, participants direct the investment of all contributions in a variety of investment options offered by the Plan. Participants may change their investment options daily.

Payments of Benefits

Benefits are payable in the event of retirement, disability, death, attainment of age 59½, or termination of employment. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants are also allowed to withdraw from their accounts in the event of undue financial hardship.

Mandatory Cash-Out Provision

If the amount of the participant's vested account balance to be distributed exceeds \$1,000 but is less than or equal to \$5,000 and the participant fails to elect a lump sum payment or direct rollover to a participant designated Individual Retirement Account (IRA), the Plan administrator will roll the entire vested balance to an IRA. Account balances of less than \$1,000 will be distributed as a lump-sum amount without the consent of the participant. The Plan's administrative policy states that a terminated participant is entitled to a distribution as soon as administratively feasible.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation (depreciation) in fair value of investments consists of both the realized gains or losses and unrealized appreciation (depreciation) of those investments.

Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of plan administration. Certain of the Plan's administrative expenses are paid by the Employer, which are excluded from these financial statements. At any time, the Employer may elect for the Plan to pay administration costs. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through October 8, 2025, the date which the financial statements were available to be issued.

3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2* Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – The net asset value (NAV) of pooled separate accounts (PSA) is based on unit values reported by the Plan custodian as determined by the investment manager based on the fair value of the underlying assets net of liabilities divided by the number of outstanding units of the trust on its valuation date. Management has determined that the investments using NAV as a practical expedient do not have published prices and; therefore, the investments are not assigned a level in the fair value hierarchy.

For the years ended December 31, 2024 and 2023, the Plan had no investments valued at fair value based on the fair value hierarchy. The investments measured at NAV as of December 31, 2024 and 2023, were \$1,644,222 and \$914,931, respectively.

5) Plan Termination

Although it has not expressed an intent to do so, the Employer, as the Plan’s sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6) Tax Status

The Plan is operating under a prototype document with a nonstandardized adoption agreement. The Internal Revenue Service has determined and informed the Plan sponsor by letter dated June 30, 2020, that the prototype plan, as then designed, is in compliance with applicable sections of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype sponsor. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan's administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's first income tax filing was for December 31, 2021.

7) Related-Party and Party-in-Interest Transactions

Certain Plan assets are shares of pooled accounts managed by John Hancock Life Insurance Company, the custodian of the Plan. These transactions qualify as exempt party-in-interest transactions.

The Employer provides certain accounting and administrative services to the Plan for which no fees are charged. For the years ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses amounted to \$36,914 and \$23,604, respectively.
