## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Schlotterbeck & Foss 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

#### Note 1. Description of Plan

The following description of the Schlotterbeck & Foss 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as most recently amended effective January 1, 2024, for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan which was established in 1978 for the benefit of eligible employees of Schlotterbeck & Foss (the Company).

**Eligibility:** Employees who are 18 years of age are eligible to participate in the Plan. Eligible participants may enter the Plan on the first day of the quarter coinciding with or the next following date that eligibility requirements are met. Those who defer compensation to contribute to the Plan are eligible to receive Company matching and discretionary profit sharing contributions, if any, immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** A participant may elect to make before-tax contributions or Roth, after-tax contributions up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants are allowed rollover contributions from other qualified defined benefit or contribution plans.

Company matching contributions may be made at the discretion of the Company in a tiered format. Such amounts are credited among the accounts of participants who have made employee deferral contributions during the year. For the year ended December 31, 2024, the match contribution for all participants was equal to 50% of each participant's deferral contribution up to the first 6% of the participants' eligible compensation.

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant contributions are withheld from compensation.

A Company profit sharing contribution may be made at the option of the Company's Board of Directors from the Company's pre-tax profits. There were no profit sharing contributions during the year ended December 31, 2024. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions and Company matching contributions, if any, and receives an allocation of the Company's profit sharing contribution, if any, and plan earnings, and is charged with an allocation of administrative expenses. The Company's discretionary profit sharing contribution is allocated equally among eligible participants in the Plan, if applicable. Allocations of plan earnings and expenses are based on participants' account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant vests 30% after one year of service, 60% after two years of service and the participant is fully vested after three years of credited service. In the event of death, disability or retirement at designated ages, participants become fully vested.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions into a variety of investments as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Forfeitures:** Forfeitures of terminated participants' non-vested accounts may be used to reduce Company contributions or pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited amounts approximated \$5,894 and \$17,500, respectively. During the year ended December 31, 2024, the Company used approximately \$24,000 of forfeitures to reduce Company contributions.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000, reduced by the greatest note balance outstanding during the prior 12 months, or 50% of their vested account balance. A participant may only have one note outstanding at any given time. Note terms range from one to five years and may be extended up to 15 years if the note is for the purchase of a principal residence. The notes are collateralized by the balance in the participant's account and bear interest at the prime rate (at the time of loan origination) plus 2%. Interest rates ranged from 5.25% to 10.50% at December 31, 2024. Principal and interest payments are paid through payroll deductions.

**Payment of benefits:** Benefits under the Plan are payable to participants or their beneficiaries upon death, retirement, disability or termination of employment. Benefits are payable in a lump sum or by other methods as described in the Plan's literature. Participants may make withdrawals from their account balances upon reaching age 59-1/2, or by determination that a financial hardship, as defined, has been incurred.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Defaulted notes are treated as distributions based upon the terms of the plan document.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to plan administration are charged directly to participant accounts and are included in administrative expenses.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for recognition and/or disclosure through October 9, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified and Provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Custodians

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodians and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodians that the information certified and provided to the Plan Administrator by the custodians related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule, related to the following assets and income:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

**Shares of common/collective trust:** Shares of common/collective trust are valued based on the NAV of shares of common/collective trust held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### **Note 5. Guaranteed Portfolio Fund and Fully Benefit-Responsive Contract**

In 2012, the Plan entered into an unallocated fixed annuity Key Guaranteed Portfolio Fund guaranteed investment contract with Empower Annuity Insurance Company of America (Empower), which is an AA rated company. Empower maintains the contributions in a general account. The account is credited with earnings on the investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events limit the ability of the Plan to transact at contract value with the issuer. Participants should refer to the investment contract for a list of such events. The Plan Administrator does not believe that the occurrence of any such value event which would limit the Plan's ability to transact at contract value with participants, is probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise. There are no contract termination clauses or charges applied upon discontinuance to terminate the agreement prior to the scheduled maturity date. The contract value of investment contracts as of December 31, 2024 and 2023, was \$78,545 and \$88,188, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. There is no required crediting interest rate for the investment contract. At December 31, 2024 and 2023, the interest rate for the investment contract was 1.41% and 1.23%, respectively.

#### **Note 6. Related-Party and Party-In-Interest Transactions**

The Plan's investments are held by and managed by Empower, the custodian; therefore, these transactions qualify as party-in-interest transactions. Empower and TPA Experts. provide administrative and advisory services to the Plan. Total administrative expenses paid by the Plan amounted to \$54,715 for the year ended December 31, 2024.

Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan. Certain other administrative expenses of the Plan are paid by the Company. These amounts are not material to the financial statements.

#### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company may discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **Note 8. Income Tax Status**

The Plan has adopted a non-standardized form of a prototype plan sponsored by TPA Experts. The prototype plan provider has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since the prototype plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

#### Note 8. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
