To the Participants and Plan Administrator of the LivePerson, Inc. 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the LivePerson, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan was adopted on January 1, 2012 and most recently amended and restated effective July 15, 2021. The Plan is a defined contribution plan covering all eligible employees of LivePerson, Inc. (the “Company” or “Employer”). Non-eligible employees (“excluded employees”) are those covered by a collective bargaining agreement, non-resident aliens who have no earned income from sources within the United States and interns. An employee is eligible to participate in the Plan upon attainment of age 20 and can enter into the Plan the first day of the month coinciding with or following the date the employee becomes eligible. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may elect to contribute not less than 1% or more than 90% of their annual compensation up to the maximum contribution limitation for a Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions may be designated as Roth 401(k) contributions. The Plan provisions include automatic enrollment for participants who do not complete a salary deferral agreement by their Plan entry date. The automatic enrollment deferral percentage is 6% of eligible compensation to be contributed to the Plan. Provided that no contrary election is made, the participant will automatically defer for each payroll period to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes a safe harbor matching contribution equal to 100% of salary deferrals up to the first 3% of plan compensation, plus 50% of salary deferrals up to the next 2% of plan compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and safe harbor matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

All fund options within the Plan are intended to be participant directed, which means that each participant may invest his or her contributions, and any Company matching contributions in any one of the investment funds offered under the Plan from time to time. In addition to a number of funds offered by the Plan trustee, participants could elect to invest a portion of their contributions in a LivePerson, Inc. stock fund that invested primarily in the common stock of LivePerson, Inc. The LivePerson, Inc. stock fund also included the Fidelity Government Money Market fund to provide liquidity. During 2024, the Plan fully liquidated the LivePerson, Inc. Stock Fund, and it is no longer an investment option of the Plan (see Note 7).

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions and any income or loss thereon. Participants become 100% vested in Company matching contributions (non-safe harbor) after five years of service, in accordance with the following schedule:

Participants are fully vested upon retirement, disability, death, or termination of the Plan.

Forfeited Accounts

Forfeitures resulting from the non-vested portions of accounts of participants who terminate employment prior to being fully vested are used to reduce the Employer contributions and to pay any administrative expenses. Forfeitures amounted to \$58,597 and \$28,489 as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, \$92,974 of forfeitures were used to offset employer contributions and \$0 was used to pay administrative expenses.

Payment of Benefits

Withdrawals by participants during their employment are permitted with certain restrictions. On termination of service, a participant may receive a lump-sum payment, partial lump sum or installment payment over a period not to exceed the assumed life expectancy of the participant, if the balance of the withdrawal exceeds \$5,000. If the payment is for less than \$1,000 then the participant must receive a lump sum payment. If the payment is a death benefit payment, it will be made in one lump sum within one year of death of the participant. Participants may receive in-service distributions if they attain age 59 ½. The Plan also provides for hardship withdrawals in the case of a financial hardship.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum amount equal to \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence. Participants may only have one outstanding loan.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's oversight committee determines the Plan's valuation policies utilizing information provided by the trustee, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the safe-harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payments of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including trustee, custodial and third party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events

Management evaluated subsequent events for the Plan through October 10, 2025, the date the financial statements were available to be issued.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, trustee of the Plan and a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, due from broker for securities sold, due to broker for securities purchased, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income, as well as interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for the mutual funds, common collective trust and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

LivePerson, Inc. stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust: A common collective trust is valued at the net asset value or equivalent based on units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of levels 1, 2, or 3.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its common collective trust, the Reliance Trust Company New York Life Anchor Fund (the "Fund"). The investment objective is to seek to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rates by investing in a group annuity contract issued by New York Life Insurance Company. Participants' ownership of the collective investment trust is represented in units. Units are issued and redeemed daily at the common collective trust's current NAV. The common collective trust allows for daily liquidity, with no additional days' notice required for redemption for participant-initiated transactions. However, it is possible that these redemption rights may be restricted by the common collective trust in the future in accordance with the underlying common collective trust agreement. Due to the nature of the investments held by the common collective trust, changes in market conditions and the economic environment may impact the NAV of the common collective trust, and consequently, the fair value of the Plan's interest in the common collective trust. Furthermore, changes in the liquidity provisions of the common collective trust may significantly impact the fair value of the Plan's interest in the common collective trust.

5. Tax Status

Effective July 15, 2021, through the adoption of a Fidelity Pre-Approved Defined Contribution Plan, the Plan was amended and restated. The Internal Revenue Service (“IRS”) issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable Internal Revenue Code (“IRC”) requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the statements of net assets available for benefits.

7. Related-Party and Party-In-Interest Transactions

The LivePerson, Inc. Stock Fund held shares of LivePerson, Inc. common stock. During 2024, the Plan fully liquidated the LivePerson, Inc. Stock Fund. Certain other plan investments are managed by an affiliate of Fidelity Management Trust Company which serves as a recordkeeper and trustee of the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Notes receivable from participants also qualify as party-in-interest transactions. Direct fees paid by the Plan for services provided by Fidelity Management Trust Company were \$124,060 for the year ended December 31, 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.
