To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audits.

1. DESCRIPTION OF PLAN

The following description of the Advantive, LLC 401(k) Savings & Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide employees of Advantive, LLC (the Company or the Sponsor) the opportunity to accumulate savings that provide benefits in the event of retirement, disability or death. The Plan is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration

The Plan is administered by the Company which, as Plan administrator, has substantial control of and discretion over the administration of the Plan. Assets of the Plan are held by John Hancock Trust Company LLC (John Hancock or the Trustee).

Eligibility

Participation in the Plan is voluntary. All employees of the Company become eligible to participate in the Plan after attaining 21 years of age and completing three months of service, as defined. Union employees, leased employees and nonresident aliens who have no earned income from sources within the United States are excluded from participation of the Plan. Participants can enter the Plan on the first day of the month after meeting eligibility requirements. Upon enrollment, participants direct their contributions to various investment options offered by the Plan. Participants may change their investment elections at any time.

Contributions

Participants may make deferred compensation contributions to the Plan by electing to reduce their gross pay in an amount or percentage up to the maximum contribution allowed by the Internal Revenue Code (the IRC). Participants may also rollover contributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Effective May 1, 2024, the Plan was amended to add an automatic deferral arrangement where eligible employees are automatically enrolled at 4% pretax contribution deferral 30 days following his or her employment commencement date. Absent an election by the participant, the 4% pretax contribution deferral will automatically increase each April 1st by 1% per year up to 10%.

The Sponsor contributes a safe harbor matching contribution equal to 100% of the first 4% of participant-eligible compensation. The Company may also make a discretionary additional matching contribution. For the year ended December 31, 2024, there were no discretionary contributions made to the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, allocations of the Company's contributions and Plan earnings, and charged with withdrawals, an allocation of Plan losses and administrative expenses, as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are fully vested in their contributions and the Sponsor's safe harbor contribution. Participants vest in Sponsor discretionary contributions and related earnings based on a six-year graded vesting schedule.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant or their beneficiary may receive their vested balance in either a single lump-sum distribution, a direct rollover into a qualified retirement plan or individual retirement account, monthly installments, or defer receiving payments until age 73. Terminated participants, with a vested balance less than \$5,000, that have not elected payment will have their vested balance automatically rolled over into an IRA or cashed out. In-service distributions are available upon reaching age 59½, for financial hardships as defined by the Plan, and from rollovers or after-tax accounts.

Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. The Plan may use forfeitures to reduce Sponsor contributions or to pay Plan expenses. At December 31, 2024 and 2023, forfeited, nonvested account balances were \$6,980 and \$39,948, respectively. Approximately \$47,815 of forfeitures were used to reduce Company contributions during the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments include mutual funds, a common collective trust fund, and a self-directed brokerage account. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Company pays substantially all administrative costs of the Plan, except for participant-initiated recordkeeping fees, which are paid by the participants.

Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust (CCT) fund: Valued at NAV as determined by the issuer of the respective CCT fund based on the fair value of the underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Money market and interest-bearing cash (held in SDBA): Valued at cost, which approximates fair value.

There are no unfunded commitments or redemption restrictions.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. There were no Level 2 or Level 3 investments as of December 31, 2024 and 2023.

4. INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024, and net appreciation in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee of the Plan.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares or units of investment funds managed by John Hancock. John Hancock is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. In 2024, the Plan paid recordkeeping and investment management fees to the recordkeeper. This expense is reflected in administrative expenses within the statement of changes in net assets available for benefits for the year ended December 31, 2024.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

7. TAX STATUS

The Company adopted a non-standardized, pre-approved, profit-sharing/money purchase/CODA sponsored by John Hancock Retirement Plan Services LLC. The underlying prototype plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC; therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
