### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Messner Reeves LLP Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Plan Description

The following description of the Messner Reeves LLP Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted by Messner Reeves LLP (the Company or Employer) effective January 1, 1998 and has been amended and restated most recently effective January 1, 2021. The Plan is a defined contribution plan covering eligible employees of the Company. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Issuer, Trustee, and Administration of the Plan*

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company is the trustee of the mutual funds and the guaranteed investment option, and is the recordkeeper of the Plan; Principal Life Insurance Company (Principal Life) is the issuer of the pooled separate accounts; and Principal Global Investors Trust Company is trustee of the collective investment trusts (collectively, Principal or Trustee) in accordance with the provisions of the service provider agreements with the Company.

The Plan administrator is the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees are eligible to become a participant in the Plan on the first day of the month coinciding with or following attainment of age 18 and completion of six consecutive months of service. Union employees, interns, and non-resident aliens are not eligible to participate in the Plan.

#### *Contributions*

Participants may contribute up to 100% of their eligible annual compensation on a pre-tax or after-tax Roth basis, subject to certain IRC limitations. The Plan also allows catch-up contributions for participants aged 50 or older, subject to certain IRC limitations.

The Plan allows for discretionary employer matching contributions and discretionary employer non-elective contributions. Employees are eligible for these contributions on the first of the month after completion of one year of service with 1,000 hours. The discretionary employer non-elective contributions are pro-rata based on the eligible compensation of all eligible employees. For the year ended December 31, 2024, a discretionary employer matching contribution was made in the amount of 25% of participant contributions up to 4% of eligible compensation. This contribution will be remitted to the Plan in December 2025 and is recorded as a receivable in the statement of net assets available for benefits. There were no discretionary non-elective contributions for the year ended December 31, 2024.

Prior to January 1, 2024, the Plan allowed for employer safe harbor contributions.

Rollover contributions from other qualified plans or an Individual Retirement Account (IRA) may also be made to the Plan if certain criteria are met.

### ***Participants' Accounts***

Participants' accounts are credited with participant pre-tax, after-tax Roth, rollover, discretionary employer matching, employer safe harbor, and discretionary employer non-elective matching, as well as an allocation of Plan earnings or losses. Participants are charged with certain administrative fees that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participant accounts are also credited or debited with participant-initiated transactions. Participants may direct the investment of their account balances into various investments offered by the Plan. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Notes Receivable from Participants***

An employee may, with the consent of the Plan administrator, borrow a minimum of \$1,000 up to the lesser of \$50,000 reduced by the excess of the participant's highest outstanding loan balance during the previous 12 months, or ½ of their vested account balance. Participants may not have more than one loan outstanding at any time. The maximum term of the borrowing is five years, unless for the purchase of a principal residence where the loan can be up to 30 years. A participant's loan shall immediately become due and payable if such participant terminates employment for any reason or fails to make a principal and/or interest payment as provided in the loan agreement. The loans are secured by the balance in the participant's account and bear interest at *The Wall Street Journal* posted prime rate plus 2% and are fixed for the duration of the loan. The interest rate on outstanding loans at December 31, 2024 ranged from 5.25% to 10.50%. Principal and interest are repaid through payroll deductions.

### ***Vesting***

Participants are immediately vested in their pre-tax, after-tax Roth, rollover, catch-up, safe harbor contributions, and actual earnings thereon. Participants vest 20% per year after two years of service, and an additional 20% per year, becoming fully vested after six years of service in their discretionary employer matching and non-elective matching contributions. Participants who attain normal retirement age (age 65) or terminate employment due to death or disability, as defined, or upon termination of the Plan, are fully vested.

### ***Forfeitures***

Forfeited amounts may be used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited accounts were de minimis. During the year ended December 31, 2024, forfeitures of \$7,658 were used to reduce employer contributions and \$2,788 were used to pay administrative expenses.

### ***Benefit Payments***

Upon termination of service due to death, disability, separation of service, or attainment of normal retirement age (65), a participant may elect to receive his/her benefit payment in the form of a lump-sum amount, or installment payments; remain in the Plan; or may roll over the amount to

another qualified retirement plan or IRA. Immediate lump-sum distributions are to be made to terminated participants if the participant's vested account balance is \$1,000 or less. If the account balance is greater than \$1,000 but less than or equal to \$5,000, the balance is rolled into an IRA for the benefit of the participant. These mandatory distributions are only made if the participant has not affirmatively elected to receive their distribution in another form. In-service withdrawals at age 59½ are also allowed by the Plan if certain criteria are met.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the terms of the Plan document to terminate the Plan, subject to the provisions of ERISA. Participants would become fully vested upon termination.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments, as detailed in the accompanying supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year), are stated at fair value, as further discussed in Note 4 (except the fully benefit-responsive investment contract). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and Principal.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income and capital gains are recorded on the ex-dividend date. The net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses (in the form of an expense ratio) charged to the Plan for investments are deducted from income earned on a daily basis and reflected as a reduction of investment return for such investments.

### ***Accounting for Investment Contracts with Insurance Companies***

On January 1, 2020, the Plan entered into a fully benefit-responsive investment contract, the Fixed Income Guaranteed Option, with Principal Life. Principal Life maintains the contributions in a custodial account. These contracts meet the fully benefit-responsive investment contract criteria

and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to pay the principal and specified interest rates guaranteed. There are no reserves against the contract value for credit risk of the contract issuer. The crediting interest rate is based on a formula agreed upon with Principal Life but may not be less than 0%. Interest rates are reset semiannually. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with Principal Life. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Employer does not believe any of these events are probable of occurring.

### ***Contributions***

Participant contributions and discretionary or safe harbor employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Any discretionary employer non-elective contributions would be recognized in the period during which the related compensation was paid.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Any accrued, but unpaid interest was de minimis at December 31, 2024 and 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Benefit Payments***

Benefit payments to participants are recorded upon distribution.

### ***Expenses of the Plan***

During the year ended December 31, 2024, administrative expenses totaling \$111,892 were paid by the Plan for recordkeeping, loan and distribution administration, audit and investment advisory services. Certain other fees and expenses may be charged within the investments (as an expense ratio) and are reflected in the net appreciation in fair value of investments. The Company, on behalf of the Plan, paid all other administrative expenses of the Plan, and those expenses are excluded from these financial statements.

### 3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Principal, qualified institutions, have certified the following information, which is included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments, as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest, dividend, and other investment income as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts in the notes to the financial statements.
- Investment information included in the notes to the financial statements and in the supplemental schedule, Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, excluding notes receivable from participants.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements and Disclosures

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Insurance Company Pooled Separate Accounts (PSAs)* - PSAs are valued at fair value using NAV as a practical expedient. NAV is determined by the issuer based on the fair value of the underlying investments. The practical expedient would not be used if it is determined to be probable that the investment will be sold for an amount different from the NAV. These investments are direct-filing entities with the Department of Labor.

*Collective Investment Trusts (CITs)* - CITs are valued at fair value using NAV as a practical expedient. NAV is determined by the issuer based on the fair value of the underlying investments. The practical expedient would not be used if it is determined to be probable that the investment will be sold for an amount different from the NAV. These investments are direct-filing entities with the Department of Labor.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies as of December 31, 2024 or 2023.

## 5. Related Party and Party-in-Interest Transactions

During 2024, the Plan invests in certain investments managed by Principal. Participant loan and distribution processing fees are paid to Principal by participants. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. Certain other fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## 6. Tax Status

The Plan was restated by adopting a Non-Standardized Pre-Approved Plan Document effective January 1, 2021, sponsored by Creative Retirement Plan Consulting, LLC, which obtained an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, indicating that the Non-Standardized Pre-Approved Plan is designed in accordance with the applicable sections of the

IRC and, therefore, the related trust is tax-exempt. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC, thus no provision for income taxes has been included in the accompanying financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **7. Risks and Uncertainties**

The Plan provides for various investments in mutual funds, PSAs, CITs, and a fixed-income investment contract. Investments, in general, are exposed to various risks, such as interest rate, overall market volatility, and credit risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' account balances.

### **8. Delinquent Participant Contributions**

During the years ended December 31, 2024, 2023, 2022, 2021, 2020, 2019, 2015, and 2014, the Company failed to timely remit certain employee contributions and loan repayments to the Plan as reported in the supplemental Schedule H (Form 5500), Line 4a - Schedule of Delinquent Participant Contributions.

### **9. Subsequent Events**

The Plan has performed an evaluation of subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements, except as disclosed below.

Effective May 8, 2025, management elected to adopt certain provisions of SECURE 2.0. The Plan will formally amend for by the deadline imposed. These elections include adding disaster loan and withdrawal provisions, increasing the threshold to automatically distribute a participant's account to \$7,000 and to add the super catch up contribution provisions.
