INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
Crawford & Company Savings and Investment Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Crawford & Company Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Crawford & Company Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Crawford & Company (the Company). Eligible employees are defined as those who are actively employed by the Company, excluding leased employees, members of collective bargaining units, employees of Crawford Catastrophe Services, LLC whose job classification is "non-core CAT", an employee who is not a U.S. Citizen or permanent U.S. resident, an employee who is not paid through the Company's U.S. payroll system, a highly compensated employee who has agreed not to participate in the Plan, or a resident of Puerto Rico. Except for certain temporary or seasonal employees, an employee becomes eligible to participate in the Plan upon completion of 30 days of service as defined by the Plan document. Certain temporary or seasonal employees are eligible to participate in the Plan after completing 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax and/or Roth contributions up to 50% of eligible compensation as defined in the Plan, not to exceed \$23,000 in 2024, plus up to an additional \$7,500 catch-up deferral for participants over age 50. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants are automatically enrolled in the Plan upon meeting the eligibility requirements at a rate of 6% of eligible compensation, unless the participant elects otherwise. This automatic contribution rate will increase by 1% annually in July following the first full calendar year of participation up to a maximum of 15%, unless the participant elects otherwise.

The Company's contributions to the Plan are determined each year and take the form of a matching contribution and a performance contribution. The matching contribution is made on a discretionary basis. For the year ended December 31, 2024, a participant must be employed on the last day of the Plan year and have made elective deferrals to receive the discretionary matching contributions. If a participant terminated before the last day of the Plan year, they were eligible to receive Company discretionary matching contributions if termination was due to death, retirement, or disability. For the year ended December 31, 2024, the Company matched 50% of participant deferrals, up to 6% of eligible compensation. For participants to receive a performance contribution, the Company must reach certain discretionary goals as defined in the Plan document. A participant is eligible to receive a performance contribution if they are employed on the last day of the Plan year and are not an hourly or highly compensated

employee. Any performance contribution is allocated to participants proportionately based on compensation among those eligible to receive it. There were no performance contributions made in 2024. All 2024 Company contributions were calculated and funded subsequent to the Plan's year-end and are included in the employer contributions receivable at December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account, and is charged with transaction fees for loans and other account services. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. For Company performance and matching contributions, participants are 100% vested after two years of service.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$132,231 and \$138,423, respectively. These accounts are used to reduce Company contributions to the Plan or to reduce administrative expenses. During 2024, \$226,966 of forfeitures were used to reduce 2023 Company contributions and no amounts were used to reduce administrative expenses. During 2025, \$164,321 of forfeitures were used to reduce 2024 Company contributions and no amounts were used to reduce administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two loans outstanding at any time. The loans are secured by the balance in the participant's account and bear an interest rate equal to the prime rate plus 1%. During 2024, loans had fixed rates ranging from 4.25% to 9.50% for the term of the loan, not to exceed 5 years or 10 years if used for the purchase of a residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, termination of employment or retirement, a participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump-sum distribution or partial and installment distributions subject to certain

conditions defined by the Plan document. The participant may also receive an in-service distribution upon the age of 59½ or for certain hardship situations. Participant loans in default are treated as deemed distributions if the participant does not have a distributable event.

Administrative Expenses

The Plan has an Administrative Budget account where the third-party administrator deposits revenue sharing payments into the account on a quarterly basis. The balance is used to pay for fees and expenses associated with services related to the Plan. For 2024, the third-party administrator deposited \$151,467 into the account and the Plan used \$161,269 from the account to pay administrative expenses related to the Plan. The account had investment earnings of \$9,778 during 2024. There were no revenue sharing payments allocated to participants during 2024. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. At December 31, 2024 and 2023, the balance in the Administrative Budget account was \$163,225 and \$163,249, respectively, which is included in mutual funds on the statements of net assets available for benefits.

Expenses paid by the Plan in 2024 included recordkeeping fees and advisory fees. These expenses are paid to service providers of the Plan and therefore qualify for party-in-interest transactions. The Company pays all other administrative expenses of the Plan. The Company does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company matching and performance contributions are considered payable to the Plan after approval by the Administrative Committee. Any unfunded participant or Company contributions are included in the participant or employer

contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with FASB ASC 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the employer contributions receivable. After giving consideration to the risk characteristics, including historical payment experience, the Plan determined that no allowance for credit loss was necessary and there was no current year activity in the allowance for credit losses.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator

and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), the Plan's qualified institution.

4. Investments and Fair Value Measurements

Plan investments include common collective trusts, mutual funds, and a stable value fund managed by T. Rowe Price. T. Rowe Price is the Plan's qualified institution; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, etc. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted market prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market that the Plan has the ability to access (Level 1).

Fair value of the common collective trusts is determined by prices published daily by the trust manager, which is the NAV of the common collective trusts (Level 1). Net asset value is determined by the fair value of the mutual funds, stocks, and other securities in the common collective trusts. Participants can trade the common collective trusts daily at the published NAV.

The Plan invests in a stable value fund held in a common collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the net asset value (NAV) which is based on the contract value of the underlying investments (Level 1). The stable value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

5. Income Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated December 5, 2014, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although, the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and has no income subject to unrelated business tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.
